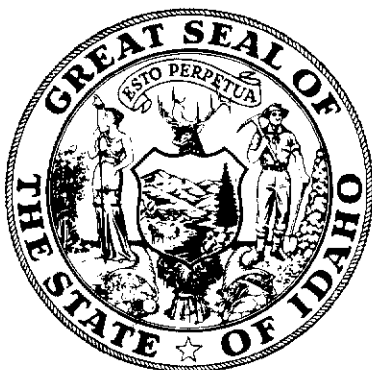

ARTICLES OF INCORPORATION
OF
COEUR d'ALENE DOG FANCIERS , INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, for the purpose of forming a corporation under the laws of the State of Idaho relating to charitable and educational corporations have entered into the following agreement:

ARTICLE I

Name

The name of this corporation shall be COEUR d'ALENE DOG FANCIERS , INC. This corporation shall be a non-profit corporation.

ARTICLE II

Location

The principal office and location of COEUR d'ALENE DOG FANCIERS , INC. shall be 4102 Nez Perce, Coeur d'Alene, Idaho 83814.

ARTICLE III

Duration of Corporation

COEUR d'ALENE DOG FANCIERS , INC. shall continue in perpetual succession unless and until dissolved in the manner set forth in Article VI of these Articles of Incorporation.

ARTICLE IV

Purposes

The purposes for which this corporation is formed are:

A. (i) To encourage and promote the knowledge and breeding of all breeds of pure bred dogs and to do all possible to bring their natural qualities to perfection.

(ii) To protect and advance the interest of all purebred dogs and to encourage sportsmanlike competition at dog shows and obedience trials.

(iii) To conduct sanctioned matches, dog shows and obedience trials under the rules of the American Kennel Club.

(iv) To further the advancement of purebred dogs through meetings, fun matches, programs and other educational activities.

- B. To purchase or sell, hypothecate, mortgage and lease such real and personal property as may be necessary for the purposes of the corporation, and to execute deeds, contracts, agreements and obligations, the purposes whereof are consonant with the laws of the State of Idaho under which this corporation is formed, and to accept and execute any trust, the purpose whereof is lawful under the said laws and consistent with the purposes of this corporation; and to do each and everything necessary, suitable, or proper for the accomplishment of any of the purposes herein enumerated, or which may at any time appear conducive or expedient for the benefit or protection of this corporation.
- C. This corporation shall have no capital stock, no dividends shall ever be declared or profits distributed, and no part of the net earnings of the corporation shall be distributed to, used for, or inure to the benefit of any private shareholder, trustee, director or individual.
- D. This corporation is organized exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of section 501(c) (3) of the Internal Revenue Code.
- E. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities

not permitted to be carried on by an organization exempt from Federal income tax under section 501(c) (3) of the Internal Revenue Code.

ARTICLE V

Management

ARTICLE VI

Dissolution

In the event of the existence of the corporation for any reason be terminated, all funds of the corporation shall, after the payment of its liabilities, be distributed exclusively to qualified Internal Revenue Code tax exempt charitable institutions and purposes as selected by the Board. However, if the named recipient is not then in existence or is no longer exempt from Federal income tax, or is unwilling or unable to accept the distribution, then the assets shall be distributed to an organization which has established its tax exempt status under section 501(c) (3) of the Internal Revenue Code.

ARTICLE VII

Street Address

The address of the registered office of this corporation shall be 4102 Nez Perce, Coeur d'Alene, Idaho, and the registered

ARTICLE VIII

Membership

This non-profit corporation shall have members and they shall be classified as follows:

A. Any person making a donation to this corporation and who receives a certificate of membership issued by the corporation.

B. Each member shall be entitled to one (1) vote.


