CPC 2020 YEAR IN REVIEW

We started out 2020 energized for many fun events planned for the year ahead - a Monster Sale and St. Patrick's Day parade amongst them. We enjoyed Pub Theology, Potluck dinners, monthly luncheons, the usual weekly bible study, and Sunday worship for the first few months of 2020. Ash Wednesday was celebrated with planned Lenten Gatherings to be held weekly.

However, we had sad and trying times too. We lost our beloved Mary Lu, saying goodbye to her at her memorial service in February. Many of us gathered to hear beautiful tributes, share memories, see family photos, and enjoy a wonderful feast afterwards in celebration of her life.

Then we all know the rest of the story, as they say. The pandemic caused us to go on lockdown - all to stay at home, and on March 16 we had to close the church building. All our plans immediately stopped, including our ability to worship together. These were, and are, indeed trying times but due to the hard work and determination of our congregation we are weathering the storm!

With the onset of the pandemic changing our church life, we swiveled on our heels and moved forward. In April, thanks to Steve Anderson and the F&S Committee, CPC applied for, and received a grant through the Government's *Payroll Protection Plan*, which offered to help small businesses and churches financially. The grant does not have to be repaid. A Covid Preparedness Plan was drafted for the use of the church, with regard to our ability to gather and worship. The plan follows state guidelines and is an ever-evolving plan due to the ongoing changes and restrictions of the pandemic. Thank you to Diane McCormack for all her hard work putting it together. Building & Grounds installed HEPA filters and hand sanitizers, and the building was prepared for the time when we could worship together again indoors. Throughout the summer months when we could not meet in person, the Deacon's continued to work behind the scenes, caring for the members of our congregation. They also continued their mission work, helping area food shelves and schools with monetary donations. The Monster Sale went on behind the scenes too, with Amy Bloch and Tom McCormack selling many of the larger items online generating more income. Thank you to them!

On May 31 we started Outdoor Sunday worship services in the parking lot with Glenda playing the piano, and members of the choir singing in the sunshine. We worshipped together until the weather turned cold, and we were able to move indoors with limited capacity. By November we were able to offer the service online via Zoom, with many thanks to Brad Kohl for his IT ability allowing us to get this up and running - we will be forever indebted.

We lost two treasured members of our congregations over the summer: Bill Lallman in July and founding member Norm Nelson in August.

The congregation voted not to renew Pastor Tony's contract and his last day with us was October 4.

We shared a listening session for the congregation in November following the newly formed Vision & Strategy Task Force with the aim to reflect, revise and revive our congregation moving forward. Thank you to Patty Norgaard and the group of women on the task force forging this trail.

Thank you to Brad Kohl and Austin Nelson for leading our Sunday services for the last few months with kind hearts and wonderful sermons! The congregation is incredibly grateful and the increased attendance numbers speak truth to this.

As we continue to weather the storm of Covid, several of our members and friends have caught the virus and we are blessed to have them recovered. Now members and friends are starting to receive vaccinations. We pray for the continued health of the congregation and that we can all be together in our entirety within the coming months.

DEACONS & MISSIONS COMMITTEE

The Deacons meet every fourth Tuesday or as needs arise. Our mission is to provide Congregational care and concern to our members. We do this in the following ways: The Deacon of the Month communicates with members who may need rides to appointments, meals during times of sickness, visiting by phone, writing notes, sending birthday greetings and get well cards and praying for them at all times. Starting in March and lasting until October, home visits and trips to appointments were discontinued due to the Covid19 Pandemic. Church Services were held in our parking lot. Now they are held at church with physical distancing and no gathering after the services. Many are able to Zoom the service at home. The Deacons communicate with our college students and give encouragement to each with notes and treats periodically.

We have given three gifts of checks to them this year provided by the Mary Lu Dietz Fund. We welcome all new families and new babies into our congregation with gifts for the occasion. We welcome non-members to use our facilities for weddings and baptisms. We assist and visit members who are transitioning to new homes and assisted living situations as their needs arise. The Deacons assist at the funerals held in our church. We set up coffee, water and cookies in a Sunday School room for them to use. We held outdoor funeral services for Bill Lallman this year. The Deacons usually organize an annual Christmas party at Golden Horizons Nursing Home each year, providing music, food and treats. This year we were unable to do this due to the Covid19 Pandemic and instead sent them \$400 for expenses to host their own party. The Deacons created and delivered gift fruit and treat Christmas baskets to our staff and our members who are having health issues. We were honored to be the recipient of the Mary Lu Dietz Memorial Fund by the family, and the committee worked to honor their wishes. We donated to members and other groups which were dear to Mary Lu. Flowers and food baskets were sent for special birthdays and as get well gifts. A list will be provided of our donations and fund balances.

This year we felt was the time to connect with our members and associates with a Congregational Christmas letter and card. It was well received and the Deacons and Missions Committee plan to continue the tradition. Our new members for 2021 will be Judie Larson and Gail Peterson. Patricia Tweed will be ending her three year term on the committee, and Shari Ochs will be leaving after her term.

FINANCE & STEWARDSHIP COMMITTEE

Committee Members: Steve Anderson, Treasurer; Brenda Brittan and Jane Milliman, Financial Secretaries; Dewey Krueger, Patty Norgaard, and Loyal Meech, acting chair. Louis Smith oversees the Endowment Fund.

Gifts and Memorials Sub-committee members include, Marge Angell, Brenda Brittan, Jan Lallman, and Dewey Krueger. The chairman for the committee is currently vacant.

2020 has been a very unusual year. COVID19 has kept the committee from meeting regularly and the departure of Pastor Tony has put some additional strains on finances. Our contract commitment to Pastor Tony ends January 31, 2021. In spite of this, expenses were held to \$14,359 under the original budget. This was primarily due to the fact that the original budget contained funds to replace one of the four heat pumps should one fail. With funds from the "Blest To Be A Blessing" account, the exterior of the church building was color stained and the four ventilation fans were modified to make the building usable and conform to COVID19 restrictions. The exterior doors were also painted. The east door had only been primed and never painted after it was installed in the original building. There are funds remaining in the account which will partially fund a new church sign and new edging around the church. These projects are potentially planned for completion during 2021.

The 2020 operating budget was set at \$186,737. The total yearly income was \$147,740 and expenses were \$172,378. This forced the church to use \$24.637 from our reserve account. The budget for 2021 is expected to be approximately \$125,230. To date we have 20 pledges totaling \$71,088. This shortfall will again tap into our reserve fund. The committee is investigating the potential for using the \$15,000 which the Endowment Fund earned during 2020 to help pay the bills. A Monster Sale which was scheduled for 2020 was cancelled. However, Tom McCormack and Amy Bloch are still selling donated items over the internet and were able to provide \$574 in funds during 2020.

During the spring, George Young resigned as committee chairman due to health reasons. Jan Lallman also resigned as Financial Secretary following the death of her husband. Betsy Simons resigned as chair of the Gifts and Memorials sub-committee in October.

Loyal Meech became the acting chairman of the committee in October and Jane Milliman was confirmed as Financial Secretary in December. The committee extends a warm welcome to Jane as our newest member. We thank George, Jan and Betsy for their dedicated service to the church and our committee and sub-committee.

Arleen Steele volunteered to do a review of the church financial records for year 2019 but as yet it is not completed.

Steve Anderson handled the duties of treasurer and Jan Lallman and Brenda Brittan served as financial secretaries for 2020. Thanks to these three for their excellent work and for giving many, many hours of expertise to the finances of Crosslake Presbyterian.

Louis Smith carefully watches over the Endowment Fund and his report is attached. Betsy Simons ably chaired the Gifts and Memorials sub-committee for the greater part of 2020. The yearly report for Gifts and Memorials is also attached. Thanks to both of these two individuals for their dedication to their tasks. I also thank all the committee members listed at the beginning of this report for their service and dedication to overseeing CPC's financial well-being. They are very able members and our congregation is blessed to have them share their time and talent. And thanks to you of our church family for your dedication to this church, shown by your underwriting of our financial needs so that ministry is possible.

- 2) During 2020, the Endowment Fund facilitated stock donations to Crosslake Presbyterian Church by members and friends of the church. One donation was made during the year. It was sold shortly after receipt. The net proceeds of the sale of \$25,318.92 were deposited in the church's savings account by direct transfer. The short or long term capital gain from the sale of that donation will be reflected on the annual 1099 form prepared by the church's brokerage firm. That form will also itemize the church's 2020 interest, dividends, and long term capital gain distributions shown in Note 1.
- 3) The church's brokerage firm charges no fees for this account. This includes housing the account, receiving, buying and selling of assets, transfer of cash from the account to the church, and providing investment advice.

Previously, in July 2020, our subcommittee had agreed by email to transfer the remaining \$4,475 (after a \$45 gift of flowers to Jan Lallman) given in memory of Mary Lu Dietz to the Deacons to establish the Mary Lu Dietz Memorial Fund. Steve Anderson transferred the money in July.

Dick Dietz said Mary Lu's passion was helping people, so it seemed appropriate for the Deacons to administer the fund. Pat Tweed, Chair of Deacons, agreed. Ways to spend the money were suggested by Dick, Gifts & Memorials and Deacons. Dewey gave an update on gifts that have been given - or will be - to CPC members and the community.

SPIRITUAL GROWTH & CHRISTIAN ED.

Due to the COVID-19 pandemic, our experiences with Spirituality and Christian Education were different during most of 2020. We began the year with an Epiphany study and celebration early in January during our regular Bible Study time. Bible study continued to meet most Wednesday mornings until church groups were asked to stop meeting in person, after which Tony led our Bible study via Zoom until the end of his time with us.

Pastor Tony also began 2020 by leading a mid-week small group on the topic of discerning our personal call/path to ministry.

As it was not possible to do a Sunday morning adult study group last spring, summer and fall, as we had the year before, I invited people to take part in an email group called Prayer Reflections. Thirteen people (some church members and a few old friends and family members) are taking part in that group, which is still going. We began by reflecting on and sharing our most recent personal experiences with prayer--the words we used to address God; whether we thought, spoke aloud, or wrote our prayer; whether it was a prayer of thanksgiving, a request, a complaint, or something else entirely; and any response we received from God to our prayer.

We also shared our thoughts on such topics as playing with God, what it means to pray without ceasing (including Henri Nouwen's translation of "pray without ceasing" as "come to rest"), and prayer and fasting. Currently we are on the topic of intimacy with God.

I look forward to the time when we can again share our thoughts, study, pray and worship together in the same space. We are likely to continue to offer opportunities for such activities via computer even when it is no longer necessary, as it has been good to include people who are not members of our congregation and/or do not live in this area year-round.
