# PASTOR'S REPORT

## ON THE MARK—ANNUAL REPORT VERSION 2025

*Proverbs 3:3-6*

*My child, do not forget my teaching,  
but let your heart keep my commandments,  
for length of days and years of life  
and abundant welfare they will give you.  
Do not let loyalty and faithfulness forsake you;  
bind them around your neck;  
write them on the tablet of your heart.  
Then you will find favor and high regard  
in the sight of God and of people.  
Trust in the Lord with all your heart,  
and do not rely on your own insight.  
In all your ways acknowledge him, and he will make straight your paths.*



Trust is a word that in many ways is something we instinctually understand, but trust is actually very complex. It is both an emotion and a choice. When we feel safe and comfortable, it can lead to a conscious decision to be vulnerable. As an emotion, it is not based on pure logic. Feelings of safety, acceptance, and being understood foster emotional trust. Trust as a choice involves a conscious decision to accept being vulnerable, to rely on another, even if all the information is not perfectly obvious. It often involves taking a risk. Trust is like a cycle—positive interactions create positive feelings (emotion), which inform our willingness to take risks (choice).

When the writer of Proverbs is instructing us to ‘trust in the Lord’, it is both an emotion and a choice. We like to rely on our own experience and apply that to current situations within the church. We think our past experiences will solve all of our problems in the church. Our experience as a church and as individuals may have gone through times when we maybe felt like God had not been faithful in answering our prayers and we may have developed an attitude of mistrust of God. This often makes us revert back to relying on our own insights and experiences. That is the very thing the author of Proverbs is warning us not to do.

As we look to the past and to the future of this, our church, we really wonder if we can trust God. We may feel that God has let us down, not only in the past but in our current life. We experience people leaving our church, not because of conflict, but changes in their life circumstances. We experience fewer and fewer people who are able and willing to be in leadership roles or even to share in the work of ministry. The things that brought us comfort, like worship and the choir, have almost disappeared.

What does it mean for us to trust in God and not to rely on our own insights?

### Notes

- 1) Dividends and capital gain distributions from mutual funds were reinvested in the same fund as made the distribution. Dividends and proceeds from sale of common stocks were invested in additional shares of common stocks.
- 2) The church's brokerage firm, Raymond James, charges no fees for this account. This includes housing the account, receiving, buying and selling of assets, transfer of cash from the account to the church, and providing investment advice.
- 3) The two Funds were previously commingled. Recognizing the different objectives of the Funds, they were separated into the Endowment Fund and the Investment Fund for accounting purposes, although they are both housed in a single Raymond James brokerage account.

# ANNUAL CONGREGATIONAL MEETING 2024

## 2024 ANNUAL CONGREGATIONAL MEETING MINUTES OF MEETING      Wednesday, February 5, 2025 at 5 p.m.

Moderator Pastor Mark Ford opened the meeting with prayer at 5:05 p.m.  
A quorum was declared. 11 members were physically present. 4 members attended by Zoom.

It was MSC (Moved, Seconded, Carried) to elect Kate Stangl to be clerk pro-temp.  
It was MSC to approve the agenda as on page 1 of the Annual Report.  
It was MSC to approve the minutes of the 2023 Annual Congregational meeting for February 28, 2024. (p. 14)  
It was MSC to approve the minutes of the Congregational Meeting to elect officers held on December 8, 2024.

Attention was drawn to the committee reports included in the Annual Report. People were encouraged to read them as informational pieces. No action was needed to approve or receive them.

The Nominating Committee requires two congregational representatives to be nominated from the floor of the annual meeting. Patty Norgaard and Jan Lallman were nominated. Both agreed to be nominated. As there were no nominations from the floor, it was MSC to elect Jan and Patty. Another Nominating Committee member will be elected by and from the Session.

Treasurer Steve Anderson presented the Financial Reports for 2023 and 2024 for comparison with the current Budget for 2025 found on pages 12 and 13. The Budget has already been approved by the Session but is presented to the congregation for information. It was MSC by the congregation to show their support and appreciation for the Budget information.

The Moderator called for any **Old Business**. There was none.

The Moderator called for any **New Business**. The New Business was presented by Treasurer Steve Anderson in regard to the roof damage the church sustained during the June 12, 2024 hail storm. The church roof was insured for Actual Cash Value which includes depreciation due to the age of the roof. A bid for the replacement of the hail damaged roof is \$111,000. The insurance company has already paid the church \$42,000 with another \$19,000 still pending. The church expects to receive a total of \$61,000 from the insurance company. This leaves a total of \$50,000 out of our own pockets for the roof replacement.

In discussing this dilemma, comments were made regarding the long legacy of labor of love that initially built this church and the sweat equity born of love for one another that built the Friendship Hall. The Session wants to carry on the commitment to care for the building by fixing the roof. It was acknowledged that we don't know where this portion of the Body of Christ will be in five or ten years. Membership is noted to be 45. We are grieving our losses, but we are not dead yet. Besides that, it is not our church) but it is God's Church.

Ideas were brainstormed for funding the \$50,000 needed for roof repair. Several avenues were mentioned that the Session is considering including asking members for contributions; selling stock assets or using foundation funds; getting a loan or loans. The possibility of getting loans from church members was also suggested. Session will continue to prayerfully consider this issue and explore opportunities to pay for the roofing project.

There being no other business, it was MSC to adjourn at 5:40 p.m.
