## Liability Release and Waiver of Claims

In consideration of being permitted to participate in Training organized by Nighthawk Alliance, I, the undersigned, hereby voluntarily and willingly agree to release, discharge, indemnify, and hold harmless Nighthawk Alliance, its agents, employees, volunteers, officers, and directors (collectively referred to as the "Released Parties") from any and all claims, liabilities, demands, actions, causes of action, costs, and expenses (including attorney's fees) whatsoever, whether known or unknown, anticipated or unanticipated, arising out of or related to my participation in the aforementioned activity.

I acknowledge and understand that the Training involves inherent risks, including but not limited to the risk of serious bodily harm, injury, or death. These risks may arise from, but are not limited to, the use of firearms, exposure to loud noises, flying debris, accidents, slips, falls, and any other risks associated with firearms training activities.

I further acknowledge and understand that the Nighthawk Alliance has taken reasonable steps to provide a safe environment for the Training. However, I recognize that there are factors beyond their control, and accidents or incidents may occur despite their best efforts.

I expressly waive and release any and all claims, actions, or causes of action that I have or may have in the future against the Released Parties for any injury, illness, loss, damage, or harm that may occur as a result of my participation in the Training, including claims arising from the negligence or fault of the Released Parties.

Additionally, I hereby grant permission to Nighthawk Alliance and its authorized representatives to record my likeness via video, audio, and photographs during the Training. I understand and agree that the recordings may be used for promotional, educational, or other purposes by Nighthawk Alliance, without any claims to compensation or ownership of the recorded materials.

I acknowledge that Nighthawk Alliance is the sole owner of the recorded materials and has the right to edit, reproduce, distribute, and publicly display them in any format or media now known or hereafter developed, without further consent from or payment to me.

I understand that while Nighthawk Alliance will make reasonable efforts to protect the privacy of participants, there is no guarantee of complete confidentiality regarding the recordings.

I understand that this release applies to all present and future claims, whether known or unknown, arising out of or related to my participation in the Training. This release shall be binding upon me, my heirs, executors, administrators, assigns, and any other legal representatives.
