Personal Information

- o Names, social security numbers and birth dates for filer, spouse, and dependents
- Copy of last year's tax returns
- o Bank account and routing number for direct deposit or direct debit

Income

- o W-2 forms for you and your spouse
- 1099-C forms for cancellation of debt
- o 1099-G forms for unemployment income, or state or local tax refunds
- 1099-NEC (or 1099-K if you're paid through a third-party such as PayPal) forms for you and your spouse for any independent contract work
- o Form 1099-R (for IRA/pension distributions)
- 1099-S forms for income from sale of a property
- o 1099-INT, -DIV, -B, or K-1s for investment or interest income
- SSA-1099 for Social Security benefits received
- Alimony received
- o Business or farming income—profit/loss statement, capital equipment information
- Rental property income and expenses—profit/loss statement, suspended loss information
- Prior year installment sale information—Forms 6252, principal and interest collected during the year,
 SSN and address for payer

Additional Income

- o Business income
- o Rental real estate, royalties, partnerships, S corporations, trusts, etc.
- Unemployment compensation
- Stock options
- Gambling winnings
- Payments for jury duty
- Scholarships
- o Cancellation of debt
- Taxable Health Savings Account distribution
- Prizes and awards

Adjustments to Income

- Alimony paid for divorces executed prior to 2019
- o Form 1098-E for student loan interest paid (or loan statements for student loans)
- o Form 1098-T for tuition paid (or receipts/canceled checks for tuition paid for post-high school)

- o For teachers: canceled checks or receipts for expenses paid for classroom supplies, etc.
- Records of IRA contributions made during the year
- Receipts for any qualifying energy-efficient home improvements (solar, windows, etc.)
- Records of Medical Savings Account (MSA) contributions
- Self-employed health insurance payment records
- o Records of moving expenses Keogh, SEP, SIMPLE, and other self-employed pension plan

Deductions and Credits

- o Childcare costs: provider's name, address, tax ID, and amount paid
- o Education costs: Form 1098-T, education expenses
- o Adoption costs: SSN of child; records of legal, medical and transportation costs
- o Forms 1098: mortgage interest, private mortgage insurance (PMI), and points you paid
- Investment interest expenses
- Charitable donations: cash amounts, official charity receipts, canceled checks; value of donated property; miles driven, and out-of-pocket expenses
- o Medical and dental expense records
- o Casualty and theft losses: amount of damage, insurance reimbursements
- Records/amounts of miscellaneous tax deductions: union dues; unreimbursed employee expenses (uniforms, supplies, seminars, continuing education, publications, travel, etc.)
- o Records business use of home expenses for self-employed, home size/office size, home expenses
- o Rental property income/expenses: profit/loss statement, rental property suspended loss information

Taxes You've Paid

- Estimated taxes paid
- State and local income taxes paid
- Real estate taxes paid
- Personal property taxes paid
- Vehicle license fees paid based on value of vehicle
- o Prior-year refund applied to current year and/or any amount paid with an extension to file
- Foreign taxes paid
- Foreign bank account information: location, name of bank, account number, peak value of account during the year
