UNC illegal Drugs Policy

For a first offense involving the illegal possession of any controlled substance identified in Schedules III through VI, N.C. General Statutes 90-91 through 90-94, the minimum penalty shall be probation, for a period to be determined on a case-by-case basis. A person on probation must agree to participate in a drug education and counseling program, consent to regular drug testing, and accept such other conditions and restrictions, including a program of community service, as the Chancellor or the Chancellor's designee deems appropriate. Refusal or failure to abide by the terms of probation shall result in suspension from enrollment or from employment for any unexpired balance of the prescribed period of probation.

There was not any marijuana found, just a smoking device. Even so, it seems that being kicked out of the dorms was an extreme measure, when probation could have been offered instead.

I remember when I was staying at Brendans and Sohels I kept my clothes in my dorm room with Han for a week, and went there to take a shower and change in the morning. The RA advisor saw me and told me, youre not allowed to be here. It was him. He was black, so maybe it racial. Why would he even care about that? A student accusing another student? Maybe he wasnt a student at all, right?

Ill drop most of the lawsuit for an apology letter from the Chancellor.

I remember at FAU Madura suggested that I was dismissed from the program entirely, so I saw so no need to take finals. I only later learned that only my money was cut off, and I still could have taken finals, and continued in the program. The dean dismissed me from the program in February. Madura fired me in November. Now, you never regret publishing pictures of someone, though I certainly wish for the simpler option, I could have just gone down to the DSS building and gotten the new form, which they never mailed me, never told me when I called, and still hasnt been returned by my doctor. So well keep the lawsuit open for now.

Im still looking for a lawyer, for Sleem v. the USDE Cartel of UNC, FAU, and Durham Tech, for reverse discrimination against white males. Apparently, they wont file the lawsuit and give me free money for civil rights violations.

I updated the NC residency for the UNC PhD application. I also have a PhD application at Yale, Post Docs at UNC and Yale, HKU Provost, and Fayetteville Tech Senior Vice President. I think I should work at a school again before accountant in the Cayman Isles.

Now, the black lady who handled my appeal was very nice at our meeting, I missed the final meeting because I was smoking marijuana in the dorms. Though, if a black man fired me from the dorms because I was white, that is racial discrimination. And that looks like what happened.

Since you want to talk about race instead of marijuana. Is it UNC Policy to remove students from the dorms during the semester for a first marijuana offense? Is it policy in American Academia to fire students 2 weeks before finals in PhD programmes? Is British Academia Thesis Only?

As you may know, our office, the EOC, is responsible for the UNC-Chapel Hill's policies prohibiting harassment and discrimination based on an individual's protected status (including: age, color, disability, gender, gender expression, gender identity, genetic information, national origin, race, religion, sex, sexual orientation, or veteran status) and incidents related to sexual harassment, sexual violence, relationship violence, and stalking. Options through the EOC are also limited to behavior and concerns that happen within UNC's jurisdiction, including matters involving current students and current employees. Thank you for the response. As an alumni later in life, I am 39 and working as an accountant in Fayetteville, it has dawned on me recently that what happened to me in the fall of 2001 at Hinton-James Dorm was not right. For one, rehab and counseling and community service could have been scheduled instead of kicking me out of the dorm, and almost causing me to flunk out. I had to sleep on a friend's futon that first semester, which isn't allowed. Brendan and Sohel's room was were I slept, and Han was my roommate to begin the semester. We all 4 smoked weed together, not uncommon for 18 year old college freshman. There were no hard drugs, just weed and beer.

One note of caution, marijuana has a smell. Most hard drugs do not emit odors. I had police at a party at my house when I was in high school try the same trick, he told me he smelled marijuana. So prosecuting people for smoking marijuana just because you smelled it may have adverse effects with drugs that are odorless.

Again, thank you for the response. This is the first positive communication I have received since I was fired from the PhD program at FAU fall 2008, including the USDE FAU Report.

What I want to know is if your policy has changed, or what is the policy for drugs at the campus dorms. As it should be, marijuana is illegal in the federal government, though I don't think that we want to be removing students from campus for smoking marijuana when they are young. A professor, sure, a student, no.

Sure, I would accept a phone call. When should we schedule the phone call? Fridays work best for me. I think it's counterintuitive to kick someone out of the dorm while they are still enrolled in classes. I understand that you refunded the payment to my parents, though it takes time to find

a new place to live, and after the semester is a better time to remove someone from the dorms, assuming that all options have been considered.

Is a report going to be issued by UNC on this matter? Can I get a copy of the file you have on hand from 2001, if you still have any documentation? I want this documented, that is my goal. It's certainly puzzling to me, and a trend. I have been kicked out of 3 colleges, with no police arrests, no cheating on exams, and no plagiarism, so I am definitely trying to gather more information on what I call the USDE Cartel of Sandra Battle and Cynthia Pierre, the two ladies who wrote the USDE FAU Report.

I have attached a copy of the USDE FAU Report, so you know what I am protesting. I disagree with the plagiarism allegations, and I find it unreasonable to a rational person that I would only ask for money owed and not an appeal, which the report claims. As for the appeal, I was fired 2 weeks before finals in November of 2008 via email from Jeff Madura, and never received a response from him as to my appeal options, which naturally was the first question I had, how do I appeal this. I also find it strange that Jeff Madura, an accomplished publisher in academic journals, would fire a PhD student via email 2 weeks before finals, so I think something else is going on, possibly Geoff Gitlen, a second year student who was sitting in on the paper writing class, Research Seminar, and who approached me before the semester to help me adjust. He clearly did not help me succeed. which he said he was helping to do.

As for Durham Tech, I was suspended for a year for an alleged email to a professor, which they never provided me with, and told to get a counselor letter to return to school after a 1 year suspension, which I did, and they still did not readmit me to school. So 3 times now, and I am now looking into these 3 events in the context of the mistake ridden USDE FAU Report. The men in charge of my Durham Tech dismissal are Greg Bellamy and Abraham Dones.

I just don't think it is normal for a college student to call the police on another college student because he or she smelled marijuana. This cannot be a common occurrence at college campuses. The reason I think it is the RA Advisor, is he was the only person I had met so far in the quad, and maybe an upper classman RA advisor would call the police before a freshman. Maybe you know who called the police on me, because I don't.

dorms for smoking marijuana. Someone harassed and discriminated against me by calling the police over a trivial and frivolous matter. Maybe UNC has the name of this person.

My story starts in college, at 18, at UNC Chapel Hill. I was kicked out of the dorm 2 weeks into my first semester for smoking marijuana. No rehab scheduled, no community service, just kicked out. They refunded the deposit for room and board to my parents, who did not tell me and I did not tell them. They thought I tried to get a refund for drug money. So I slept on a friend's futon for the semester, and almost flunked out. I was majoring in computer science, and would not have passed that major, too much calculus. Though, how can you remove a student from the dorms when he is still enrolled in class? This was a mistake, and at 39 I realized this mistake and emailed UNC, and they replied back with a phone conference. They know who called the police on me, probably the upper classman RA advisor, who was in the same quad as me. This is not allowed, sleeping three to a dorm room. I appealed the dismissal and had a good meeting with a black lady. Then I missed the hearing because I was smoking marijuana in the dorm room. It is not uncommon for college freshmen to smoke weed and drink beer. We do not want to be kicking students out for smoking weed. Professors, yes. Students, no.

My senior year at UNC I applied for Marines ROTC, and was denied because I have Chinese tattoos for love and hate on my wrists. The man told me on the phone that they were gang tattoos. I disagree, kanja is ubiquitous in tattoo shops, and are not gang tattoos. The US Navy owes me money for my senior year of ROTC. FAU owes me money for the PhD programme. So I took the bus to the recruiting station, I lost my truck due to DUI, and enlisted in the Navy for SWICC, the guys that back up SEALS. Though at Raleigh MEPPS they told my eyeglasses precluded me from special forces, so I signed up for nuclear program. I was stationed at Charleston, at Navy Nuclear Training Progam, then got a DUI and told them I wanted to leave. So I was transferred to the USS JFK at Naval Station Mayport. This lasted a year, as I told someone that I wanted to go to school at UNF and get an MBA. He told me no, so I quit, I said, Im not cleaning the bilge anymore, not right now. I still want to be a CPA. And they tried to hold me to the 8 year contract for nuclear program. If I had been downgraded to 4 years, I might have stuck it out. You never know. I enjoyed my time in the Navy, being enlisted is fun. Just drink and drive every nite, go to the club, use cocaine, not marijuana. Marijuana should be illegal in the federal government, and cocaine, cant have poilce officers smoking weed. I would protest making marijuana legal for the president.

After the US Navy, I worked at Georgia Pacific Paper Company as an accountant for a month. Then my tires got slashed at the club, and I missed work, and they fired me. Then I enrolled in the MBA program at the University of North Florida, UNF. At the same time I accepted a job as nite auditor at the Ponte Vedra Club, the best job ever, nite auditor at a hotel. I got 3 more DUIs in Jacksonville, though only booked for 1. I had a good lawyer, we beat the case. After graduating from UNF in May 2008, I entered a PhD program in finance at Florida Atlantic University, FAU. My 2 PhD references were John Adams and John MacArthur. Jeff Madura was my PhD advisor at FAU. Geoff Gitlen was the second year who greeted me at the door. I missed a meeting with Geoff Gitlen because I got arrested at the Jacksonville Jail requesting DUI

records for CPA eligibility. My dad paid the bail, and I forged the community service using UNF letterhead. A smart idea, forging community service. Hey, III do it eventually. Im no charity case give me something to eat, III pay you at another time.

So I got to FAU early and finished my teaching notes before the semester started, and asked to take more classes than the 3. They denied my request. Madura took the other 2 students out to lunch, and not me. Then he fired me via email 2 weeks before finals, with no appeal options. That was my first question, though the USDE Civil Rights Report said I only asked for money. I missed two classes in a row in the Statistics/Calculus class because I failed the first test. So I spent a lot of time writing my thesis. Hey, British Academia over American Academia, Its Always Thesis Only. So I left Boca Raton in April 2009, with 100k in student loans and credit card debt. Thats not that much for a young doctor. I took the CMA exam in Jacksonville, and sat for all 4 parts of the CIA exam that week of finals fall 2008. I passed 2, and passed the other 2 from my parents couch in Myrtle Beach. I also wrote my thesis in Myrtle Beach, and when I finished, I threatened the DA with pictures if he didnt drop the charges. I also took the CPA Exam for the first time in Myrtle Beach, my mom drove me to Charleston, because I got another DUI in Myrtle Beach.

I was charged with aggravated stalking and extortion against Jeff Madura. Not FAU. The 100 anonymous monkey madura emails were to Jeff Madura. The the death threat from my personal email address. I wanted him to feel it, to know where it came from. A good scheme, I think. Anonymous then personal. Lightning and Thunder. My plan after at least a year at FAU was to move to the Cayman Isles and work as an accountant. My dream was to be a CPA in the Cayman Isles, though I cant pass the CPA Exam. Instead of moving to the Cayman Isles, FAU fucked me up in the head, so I flew to Cape Town South Africa instead in February 2009, and applied for residency. My SAQA was waiting for me when I got back from being arrested in Palm Beach. After the death threat, the police responded immediately, and went to my parents' house in Fayetteville. They called me, and I went I get my gun. I was staying at a hotel, and the gun was at the Myrtle Beach house. I got arrested because I got drunk and went out looking for cocaine. You can do that you know, go downtown to buy drugs. The cops saw me sitting and waiting, and ran my drivers' license and saw the warrant.

This was the first extradition to Palm Beach. The second was for threatening the DA with pictures if he didnt drop the charges. Thats a tough ride, in that little extradition van. So I filed complaints against FAU with the accreditation agencies and the USDE, and the USDE wrote the bogus report that I plagiarised, did not do my homework, only asked for money and not an appeal, and that the extortion was not retaliation. Good job, Sandra Battle and Cynthia Pierre.

I was weak for the first conviction. I plead guilty to extortion and stalking and took 5 years probation. I was weak, and they took advantage of that. If I could turn back time, I would take the case to trial like John Goodman. Then for the pictures against the DA, I let them go. I just let them go. When your attorney begs you to take the deal, I did. I also did for the vandalism case at UNC with 5K restitution. UNC owes me money, right?

So after the probation violation, I took 2 years and unsupervised probation if I left the country. I told my attorney I would only accept unsupervised, and he led me astray. He told me that I could submit a motion for unsupervised once I was released. Again, my mistake, bad deal. So I applied for unsupervised in jail at Hamilton Prison, filed and withdrew a lawsuit against FAU with Judge Kiddlebrooks, and got in a war of words with the Warden. The first DR was for cussing out the warden in an inmate grievance, for not getting paper my father had sent me. You are only allowed 20 sheets in the mail, and he sent me 50, so they sent it all back. So I snapped. Then the warden got grimy and wrote me another DR for being a danger to the community for legal mail they went through of my original case. That set me off, and I cussed him out again in inmate grievances, got 10 DRs, then they sent the psych staff to talk to me, and they sent me Union, a psych camp. So I was Baker Acted out of jail the first time, and second time, where the probation officer met me at the mental health clinic. I refused to sign the probation papers, because it was god damned unsupervised probation.

So then first day out of jail I wrote the US Prison Report 2012, and emailed it to 100 probation offices and FAU. They arrested me the next day for contacting the victim. The judge later said at the probation hearing that I was not ijn the wrong for contacting FAU, my prior employer. They also charged me with resisting arrest. I walked out into the yard, and they just tackled me. Good scheme, tackle the criminal and charge him with arresting arrest. Then I hired the same attorney, first Douglas Leifert, then Ned Reagan, and he submitted papers for incompetent to proceed at my probation violation hearing. I fired him on the spot. He said, I quote, it was his job as my attorney to do the right thing. I will say, the mental health check turned out to be a blessing, welfare helped me get back on my feet after jail, very communist. The government should control the TV and interracial marriages in a communist country like Russia.

Then I was Baker Acted again after 10 years in jail, and sent Mcelheney Hospital, where I got the benefits check. At first I was angry to get benefits, and also angry to take spych meds. Though most psych meds are only psychiatric saline solution, they dont do anything. Its all a scam, psych meds. Its placebo effect.

After jail I went back to Myrtle Beach on my parents couch, and we had a plan to move back to Fayetteville to 707 Greenland and work for my dad for a year. They they disrespected me, In thought, so I used their Old Navy credit card to fly to London on a one way ticket. London did not let me pass, and sent me to LA. I tried to enter into Vancouver Canada, though they stopped me there too, and sent me to LA. I still had the credit card then, so I slept at the Santa Monica Pier and hostel and Wyndham for 2 weeks, then booked a Greyhound to DC. They have taxis waiting at the Santa Monica Pier. In DC, I went to Pennsylvania Avenue, and slept in front of the Trump Hotel my first nite. At some point I purposely lost my wallet and and Nazi passportes, then they returned the wallet, then the wallet magically disappeared in line at McDonalds. So I had no food. I slept in the park. It is very peacefu;I sleeping the park at nite. I stayed in the homeless shelter for 1 nite, though it is dirty there. At some point I emailed my parents from the library in Arlington, and they came to visit from Fayetteville.

I applied for a food stamps card the first time in DC, and they denied me, because I said I wanted to leave to DC. That sucked. I would have had to wait because I didnt have an ID anyways, though they could have approved the food stamps card for a homeless person. Then in Arlington we went to the food stamps office and they gave me a card on the spot.

Then I joined the Mormon Church for a bit in Arlington, met Marc Ireland, who wrote a reference for me to UNLV. Then I took the train back to Fayetteville, and my dad met me st the train station. We drove to Myrtle Beach, and he bought me a hotel room for a month for 1000K. Then we argued about money, they didnt give me the Old Navy credit card back, so I took it out of my moms purpose and my dads Lowes card. I booked a Greyhound to Las Vegas with the credit card, then tried to book a hotel room at the MGM Grande. The hotel would not take the credit card, for whatever reason, so I flipped out. I thought my mom had canceled the card, though she had not. It was just a coincidence. So I took the truck and drove to Fayetteville, and then Chapel Hill. Then i bought a hat at the Duke student store, and stayed at the Washington Duke Hotel. I was drinking at the bar and the cut me off, so I got mad, and checked out. I was going to stay there for a nite and then drive to Las Vegas. So I ripped a Duke basketball banner off the wall on the way out, and there was a cop waiting for me to arrest me for DUI, I passed the breathalyzer.

The cop told me to put the keys on the dashboard, what cop says that. So when they let me go with a court date, I had no keys. So I took a taxi to the junkyard, and then started walking. I had no keys, and it was late at nite, so I abandoned the truck, with my computer in it. I walked around Durham and Chapel Hill, until the credit cards were turned off. Then the police were called on me at the STRATA SOLARIS building, and I walked to Cameron from there. I found a great place to live in Cameron North Carolina. There is a big white house with a small one room building across the street with a mattress, and thats where I slept until the police arrested me for the Durham DUI, and extradited me back to Durham. They dropped the DUI, and I plead guilty to larceny. From there, after release, I kept walking, and was arrested in the Jordan Lake area, for IVC. I didnt have to go into Duke Hospital, he dropped me off in the parking lot.

It was there in Duke Hospital that they gave me the retarded check, SSI. Thats a good way to live, homeless with an SSI check. From there to a group home for 6 months, then Alliance Housing and Carolina Outreach in Durham. I passed the NC Insurance Exam, though was denied a license because of my record. I took the bus to the testing center. Then I entered Durham Tech, and was suspended after 2 weeks, for the ghost email. They never let me back in, even after the year had ended and I provided the counselor letter. Then I was involuntarily committed again for the UNC Student YMCA redecorating. Changed Act Teams because of that. Finally got on Special Assistance with the new Act Team. Got a car in Richmond with my dad. I paid 5K and he paid 5K, and the payments are 400 a month for 5 years.

Then Greg Bellamy and Abraham Dones and the FBI broke into my apartment and stole my 2 computers and 2 TVS. So I moved back to Fayetteville, to 707 Greenland, and Fayetteville Tech. The Raleigh District Court wont file my lawsuit.
