This letter is a final response to your request for information pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, dated September 4, 2022, and received in the U.S. Department of Education's (Department) FOIA Service Center on September 6, 2022. You requested the following:

"Emails from FAU Sleem case. I already submitted one request, though they never provided me with any of the evidence. I have a right to have the email evidence which accuses me of plagiarism and the alleged emails from the professors to me throughout the semester warning me of my performance. Where are these alleged emails and communications? Why is the USDE lying? I also would like the email from Durham Tech case that I allegedly sent to Audrey Alicia Muhammad. When do I get copies of the evidence?"

On February 2, 2024, you updated your request to the following:

"What I am primarily interested in the 2010 USDE FAU Civil Rights report, is the communications from my professors to the USDE, including from Madura, Gleason, Yuhn, and Dinev, including any plagiarism accusations. I want to see where the plagiarism accusations in the report come from. I already have a copy of the report and appeal from a previous request, so you don't need to send me the official report again and block out names. Just the interviews of my professors and the plagiarism accusations."

Your request was forwarded to the Office for Civil Rights. After a thorough search, no responsive records were located.
