#### At the Last Board Meeting

**On September 26th, 2024:** Upon notice duly given and received, the Annual Membership Meeting and Election of South Coast Shores Homeowners Association was held on the above date at the Association's community clubhouse, 3700 S. Sea Cliff Drive, Santa Ana, California. The following Inspector of Elections was appointed to count the votes and certify the results of the election: Julian Olsen, of 1921 W. West Wind. Management Representatives Present: Nicole Kardos-Claypool, CMCA, AMS for Optimum Professional Property Management.

The Association's Bylaws require 51% (93 of 182) of the members be represented either in person or by Secret Ballot to establish quorum for the Annual Membership Meeting and Election. The Inspector of Election reported that a quorum had been established with 112 members represented. The Annual Membership Meeting and Election was called to order by the Inspector of Election at 6:00 pm.

The purpose of the meeting is to elect 5 candidates to the Board of Directors, 4 candidates receiving the highest number of votes will be elected for a 2 year term expiring 2026 and the remaining one 1 candidate receiving the next highest votes will be elected for a 1 year term expiring 2025. A motion was made, seconded, and unanimously carried by the membership to APPROVE opening the floor for write-in nominations. The following member(s) were nominated: Tony Lonia, 2015 W. Summer Wind and Manny Monreal, 3706 S. Sea Cliff. (Both were present to accept nomination.)

Candidates on ballot for the Board of Directors were: Maurizio Bertoldi (incumbent), Jowanna Cannon (incumbent), Tina Polychronopoulos Montez, and Susan Todd (incumbent).

A motion was made, seconded, and unanimously carried by the membership to APPROVE the surplus of funds, if any, at budget year end be applied to next year's budget.

#### **Landscape News**

**Fall Tree Trimming is scheduled to start October 28th** weather permitting! This will include Sycamores, Ash, Liquidambar, Ficus Benjamina, Carrotwood, Pear, Orchid, and Jacaranda trees among others, as posted last month.

Tree trimming is very noisy, but if you have ear plugs it is very interesting to watch skilled tree techs at work—as it was with the removal of a large unhealthy 50-plus foot tree by the clubhouse on October 3rd. It is a 'high-wire' act, to be sure, to watch these guys climb the tree with all their safety equipment and chose just the right branch to drop without hitting anything. Larger branches at the top of the tree are roped up and then carefully cut in the direction to fall correctly and then lowered to the guys positioned on the ground that swing the branch to a good angle to be set down. Next step then, the ground crew feeds it to the chipper to mulch and be 'sprayed' into the large mulch truck to be recycled.















Removing trees is quite expensive, so the board will always consider our fiduciary duty as good stewards of HOA funds, among other factors in any decision like this. The HOA policy is to preserve as many of our mature, beautiful trees as possible, unless there are professionally documented tree health or safety concerns. And, as part of our policy if budget allows, we will normally replace any trees that are removed.

As part of our landscape crew we have a certified arborist that advises on tree trimming and removals on the property.

Products such as paints, cleaners, oils, batteries, smoke detectors, and pesticides that contain potentially hazardous ingredients require special handling when you dispose of them. No hazardous waste can go into SCS trash bins! E-waste such as televisions, tablets, cell phones and computers can also be taken to a HHW.

#### Ways to handle your Bulky Trash items

PLEASE do not leave your larger trash items where the painter's container used to be, as that is no longer our collection area. A new area for bulky item on-site collection is on hold for now...

#### So at this time, your options are:

- **1. If item is smaller**, break up the thing into smaller pieces and put in your garage court trash bin for our regular Thursday trash pickup. And if it is too much to fit in one week, that is, it takes up too much space, please spread it around to other trash bins in the other garage courts. But please remember: the bin top can't be held open because of your stuff in there or we are fined! This is best for a small set of drawers that you can break apart, bench, smaller chairs or other small furniture item, OR
- **2. For really big stuff that is heavy:** 'Junkluggers' (844.782.0255 or junkluggers.com) is a good, 'green' service to hire for haulaway items, *but at your expense*. This is great because they will come inside your house and carry the really large stuff down the stairs, like couches, big book cases or beds for you as part of the service! Or you may want to contact 'Thumbtack'—where there are vendors that you can hire to take care of home chores—online at https://www.thumbtack.com and find a selection of vetted junk haulers in our area that are known to respond very quickly, OR,
- **3.** Although we don't have a designated 'bulky' collection area onsite here on our property **Republic Waste has been coming to SCS** when you call it in to **657.467.6220**--as they have done with other residents lately. Don't stress that this is a HOA, just give good directions to your house. It may take several calls to get this done, as I have heard, as our address numbering is funky, and their guys aren't the best at finding our address numbers the first time they come. Follow their direction/dates as to when to put out your items by YOUR trash bin and please put a note on the stuff so we will know it has been called in and when to expect the pickup.
