## At the Last Board Meeting

On April 24, 2025: In accordance with Civil Code §4920, notice of the meeting and the agenda was posted on the bulletin board at least four days in advance of the General Session of the Board of Directors held on the above date at

the Association clubhouse. And in accordance with State Statute the homeowners present were given an opportunity to address the Board of Directors. Subjects brought up at this meeting were about clubhouse rental rules.

The Board reviewed proposed budget #1 prepared 03/12/25 for fiscal year 07/01/25 to 06/30/26 with an increase in assessments of \$59.00 (14.75%) from \$400.00 to \$459.00 per unit/home per month. A motion was made, seconded, and unanimously carried to APPROVE proposed budget #2 revised per the Board of Directors for fiscal year 07/01/25 to 06/30/26 with assessments remaining at \$400.00 per unit/home per month and monthly funding to reserves of \$11,250.00 which is less than the amount recommended of \$18,366.14 in the update reserve study by Foresight Financial Services dated 02/13/25 with reserves funded at 60%.

The Board of Directors is NOT currently considering a special assessment and/or obtaining a bank loan for fiscal year 07/01/25 to 06/30/26 to repair any major common area components or to fund the reserves.

Components with a remaining useful life of 30 years or less listed on the Executive Summary will continue to be funded per the approved budget and repairs or replacement of these items is not currently being deferred

A motion was made, seconded, and unanimously carried to APPROVE a new 'Welcome Committee' to be formed with board members and some homeowner volunteers with a cost not to exceed \$25 per new resident to help integrate new residents into our community with an information presentation.

A motion was made, seconded, and unanimously carried to APPROVE the payment of Cal Sparkle invoice for Pool and Spa Heater preventive maintenance dated 03/14/25 for \$2,585.91 Furthermore, the board wants to ensure the heaters are up and running prior to payment.

A motion was made, seconded, and unanimously carried to TABLE the proposal from Empire Pipe Cleaning pending additional bids to inspect sewer lines for possible blockages.

A motion was made, seconded, and carried to APPROVE the proposal from Tri-Star dated 04/04/25 to repair the trash enclosure gate and wall structure at 1920 Bay Crest for \$2865.

Board would like clarification from the City on the Wakeham Place perimeter exterior block wall crack repair responsibility that is pending. Our photographic evidence, provided by the landscape committee, shows that damage was caused by city trees and will be submitted to the City. Three bids for the repair were received and are being considered.

### LAGUNA HILLS MEMORIAL DAY HALF MARATHON, 5K & 10K


Monday, May 26 ALL RACES START AT 7am

## **Architectural News**

A new roof is an expensive proposition—about \$30,000 and up, on average, currently for SCS's kind of required concrete roof shingles. Once you've made that kind of investment, you'll want to protect it.

And even if your roof is older, maintaining it in good shape will prolong its life and keep you from having to replace it prematurely.

Here's what you need to do to get the most from your roof.

**Clean the gutters**. Ruined paint and damaged wood on siding is a typical problem caused by clogged gutters, but it might surprise you to learn that the overflow can also go upward. When leaves pile too deeply in gutters, water can wick into roof sheathing/underlay and rot it, or even rot roof rafters.

**Remove leaves and twig debris.** If you have tall trees nearby, piles of leaves will probably collect in roof valleys or near chimneys. If you don't remove them,

they will trap moisture and gradually decompose, allowing moisture to accumulate on your roof—and maybe even create fertile ground for weeds to grow! (FYI: HOA gardeners are not allowed to go on your roof to do any of this kind of cleaning, sorry.)

Also, as you know the geese like nesting on our roofs in the spring and look for areas that have leaves/twigs



already in place, to start nests. A bird on the roof is sure to leave droppings everywhere—and these acidic droppings may stimulate the growth of algae or moss on your roof by providing nutrients—shortening life span as it is exposed to bird droppings/nests, and the moisture they hold.

There are many ways to make your roof uncomfortable for birds; but one of the most popular and effective is to install roof bird spikes, also called antiroosting strips/heel blocks. These are essentially metal strips with small spikes that you can install on ledges, beams or anywhere the birds like to sit. These roof bird spikes don't hurt the birds, but make it uncomfortable or impossible for them to sit; so they simply have to fly elsewhere.

#### Besides keeping roof clean, also keep your eye on needed repairs on:

- Curling, loose, or broken/missing shingles—a yearly inspection is a good idea.
- Damaged flashing around vents, chimneys, skylights, and other openings that let moisture in that cause wood rot under roof tiles.

If anything seems amiss, ask a roofer to inspect ASAP. Most problems are fairly easy to fix or clean for professionals, but if you put repairs/cleaning off and water gets in and persists, the damage and costs can escalate.

## Recycling...not always intuitive!

# Paper and cans go into the recycling bin, but wood and scrap metal don't belong in our bins

Q: I have a pile of old wood from a construction project last summer. Can this go in our recycle bin? Also, can I put leftover flanges, braces and other miscellaneous metal items in the bin?

## A: This is one of those instances when a "leap" of understanding has been made, and unfortunely not for the better.

The leap is logical, but in this case, incorrect. Not everything can go in our bin or cart, and it's important to know WHY. Let's follow the first leap backwards: construction project wood is generally made from trees. Cardboard and paper are made from fibers that also originated, again in general, from trees. Therefore, the leap here is that if paper and cardboard are made from trees and are recyclable in perimeter street recycle bins (true), then all products made from trees must also be recyclable in bins and carts (false).

The reason this logic is false is because it misses several steps in deducing. Can construction project wood be recycled? Yes. In our bins at SCS? No, not when combined with household packaging products destined for the Republic's Recycling Facility — which is where ALL our SCS recycle bins' contents end up.

The Recycling Facility (RF) is primarily a container sorting facility. It also accepts paper products, cardboard, and box board — all products manufactured from wood and paper pulp. Leftover pieces of scrap wood from a construction project have not yet been chipped down into wood pulp and made into paper. It can't be sorted as a paper product because it isn't yet paper. The second leap is similar to the first: flanges, braces, and other metal parts are made from steel or possibly aluminum. Tinned steel cans and aluminum cans are recyclable in our bins. Scrap metal pieces are not. Why? They are not household product containers, and again, the RF is a container *sorting* facility only.

Scrap metal is highly recyclable, just not in our bins. Many cities and towns have a scrap metal drop-off box at the public

works yard or public recycle station. But placing metal non-containers and other metal scrap in your bins can lead to RF worker injuries and equipment failures at the RF.

# ONLY this stuff can go into the 6 RECYCLE bins located on the perimeter streets: Sea Breeze & Ocean Crest, inside the gated enclosures:

- Cardboard Boxes: MUST be flattened and must fit totally inside bin.
   (Please cut down large TV and other big boxes to fit)
- Paper: Clean Only, otherwise it is 'Trash' (like paint drop cloths)
   Paper towels, Bathroom Tissues, Dryer Sheets are NOT Recyclable!
- Empty \*Metal Cans/Tins: Clean
- Empty \*Plastic Bottles and Containers: Clean
- Empty \*Glass Bottles and Containers: Clean



So please, no mufflers in the recycle bin like we found last week! See next page for more info...

<sup>\*</sup>As per above article: Don't get 'creative', our recycling is mostly for 'containers' you buy food in from the Grocery Store!

What is ACCEPTABLE for our 6 existing Recycle Bins in ENCLOSURES on our perimeter streets, Sea Breeze & Ocean Crest (NOT the 'Food & Yard' waste Bins ON the streets), Wednesday is Pickup Day And, below is a visual guide to what is allowed in these bins.
