ORDINANCE NO. 061406

AN ORDINANCE PROHIBITING BASKETBALL PLAYING AND THE PLAYING OF OTHER SPORTS IN THE RIGHTS-OF-WAY OF TOWNSHIP STREETS, ROADS, AND ALLEYS AND PROHIBITING THE INSTALLATION OF EQUIPMENT FOR USE IN PLAYING BASKETBALL OR OTHER SPORTS WITHIN TOWNSHIP STREET, ROAD, AND ALLEY RIGHTS-OF-WAY.

WHEREAS, the Board of Supervisors of Millcreek Township has determined that the installation of equipment for use in playing basketball and other kinds of sports, such as poles, backboards, rims, nets, and related incidental items, within the rights-of-way of the streets, roads, and alleys of this Township interferes with the efficient and orderly plowing of snow, the efficient and orderly cleaning of streets, the efficient and orderly maintenance of roads in general, and is detrimental to the health and general welfare of the residents of and visitors to Millcreek Township; and

WHEREAS, the Board of Supervisors of Millcreek Township has determined that the playing of basketball and other kinds of sports within the streets, roads, and alleys of this Township is detrimental to the health and general welfare of the residents of and visitors to Millcreek Township.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the Board of Supervisors of Millcreek Township, Lebanon County, and it is hereby ordained and enacted by the authority of the same as follows:

**Section 1.** The installation of equipment, both permanent and portable, for use in playing basketball, or any other kind of sport, such as poles, backboards, rims, nets, and related incidental items within the rights-of-way of the streets, roads, and alleys of Millcreek Township, Lebanon County, is prohibited.

**Section 2.** The playing of basketball, or any other kind of sport, within the rights-of-way of Millcreek Township streets, roads, and alleys by any person, or persons, is prohibited.

**Section 3.** Any person, firm, or corporation who shall violate any provision of this ordinance, upon conviction thereof in an action brought before a District Judge in the manner provided for the enforcement of summary offenses under the Pennsylvania Rules of Criminal Procedure, shall be sentenced to pay a fine not more than \$1,000.00 plus costs and, in default of payment of said fine and costs, to a

term of imprisonment not to exceed ninety days. Each day a violation of this ordinance continues shall constitute a separate offense.
