 ORDINANCE NO. 081215

AN ORDINANCE ESTABLISHING NEW PENALTIES, FINES, AND PROCEDURES FOR VIOLATIONS OF THIS TOWNSHIP'S ORDINANCES REGULATING PARKING, BY AMENDING ORDINANCE NO. 11, ORDINANCE NO. SEPTEMBER 8, 1982, ORDINANCE NO. DECEMBER 14, 1983, AND ORDINANCE NO. FEBRUARY 8, 1995.

BE IT ORDAINED AND ENACTED, by the Board of Supervisors of Millcreek Township, Lebanon County, Pennsylvania, and it is hereby **ORDAINED AND ENACTED** by the authority of the same as follows:

SECTION 1: Section 7 of Article III of Ordinance No. 11 of this township, enacted September 8, 1976, is hereby repealed. Penalties, fines, and procedures for violations of the parking regulations set forth in Article III of Ordinance No. 11 shall be as provided in Section 5 of this ordinance.

SECTION 2: Ordinance No. September 8, 1982, of this township, enacted September 15, 1982, is hereby amended by deleting the second last

sentence, which reads, "Any person who violates this ordinance shall pay a fine of Five (5.00) Dollars for each offense." Penalties, fines, and procedures for violations of Ordinance No. September 8, 1982, shall be as provided in Section 5 of this ordinance.

SECTION 3: Ordinance No. December 14, 1983, of this township, enacted December 14, 1983, is hereby amended by deleting the second last sentence, which reads, "Any person who violates this ordinance shall pay a fine of five (5.00) Dollars for each offense." Penalties, fines, and procedures for violations of ordinance No. December 14, 1983, shall be as provided in Section 5 of this ordinance.

SECTION 4: Ordinance No. February 8, 1995, of this township, enacted February 8, 1995, is hereby amended by removing the prosecution of violations of Section 5 of that ordinance from Section 7 of that ordinance. From the effective date of this ordinance, the penalties, fines, and procedures for violations of Section 5 of Ordinance No. February 8, 1995, shall be as provided in Section 5 of this ordinance.


SECTION 5: Any person who violates the parking regulations of Ordinance No. 11, Ordinance No. September 8, 1982, Ordinance No. December 14, 1983, or Ordinance No. February 8, 1995, shall, upon conviction, be sentenced to pay a fine of not more than \$50.00 and costs. Provided: the police officer who determines that a violation has occurred shall attach to or place upon the vehicle that is the subject of the violation a parking violation notice stating that the vehicle was parked in violation of the law and citing the section of the law violated. The notice shall contain instructions to the owner or driver of the vehicle that if he or she pays the sum of \$35.00 within 5 days of the date of notice either by sending it to the township business office at 81 East Alumni Avenue, Newmanstown, Pennsylvania, 17073, or by making payment in person during regular office hours at the township business office at that address such payment will save the violator from prosecution and from payment of the fine and costs prescribed in the first sentence of this section.

SECTION 6: This Ordinance shall take effect and be in force five days after its enactment as provided by law.






