The question was asked about the number of ACC members on the committee and whether a majority of the members is required to approve/disapprove certain items submitted to the ACC. Charles provided the information that the Board is working on an appeal process.

All present expressed concern about the large amount of dog poop along the roads and bike paths.

A request was made to the BOD to have the builders anchor the porta-potties down. Recently, the wind turned over two porta-potties, and the contents were running down into the ditch lines. Another concern was that the builders did not lay enough gravel and that the truck tracked dirt and mud into the street, where many owners walk each day.
