DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS **BLACK ROCK FARM**

THIS AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS made this 2 day of Utility 2002, by BLACK ROCK DEVELOPMENT CORPORATION, a North Carolina corporation and WILLIAM M. BELL, hereinafter collectively referred to as "DECLARANT".

WITNESSETH:

WHEREAS, as fee simple owner of certain lands as more fully described in the Declaration of Covenants, Conditions and Restrictions for Black Rock Farm recorded in Book 773 at page 96 of the Bertie County Registry, the Declaran subjected lots in Black Rock Farms Subdivision to certain restrictions and covenants as more fully described in the recorded declaration, and;

WHEREAS, the Declarant desires to clarify and make certain a provision in the declaration concerning ownership of multiple lots by one individual owner, and;

WHEREAS, under the provisions of Section 11.8 of the declaration, the Declarant reserved the right to modify or amend the declaration at any time without prior notice and without the consent of any person or entity or the association for any purpose whatsoever.

NOW, THEREFORE, under the provisions of Section 11.8 of the declaration as recorded in Book 773 at page 96 of the Bertie County Registry, the Declarant hereby amends the declaration as follows:

Article 5, Section 5.1, is amended to add at the end of such section, the following provision:

"Where more than one low is owned by one person or entity (to include one or more persons owning as tenants by the entirety, joint tenants or tenants in common) and the parcel is used as one lot or parcel of land, then such multiple ownership of lots shall be deemed to be one lot and shall be subject to one assessment, whether periodic or special, as provided for in this article. If the ownership of the parcel is thereafter divided, then the divided ownership shall thereafter become subject to an assessment for each such separate owner."

THE REMAINING PROVISIONS OF THE ORIGINAL DECLARATION REMAIN IN FULL FORCE AND EFFECT.
