HOA MISSION STATEMENT

ANNUAL COMMUNITY DAY

The 2020 Community Day originally planned for May 23rd has been postponed due to the Coronavirus (COVID-19) crisis. The event will be rescheduled at a later date once it is safe for the community to conduct the event.

WATER ACCESS AREA DEDICATION

Due to the postponement of the Community Day we are working on a new date to dedicate the water access recreation area. The water access area will be named "Freddie Todd Park" to honor Mr. Todd's nearly 30 years of dedication to our community. Mr. Todd was a key member working with the Bell Family designing and developing the community starting around 1991. Over the years Mr. Todd has been instrumental in maintaining the community at a high standard of appearance. We hope to conduct the dedication ceremony in May or June if the virus conditions permit. Please plan on joining us to honor him and his family.

WATER ACCESS AREA UPGRADE PROJECT

The community pavilion now has water and electrical service. The reserve funded project cost came to \$6325. The pavilion now has county water service; 100 amp electrical service; two quad receptacle boxes; two 8' LED lights providing lighting to the covered pavilion area; and a LED dusk-to-dawn light for security purposes. We compliment and extend our deepest appreciation to Jernigan Electrical and Peele Plumbing for doing an outstanding job.

NORTH SHORE DRIVE DRAINAGE IMPROVEMENT PROJECT

The reserve funded project to improve storm water drainage along North Shore Drive remains delayed due to the wet weather. Once the ground hardens work can commence on creating a new drainage ditch along the rear boundaries of lots bordering the farm.

LOW COST MARKETING INITATIVES

- ❖ At our 2019 annual membership meeting, members voiced support for exploring low cost efforts to better market the community. The BoD implemented a member suggested proposal to erect a sign at the front entrance alerting vehicle traffic on Highway 17 that lots and homes are available within the community.
- The HOA website was updated with added emphasis on promoting and marketing the community.
- ❖ The BoD will continue to explore low cost efforts to assist members trying to sell their lots.

REVISED RULES PAMPHLET (APRIL 2020 EDITION)

The BoD has published a revision to the HOA Rules Pamphlet. The Rules Pamphlet is our primary document to assist members with complying with our governing documents. The pamphlet was updated to clarify procedures for installing driveway culverts. The major changes are found on pages 5-6. Additionally, the open storage of boats/watercraft period has been expanded from April thru September. The Rules Pamphlet is found on the HOA website under Documents and Forms.

DOG OWNERSHIP

Being a pet owner is an amazing experience. Along with the love and joy that comes with owning a dog are the responsibilities for proper care when it affects the community:

- Owners that walk their dogs are responsible for removing any dog waste.
- Owners shall take necessary precautions to keep their dogs in their yard.

DEAD OR DYING TREES

- ❖ In our August 2019 Newsletter we addressed owner responsibility regarding dead trees on their property. For both insurance liability and appearance reasons we encourage owners to identify and remove dead or dying trees from their property.
- ❖ Owners are also encouraged to remove down trees and/or branches from their property. Keeping lots clear of debris has a major effect on the overall appearance of the community.

OPEN STORAGE OF BOATS/WATER CRAFT

Owners may park their boats (with trailers) and other water craft vessels in plain view starting April 1st. Empty trailers should be stored at the designated community storage area.

CAMA permits are required any time there is a disturbance of soil within 75 feet of the normal water line. Any man-made object/feature within 75 feet requires a CAMA permit prior to construction.
