
Just a reminder always be cognizant of the time allowances noted on your play day scorecards...these time checks help to keep the pace of play.

Two years ago when we formed the Lake Windcrest WGA, it was necessary to establish By-Laws and Standing Rules. It was unnecessary to (as the expression goes) "re-invent the wheel". In other words, we used existing materials from similar organizations and revised them to fit our situation. However, after two years, we find a

need for additions, revisions or even deletions in order to reflect our current practices.

Below you will find changes recommended by your WGA Board. Any such changes require the approval of a majority of those present at a general meeting assuming there is a quorum present. According to our By-Laws a quorum of our WGA is 30% of the membership. Below are the proposed changes. Red lines have been drawn through current language to be removed. All new language is in blue print. Please review them and be prepared to ask any questions you may have prior to a vote for approval. A rationale for each change is noted below the proposed language.

Section 3. WEEKLY COMPETITION PLAY DAYS

C. Each week the game will be the same for all three (3) play days. Pro Shop credit will be awarded to the winner of the scheduled game. There will be an optional \$2 cash buy-in collected by the Playday Reps-Pro Shop to be split between the game winner and low putts whatever proximity has been selected (i.e. low putts, closest to the pin. etc.

RATIONALE: Pro shop offers service of collecting fees; low putts only is too restrictive.

E. Players shall sign up on-line by noon a minimum of two (2) days prior to the playday. If a player needs to cancel after the cut-off date, she must contact the appropriate play day representative and the Pro Shop.

RATIONALE: Updated to correspond with Pro Shop request.

Section 4. HANDICAPS

C. To maintain the pace of play, any golfer in difficulty may pick up and mark a 10 gross score with 4 putts. Note for GHIN posting purposes a player's max score should be entered as her Net Double Bogey (par +2 + her strokes on the hole. To maintain the pace of play, any golfer who is having great difficulty is encouraged to pick up and is to record a 10 gross and 10 net with 4 putts for the game. However, a player who is having difficulty but feels she may still be competitive for a low putts game, may opt to continue to play the ball and is to record the actual number of strokes and putts (for example, a player could have an 11 with one putt). In either case, for posting purposes, a player is to post her maximum which is par +2 + her strokes on the hole (when posting hole by hole, the maximum is calculated automatically).

RATIONALE: The major change requiring a score on a hole that is picked up to record a net 10 as well as the 10 gross is to remove the strokes factor. Since we are essentially a net league, the net score is the score that should be impacted most by the "pick up penalty". This requirement has no effect on scores posted to GHIN...only on the game score.

Section 5. USGA RULES shall govern all play with the exception of local rules. If in doubt about the interpretation of a rule, a player shall play a second ball and get a ruling from the Tournament Chairs or the Pro Shop

LOCAL RULES ARE AS FOLLOWS: Addition of part C.

C. When the game indicates low putts as a competition, counting putts begins as soon as a player's ball is on the putting surface. All strokes, whether still on the green or off the green, in any lie or with any club, will be counted as putting — once you start to putt, you are putting through the hole.

RATIONALE: Currently in practice, but not in writing. Note: you cannot have a chip-in once you start putting.

CONTINUED REVIEW OF THE PROPOSED CHANGES TO THE WGA STANDING RULES



SECTION 6. MONTHLY COMPETITIONS AND TOURNAMENT PROCEDURES

C. All putts must be "holed out" in all regular play day competitions, unless specified otherwise by the play day rep.

RATIONALE: This change allows for the possibility that certain conditions might permit giving putts or setting a maximum number of putts ... examples—newly aerated greens, excessive heat.

SECTION 7. CANCELLATION OF RESERVATIONS

Members will be charged for meal reservations for tournaments that were not canceled within 4 hours of the cancellation deadline. The luncheon selection for the tournament may not be altered unless there is advance notice of a medical concern (including allergies). If a player does not choose to participate in the tournament meal selection, the lunch may be boxed for carry-out and the player may order from the menu at her own expense. The Pro Shop may also charge members a cancellation fee.

RATIONALE: Our kitchen prepares for tournament food based on the number participants and a price is set; deviation from the planned menu by individuals is disruptive to preparation and billing.

SECTION 8. ANNUAL AWARDS

Annual Awards shall be given for various achievements as noted below. While all WGA members are encouraged to play on any play day, they will need to declare their designated play day for Annual Awards competition. Awards will be presented to golfers breaking 100, 90 or 80 for the first time on any monthly competition on any regular playday. Awards will be presented for Eagles and Holes-In-One made at any time at a WGA event during the year.

- A. BIRDIES: There will be (1) winner per flight play day for the golfer making the most birdies during the golf year. Two (2) or more prizes will be awarded in the event of ties.
- B. CHIP-INS: There will be (1) winner per flight play day for the golfer making the most chip-ins during the golf year. Two (2) or more prizes will be awarded in the event of ties,
- C. MOST IMPROVED GOLFER§: This will be awarded to the golfer in each flight who shows the best "adjusted" reduction in handicap using the recommended formula from the USGA. A player's handicap on the first day of play with the WGA for a season and her handicap at the official end of the season will be used to calculate the adjustment as the start and end dates in the formula.

 RATIONALE: Birdies and chip-ins should be recognized on all playdays rather than just one. However, no

WGA ABCD TOURNAMENT



It has been customary to always try to address in this column, any rules

questions that occur during a regular playday. Recently one of our players had a ball that landed in the mulched area in the center of the cart turn around on Hole # 12. The ball landed in the mulch close to the flagstone that borders the tree in that area. She asked if there was free relief based on the fact that this is a man-made area which is not an integral part of the course — or is it?

What constitutes an integral part of the golf course? According to the USGA Rules of Golf, an integral object on the golf course is: "an artificial object defined by the Committee as part of the challenge of playing the course from which free relief is not allowed. Artificial objects <u>defined</u> by the <u>Committee</u> as integral objects are treated as immovable (see Rule 8.1a). But if part of an integral object (such as a gate or door or part of an attached cable) meets the definition of movable obstruction, that part is treated as a movable obstruction. Integral objects are not obstructions or boundary objects." Got that? I don't! That explanation simply adds to my confusion! The flagstone border is definitely immovable in the sense that the player cannot simply move the stones readily to make a shot. The key word to me in that excerpt is "Committee". I believe

that our "Committee" essentially consists of our Professional Golf Staff...they determine the boundaries and penalty areas on our course. Golf courses can vary on how planted areas are treated. Some expect a golfer to play the ball as it lies in spite of being in a planted area. For example, one might say our player could have taken an unplayable lie, moving the ball back two club lengths farther into the mulch for a one stroke penalty. And maybe, some might even offer full relief out of the bedding area entirely...but then, where is relief? Certainly not on the cart path that encircles the planted area! This area on our course is deemed by the "Committee" to be an integral part of our course and therefore, does not allow the player relief.

Some clubs provide for relief from tree roots while others do not. Similarly, some clubs afford relief from sprinkler heads in the line of a putt from the fringe of the green while others do not. Often, a **local rule** may be adopted to cover such situations as those noted above. We have neither a root allowance nor provision for a sprinkler head in the line of a putt on the fringe. (Of course you get relief if your ball sits on the sprinkler head or it interferes with your stance or swing). Our club has adopted a local

rule (which was recommended by the USGA)which allows a player to take a two stroke penalty instead of the familiar stroke and distance penalty for lost or OB balls. If you have no idea where your errant shot went, then you have no option but to take a stroke and distance penalty. However, if you can estimate the spot where your ball is lost or went out of bounds and then find the nearest fairway edge that is not nearer the hole than the estimated spot, you can drop a ball in the fairway within two club-lengths of that fairway edge point, or anywhere between there and the estimated spot where your ball is lost or went out of bounds for a two stroke penalty. Some players think immediately that the two stroke penalty is more severe when actually it may not be at all. If your errant shot had good distance, then taking this option puts you in the fairway without the risk of another mishit. The stroke and distance penalty is one stroke to take the ball back to where you hit from and then you hit again and hope to get the same distance and land in the fairway. So, actually you have already added 2 strokes to hopefully get to the same place. It is always worth it to carefully assess your situation!
