- 1. That the Bylaws be amended to reflect the San Benito Economic Development Corporation's new address, which will be hereafter at 401 N. Bowie Street, San Benito, Texas, 78586;
- 2. That the Bylaws be amended to reflect language that addresses the excuse of absences in circumstances that are beyond the control of the Board Member. The language will reflect the following:

"A board member absent for more than three consecutive meetings may have his absences excused if he/she provides justification (letter from employer, medical excuse, etc.) for their absence and may soon after their absence may maintain regular attendance to the EDC Board of Directors Meetings.

# 16. Consideration and Action on the Procurement and Payment of Goods and Services Policy

- The Executive Director will be able to approve the procurement and payment of goods and services up to \$1,500.00;
- Procurement and payment of goods and services under between \$1,500.01 and \$3,000.00 will require approval from two (2) EDC Board Officers;
- Procurement and payment of goods and services over \$3000.01 will require full board approval.
- That signature of checks language mirror that of the resolution for signature cards.
