

## SMALL BUSINESSINVESTMENT PROGRAM

The Small Business Investment program has two (2) different financial reimbursementassistance grants that will be available to <u>entrepreneurs or small</u> business owners.

The **Small Business Investment Program** offers two grant opportunities and they are thefollowing:

- Commercial Façade Improvement Grant
- Rent Subsidy Grant

The eligible small businesses must be willing to open or expand within the City of San BenitoCity Limits.

GOALS: The goals of the Small Business Investment Program are to:

- Encourage business investment and activity within the City of San Benito city limits:
- Increase the city's sales tax base;
- Create opportunities for residents to show local;
- Reduce leakage of dollars to neighboring communities;
- Economically activate business properties:
- Encourage property investment that directly relates to improving the aesthetics ofbuilding and places in the designated/eligible areas of San Benito, TX;
- Expand business and employment opportunities in existing and deterioratedstructures;
- Enhance the visitors experience within our city attractions;
- Help new and existing businesses succeed by enhancing their curb appeal; and
- Increase commercial property values.

The Small Business Investment Program is funded on a yearly basis by the San Benito EDC and availability is subject to funding. For Fiscal Year, starting Oct. 1 and ending Sept. 30, the San Benito EDC has allocated a total amount of \$76,000 for **both** grants.

## Small Business Investment Program RENT SUBSIDY GRANT (RSG)

Rent Subsidy Grant The RSG is available to new business start-ups that want to open a new business location, as well for established businesses that want to relocate or expand their rentable space within the City of San Benito city limits. Note that new or expanded businesseswill only be considered for the RSG within the first two years from being officially opened forbusiness. Ex: Business officially opened February 2019; the business will be eligible to applyfor the RSG from February 2019-February 2021.

The San Benito EDC offers up to (50%) rent subsidy reimbursement of the monthly lease amount worth up to **six (6) months of rent** with a maximum of \$850 per month, and a total not to exceed \$5,000.00.

Businesses must sign a minimum of a two (2) year lease in a commercial space and be open for business before applying for this grant. The dollar per square foot of the space should fall within fair market value and should be disclosed on the lease agreement.

Prospective businesses must be open to the public at least six (6) days a week, minimum of eight (8) hours a day, and open past 6:00 PM.

If awarded, applicants must submit a copy of their sales tax report.

## **Eligible Businesses:**

- Upscale restaurants, coffee shops, specialty food & entertainment (including bar & grills);
- Artisan shops;
- Home furnishings and appliances;
- Visual and Performing Arts, galleries
- Specialty grocery store;
- Bookstores;
- Music stores:
- Boutiques

The business must be a small scale business with a minimum of 3 employees during the application period and no more than \$350,000 of gross sales a year.

Other business types may be considered by the San Benito EDC, yet subject to such businesses generating sales and impactful job creation.

Home based businesses or vendors operating inside another business are NOT eligible for the Rent Subsidy Program.

In order to avoid a conflict of interest or perception of it the property owner/landlord should not be a family relative to the business owner/tenant that will occupy/lease the property.

### <u>INELIGIBLE BUSINESSES</u>

Businesses located on illegally obtained property, illegally used property per the City's zoning ordinances, or properties used for anything beyond that which it is approved by the City's Planning & Zoning Board ARE NOT eligible.

Faith based organizations whose building is primarily used for religious activities such as worship, religious instruction, or conversion ARE NOT eligible.

The following types of businesses **ARE NOT** eligible:

- Adult entertainment oriented businesses (strip joints)
- Automotive sales
- Banking institutions
- Insurance Companies
- Check cashing stores
- Payday loan stores
- Nursing homes
- Education/Training Schools

- Assisted living facilities
- Child and Adult Day Care centers
- Entertainment/event centers or party halls
- Non-profit organizations
- Corporate or Chain Retail Shops
- Corporate or Chain Restaurants
- Franchise Retail Stores or Fast Food Restaurants

	Must provide proof the business has a Texas Comptrollers Sales Tax Permit;

	Draft of negotiated two (2) year lease. An executed lease agreement is requiredprior to the execution of the Rent Subsidy Grant Agreement. The dollar per square foot of the space should fall within fair market value and should be disclosed on the lease agreement;

The San Benito EDC reserves the right to request additional information to evaluate beyond that which is requested on the grant application.

The San Benito EDC reserves the right to accept or deny grant requests and to change grant guidelines at any time.

### **RENT SUBSIDY GRANT AGREEMENTS / AWARDS**

Applicants must have a signed Grant Agreement with the San Benito EDC prior to submitting any request for reimbursement.

Rent reimbursements will be processed monthly. Reimbursements will be made within 14 30 calendar days from when the tenant submits proof of rent payment and includes a paid receipt from the landlord.

Applicant shall remain open for business for the entire grant period of six (6) months. In the event the business closes the applicant will be required to reimburse the San Benito EDC any amount that has been distributed and will be ineligible for any future grant funding that the San Benito EDC may offer.

If awarded an agreement will need to be signed that stipulates a guarantee that the San Benito EDC will have a method to recover any funds from the grantee if it fails to remain open for the entire grant period.

Rent payments spent prior to execution of the Grant Agreement by both parties are not eligible for reimbursement.

Grant amounts may not be increased after the Grant Agreement is executed.

If the award grantee fails to be incompliance with the grant agreement stipulations/requirements, the San Benito EDC reserves the right to negate/rescind the award and redistribute those funds.

#### APPLICATION

Grant applications will be reviewed on a monthly basis and are due by last Friday of the month at 12:00 PM. Complete Applications received by the deadline will presented to the EDC Board of Directors for consideration during the following month EDC Board Meeting.

Applicants that have been denied a grant, may resubmit an updated application and be considered for the SBEDC Board the following month. However, do note that the San Benito EDC reserves the right to accept or deny grant applications/requests and change the grant guidelines at any time.

San Benito EDC reserves the right to request additional information to evaluate beyond that which is requested on the grant application. A good faith effort by the San Benito EDC staff will be made to notify all interested parties.
