- **Setup time is 7:00am Saturday morning; take down time is 5:00pm Sunday afternoon. All booths, equipment, vehicles, etc. must be removed by 7:00pm Sunday evening or they will be taken away at the owner's expense. There are no vehicles allowed on East Campbell Avenue after Saturday morning.**
- The business/organization understands that security, accident and theft insurance related to their booth and merchandise is solely their responsibility. The business/organization must provide the Chamber with a copy of their insurance policy naming the Campbell Chamber of Commerce as an additional insured.
- Should the business/organization violate any of the above requirements, the Chamber of Commerce reserves the right to ask the business to leave the Festival without a refund.
- No refund will be issued if cancellation is made after **ONE MONTH OUT FROM DATE OF EVENT.**
- In consideration for the opportunity of being a **Business Row** participant in the **Oktoberfest Festival**, and for the service provided by the Campbell Chamber of Commerce, I/we (on behalf of ourselves, our heirs, assigns and legal representatives) release the Chamber of Commerce, its officers, employees, agents and servants of liability for their negligence.
