Selection process:

- Panel of four consisting of three Old Courthouse Society Board members and one JA of Orange County staff member.
- Panelists will meet on a mutually agreed date at a mutually agreed location to score the submissions.



Criteria for scoring the document:

- Submissions will be scored on a 1-3 scale, in the following categories: Focus, Organization, Grammar,
 Spelling & Vocabulary, Style, and Original Content.
- See rubric for details:

CATEGORY	DESCRIPTION
1. Focus	The essay is clearly addressing the topic as outlined in the instructions.
2. Organization	The essay has five or more paragraphs. There is an opening paragraph, three or more detail paragraphs, and a concluding paragraph.
3. Grammar, Spelling & Vocabulary	Essay includes complete sentences. Punctuation and spelling is correct. The choice of terms clearly support the writer's point of view as described in the introductory and concluding paragraph.
4. Style	The essay is written in an interesting and informative manner. Paragraph transitions are well written.
5. Original content	The essay reflects original content. If there is a quote from any source, appropriate punctuation and attribution is used.

Award Presentation:

- The winning student will be invited to attend the Old Courthouse Society Board meeting on May 13, 2020, 12:00pm, where the check will be presented. **Student must be present to receive scholarship.**
- JA of Orange County will post a picture of the check presentation, along with the name of the winner on social media.

Timeline:

- April 3, 2020: Application cycle closes
- April 30, 2020: Winning student will be notified
- May 13, 2020: Scholarship presentation will be held at an Old Courthouse Member Society Board of Directors meeting at the Old Orange County Courthouse, Santa Ana.
