1. INTRODUCTION AND CORE PRINCIPLE

A serious political movement must be financially disciplined. Political independence begins with economic responsibility. When a party depends on a few wealthy individuals, it risks capture, compromise, and loss of integrity. When a party is funded collectively by its people, it remains accountable to the people alone.

This financial responsibility and transparency plan is founded on one clear principle: small, consistent contributions from millions of members create sustainable national power. No individual is overburdened. No one is excluded. Every member participates in building the movement.

This plan clearly defines contribution obligations, payment methods, income projections, approved uses of funds, accountability rules, and transparency mechanisms.

2. WHO CONTRIBUTES AND HOW MUCH

2.1 General Party Membership

Every registered member of the Freedom and Economic Movement contributes **50 CFA per month**. This amount is intentionally set low to ensure universal participation regardless of income level, profession, or location.

At 50 CFA per month, each member contributes **600 CFA per year**. This is affordable for individuals yet powerful when aggregated nationally. Members who feel able and convicted may contribute

more voluntarily, but no member is pressured beyond the minimum requirement.

2.2 Active Leadership and Field Operators

All active leadership and field operators, totaling **37,784 members**, contribute **100 CFA per month**, equivalent to **1,200 CFA per year**.

This contribution is **in addition to** the standard membership contribution. Leadership is not privilege; it is responsibility. Leaders are required to model discipline, commitment, and accountability. Voluntary additional contributions are welcomed but never compulsory.

These figures demonstrate that financial strength comes from organization, not elite dependence.

4. APPROVED USES OF PARTY FUNDS

Party funds are strictly reserved for lawful movement building, campaign execution, and national service. Every expenditure must serve the collective interest of the party and the nation.

Authorized uses include:

- campaign communication, printing, mobilization, logistics, and polling-day coordination.
- Funds may also be used for the construction and operation of party secretariats and main offices in all 10 regions, ensuring permanent grassroots presence.
- Legal counsel fees for compliance, election matters, disputes, and party protection are authorized.
- Transportation buses and logistics vehicles may be purchased and maintained for conventions, campaigns, training, and official activities.

No party funds may be used for personal benefit under any circumstance.

5. HUMANITARIAN AND NATION-BUILDING PROJECTS

The Freedom and Economic Movement is people-focused and nation-building. Humanitarian action is not optional; it is a moral obligation. These projects are implemented with dignity, transparency, and without discrimination.

Authorized humanitarian initiatives include:

- Clean drinking water projects.

- Emergency disaster relief.
- Community primary school construction.
- School furniture and learning materials.
- Educational scholarships and bursaries.
- Community health outreach clinics.
- Maternal and women support programs.
- Youth vocational training centers.
- Agricultural support for smallholder farmers.
- Food security initiatives.
- Rural electrification and solar energy projects.
- Sanitation and hygiene programs.
- Disability support, widows and orphans assistance.
- Youth sports facilities, community road rehabilitation.
- Housing and shelter assistance, digital access centers.
- Peacebuilding and reconciliation programs and civic education initiatives.
- These projects translate political presence into tangible national impact.

6. COLLECTION CHANNELS AND PAYMENT METHODS

To ensure transparency and prevent misuse, **all contributions must be made through approved channels only.**

Contributions are accepted via **mobile money transfers** using officially designated party numbers and **bank transfers** into approved party accounts. These channels are mandatory because they generate automatic transaction records.

Cheque contributions are permitted but must be forwarded to the **National Head Office** or the appropriate **Regional Secretariat**. Cheques must be payable to the Freedom and Economic Movement, the Movement Accountant, or the National President, and must clearly state the region and purpose.

7. MANDATORY MEMBER IDENTIFICATION FOR ALL CONTRIBUTIONS

Every contribution must be clearly identifiable. Each mobile money transfer, bank transfer, or cheque **must include the contributor's full name and party ID number** in the transaction reference.

This applies to general members, leadership, and voluntary contributors at all levels. Identification ensures accurate crediting, proper database updates, compliance tracking, and audit integrity. Contributions without identification are recorded as unallocated until verification is completed.

8. RECORD KEEPING, REPORTING, AND AUDIT

Every contribution must be supported by a mobile money reference, bank transfer confirmation, or official receipt. Records include contributor name, party ID, amount, date, region, municipality, and payment channel.

Financial reporting follows a strict structure. Municipal reports are submitted monthly. Regional reports are submitted quarterly. National summaries are compiled quarterly. An **annual**

independent audit is conducted by a third-party organization jointly selected by party leadership and members.

9. TRANSPARENCY, DISCIPLINE, AND VOLUNTARY CONTRIBUTIONS

Financial transparency is non-negotiable. Cash handling without documentation, use of personal accounts, unrecorded collections, and unauthorized spending are strictly prohibited. Any misuse of funds attracts disciplinary and legal consequences.

Members and supporters may contribute more voluntarily. Additional fundraising may be conducted for humanitarian response, transportation buses, or infrastructure projects. All voluntary contributions follow the same transparency and reporting standards.

10. CLOSING STATEMENT

This financial plan is not about pressure. It is about ownership.

When millions contribute **50 CFA monthly**, and leadership contributes **100 CFA monthly**, the movement becomes financially independent, disciplined, and accountable. Small amounts create massive impact. Shared responsibility builds collective strength.

11. BUDGET ALLOCATION FRAMEWORK

To ensure financial discipline, transparency, and impact, party funds are allocated according to a structured national budget framework. This framework balances three priorities: **winning elections**, **building permanent party infrastructure**, and **serving the people through national development and humanitarian action**.

All allocations are reviewed annually by the National Executive Council and adjusted only through formal approval processes. No spending is permitted outside these approved categories.

11.2 EXPLANATION OF EACH BUDGET CATEGORY

Campaign and Electoral Operations – 30%

This allocation supports communication, media outreach, printing, grassroots mobilization, campaign logistics, polling-day coordination, and lawful election protection activities. Elections are competitive and time-bound, and this fund ensures the party campaigns effectively without last-minute fundraising or financial panic.

Party Secretariats and Infrastructure – 20%

This fund supports the construction, renovation, and operation of permanent party secretariats and main offices in all **10 regions**. It includes office equipment, utilities, basic staffing support, and maintenance. Permanent offices ensure year-round presence and grassroots coordination, not election-only visibility.

Transportation and Logistics – 10%

This allocation funds the purchase, maintenance, fueling, and operation of transportation buses and logistics vehicles. These assets support conventions, trainings, campaigns, humanitarian response, and official party activities, especially in rural and hard-to-reach areas.

Legal Counsel and Compliance – 7%

This fund ensures continuous legal protection and compliance. It covers legal advisory services, election-related litigation, regulatory filings, dispute resolution, and lawful defense of the party and its members. Strong legal preparedness prevents disruption and protects democratic participation.

Humanitarian and Disaster Response – 10%

This allocation enables rapid response to floods, fires, conflicts, health emergencies, and other disasters. Funds are used for food aid, shelter assistance, medical supplies, and emergency logistics. This ensures the party can act quickly and responsibly when citizens are in need.

Community Development Projects – 13%

This fund supports long-term nation-building projects such as clean water systems, schools, rural electrification, sanitation, agricultural support, community roads, ICT access centers, and housing assistance. These projects create lasting impact beyond election cycles.

Education and Scholarships – 5%

This allocation funds scholarships and educational assistance for deserving Cameroonians, particularly youth from disadvantaged backgrounds. Education is a long-term investment in national stability, leadership development, and economic growth.

Party Uniforms and Identity Materials – 5%

This fund supports the production and distribution of official party uniforms and identity materials. Uniforms promote unity, visibility, discipline, and professional representation during campaigns, humanitarian projects, and national events.
