The cool temps as 2024 rolls in have Islanders searching the back of their closets for their pair of long pants and fur-lined flip flops. According to the Weather Wonks the average temperature for January here on our little sandbar is 57 degrees. That includes a lot of days in the 70's punctuated by a few says in the 40's. If 57 seems a bit low when you think of of how many sunny comfortable days we have in the 60's and even 70s just think is the average January temperature for Minnesota, Wisconsin, or Michigan and 57 doesn't seem so cold now.

Tom's rain report in this issue shows we have had about 30 inches of rain hereabouts in 2023 and as we wind our way into 2024 the lakes that are our water supply are at 30% capacity and we find ourselves under water restrictions that look to be part of everyday life now. City planners told the Corpus Christi City Council in December that it will take about 14 inches of rain in our watershed to get our head above water (restrictions) and when you consider that last year at this time the lake levels were at 44% things don't look good for being able to water the rocks in our yard with any frequency going forward. Keep in mind that the Island's water table is only a few feet below our feet and many homeowners Around The Island use well water for landscaping.

Island Bulkheads included in Padre Isles Management District

Created in 2013 and forgotten the district can issue bonds for bulkhead repairs and maintenance

By Dale Rankin The bulkheads on Padre Island owned by the Padre Isles Property Owners Association are part of the Padre Isles Management District created by the City of Corpus Christi and the Texas legislature in its 2013 session which has the authority to issue bonds for the maintenance and repair of Island bulkheads, according to records from the State of Texas and the City of Corpus Christi. In 2012 a group of Islanders concerned about the long-term future of Island bulkheads and the Michael J. Ellis Seawall initiated an effort to create a public entity that would allow for the issuance of bonds through the City of Corpus Christi to raise money in the case of a storm which caused damage to either. Creation of the district required action by City of Corpus Christi and the Texas Legislature. The effort resulted in the creation of the Padre Isles Municipal Management District by the Corpus Christi City Council

Resurfacing Work Resuming on JFK Causeway Bridge

Work Will Require Single Lane Closures

Beginning Wednesday, January 3 Texas Department of Transportation contractors resumed resurfacing travel lanes on the JFK Causeway bridge's main span with a polyester polymer overlay.

This work will require continuous, single-lane closures of the inside (left) lanes on the bridge's main span in both directions beginning at 7:00 a.m. Wednesday. This work, and the lane closures, will take place only on the bridge's main span, not the entire causeway.

The schedule shows the completion of the overlay work is approximately three weeks. The outside (right) eastbound and westbound lanes will remain open during the overlay work.

As previously announced, once the overlay work is completed, crews will then resurface the approaches to the bridge. The resurfacing work will require alternating, continuous, single-lane closures. The resurfacing will conclude work on top of the bridge that would affect traffic, and it is expected to be completed by the end of February. Work may still be taking place under the bridge. The continuous, single-lane closures are a necessary part of the construction operation. Message boards are alerting drivers to the work and single-lane closures.

The maintenance project is designed to maximize the life of the bridge and to

reduce the overall life-cycle costs of the bridge. Again, the work being done is on the bridge that spans the Gulf Intracoastal Waterway, not the entire causeway. The construction is focused on the main span of the bridge and includes repair to the substructure, superstructure, and railing. Also, existing armor joints and bearing pads are being replaced, and, lastly, a new overlay travel surface will be applied to the

Bad weather rarely disrupted activities for island residents and visitors last year. It was the second consecutive year of below-normal rainfall on the island as two-thirds of our total 2023 precipitation occurred during just eight stormy days. We also endured four dry spells that stretched three to six weeks (late February into March, June-July, July-August, and August-September) when the gauge catch was zero. Last year's 30.31 inches (the average of five locations reporting from Padre Island) was far below our record 2021 rains that totaled

The highest single-day precipitation fell on our sandbar last December 15. More than four inches of the wet stuff was measured at four Padre Island locations, though these soakings were quite localized.

Heavy rain — one inch or more in a 24-hour period — was recorded only eight times last year. Three of these were in April and then again in June, August, October, November, and December.

Volunteer Weather Reporters All Padre Island locations that regularly appear in the Island Moon Rain Report are only a few miles apart. However, their measurements sometimes vary by as much as one inch on a single day.

The Island Moon Rain Report uses data from the Community Collaborative Rain, Hail, & Snow Network (CoCoRaHS), a nonprofit organization that was founded at Colorado State University in 1998. It relies on 10,000 volunteers in all 50 states who buy precision rain gauges, record daily precipitation amounts at their registered locations, and then report them online.

There are currently five active CoCoRaHS weather observers reporting from Padre Island, and about 30 others sprinkled across Nueces County.

Official Reports

The National Weather Service (NWS) in Corpus Christi has compiled rain totals dating to February 1887. Measured now at the city's airport, the annual average is 31.74" using all 137 years. According to the NWS, the lowest annual rainfall was a scant 5.38" in 1917 which is the only total under 12".

Nuclear Testing Part 1

Dotson's Note: The history of nuclear testing began early on the morning of 16 July 1945 at a desert test site in Alamogordo, New Mexico when the United States exploded its first atomic bomb. Thanks to Major Huffy and Captain Cabin (Both U.S. Army), for the facts contained in this report, and to Rick Bajornas, UP, and CTBTO, for the photos.

in 1945 and the opening for signature of the Comprehensive Nuclear-Test-Ban Treaty (CTBT) in 1996, over 2,000 nuclear tests were carried out all over the world.

In the five decades between that fateful day

The United States conducted 1,032 tests between 1945 and 1992.

The Soviet Union carried out 715 tests between 1949 and 1990.

out 45 tests between 1952 and 1991.

The United Kingdom carried

France carried out **210** tests between 1960 and 1996.

China carried out 45 tests between 1964 and 1996.

India carried out 1 test in 1974.

Since the CTBT was opened for signature in September 1996, it is known that approximately 10 nuclear tests have been conducted (it's not always known if every test is *reported):

☐ India conducted two tests in 1998.

Pakistan conducted two tests in 1998.

The Democratic People's Republic

of Korea conducted nuclear tests in 2006, 2009, 2013, 2016, and 2017.

Nuclear explosions have been detonated in all environments: above ground, underground and underwater. Bombs have been detonated on top of towers, onboard barges, suspended from balloons, on the earth's surface, underwater to depths of 600m, underground to depths of more than 2,400m and in horizontal tunnels. Test bombs have been dropped by aircraft and fired by rockets up to 200 miles into the atmosphere.

Atmospheric testing refers to explosions which take place in or above the atmosphere.

All told, of the over 2,000 nuclear explosions detonated worldwide between 1945 and 1996, 25 % or over 500 bombs were exploded in the atmosphere: over 200 by the United States, over 200 by the Soviet Union, about 20 by Britain, about 50 by France and over 20 by China.

International concern over radioactive fallout resulting from atmospheric tests escalated in the mid 1950s. In March 1954, the United States tested its hydrogen bomb Castle Bravo in the Pacific's Marshall Islands. The Bravo test created the worst radiological disaster in the United States' testing history. By accident, local civilians on the Marshall Islands, US servicemen stationed on Rongerik atoll, and the Japanese fishing trawler Lucky Dragon,

were contaminated with the fallout.

Nuclear weapon tests have been carried out in all environments: above ground, underground and underwater. Atmospheric testing was banned by the 1963 Partial Test Ban Treaty. Negotiations had largely responded to the international community's grave concern over the radioactive fallout resulting from atmospheric tests. The United States, the Soviet Union and the United Kingdom became Parties to the Treaty; France and China did not. France conducted its last atmospheric test

Underwater testing refers to explosions which take place underwater or close to the surface of the water. Relatively few underwater tests have been conducted. The first underwater nuclear test — Operation Crossroads — was conducted by the United States in 1946 at its Pacific Proving Grounds in the Marshall

in 1974, China in 1980.

Islands with the purpose of evaluating the effects of nuclear weapons used against naval vessels. Later, in 1955, the United States' Operation Wigwam conducted a single underwater nuclear test at a depth of 600 m to determine the vulnerability of submarines to nuclear explosions.

Underwater nuclear explosions close to the surface can disperse large amounts of radioactive water and steam, contaminating nearby ships, structures and individuals. Underwater nuclear testing was banned by the 1963 Partial Test Ban Treaty.

Of the over 2,000 nuclear explosions detonated worldwide between 1945 and 1996, 25% or over 500 bombs were exploded in the atmosphere.



Underground testing means that nuclear explosions are detonated at varying depths under the surface of the earth. These comprised the majority (i.e. about 75%) of all nuclear explosions detonated during the Cold War (1945–1989); that is, over 800 of all tests conducted by the United States and nearly 500 of all tests conducted by the Soviet Union. When the explosion is fully contained, underground nuclear testing emits negligible fallout compared to atmospheric testing. However, if underground nuclear tests "vent" to the surface, they can produce considerable radioactive debris. Underground testing is usually evident through seismic activity related to the yield of the nuclear device. Underground nuclear testing was banned by the 1996 Comprehensive Nuclear-Test-Ban Treaty (CTBT) that bans all nuclear explosions on Earth. 75% of all nuclear test explosions during the cold war were conducted underground. Nuclear Testing 1945–2009--the beginning of the nuclear era. The United States launched the Nuclear Age in the pre-dawn hours of 16 July 1945 when it detonated a 20-kiloton atomic bomb code-named "Trinity" at Alamogordo, New Mexico. While the Alamogordo test demonstrated many of the explosion's effects, it failed to provide a meaningful comprehension of radioactive nuclear fallout, which was not well understood by project scientists until years later. We all know that the United States dropped two atomic bombs on Japan towards the end of World War II: one called "Little Boy" on Hiroshima on 6 August 1945; another called "Fat Man" on Nagasaki on 9 August. Toether these two bombs killed some 220,000 Japanese citizens outright, with over 200,000 more dying subsequently from lethal radiation overdoses.



*So far, no luck in finding this report. Dotson's Other Note: No sooner was World War II brought to a close in August 1945 than an all-out technical-industrial nuclear weapons race ensued between the two newly emerging superpowers, the United States and the Soviet Union. Between 1946 and 1949, the United States conducted an additional six tests. Then on 29 August 1949, the Soviet Union tested its first atomic bomb, "Joe 1". It ain't because I don't smoke myself


And I don't reckon that it'll harm your health

Island bulkheads the city map of the district includes the Michael J. Ellis Seawall. Creation of the district then found its way to Austin under the sponsorship of State Representative Todd Hunter and at Hunter's insistence the Management District would not contain the power to tax. What was subsequently passed was styled as Added by Acts 2013, 83rd Leg., R.S., Ch. 607 (S.B. 1098), Sec. 1, eff. June 14, 2013. There is nothing currently found in a search of city records that indicates the Padre Isles

Management District was ever dissolved, nor that a board of directors currently exists.

What is it?

The following language is taken from the bill, portions of which read as follows: CREATION AND NATURE OF DIS-TRICT. The Padre Isles Management District is a special district created under Section 59, Article XVI, Texas Constitution. (2) "Bulkhead property" means all bulkheads in the district owned by the district or owned or previously owned by the Padre Isles Property Owners Association, including any associated easements.

- (c) The district is created to supplement and not to supplant city services provided in the
- (d) The district will:
- (1) promote the health, safety, and general welfare of residents, employers, potential employees, employees, visitors, and consumers in the district, and of the public; (2) seek and provide needed funding for the
- district to preserve, maintain, and enhance the economic health and vitality of the district territory as a residential community and business center; and (3) promote the health, safety, welfare, and
- enjoyment of the public by providing for the preservation of bulkhead property and the navigable waters surrounding Padre Island. (e) The district will not act as the agent or instrumentality of any private interest even though the district will benefit many private interests as well as the public.

SUBCHAPTER B. BOARD OF DIREC-Sec. 3912.051. GOVERNING BODY;

TERMS. The district is governed by a board of five voting directors who serve staggered terms of four years with two or three directors' terms expiring June 1 of each odd-numbered year. The governing body of the city shall appoint directors from persons recommended by the board. Sec. 3912.052. QUALIFICATIONS OF DIRECTORS APPOINTED BY CITY. (a) To be qualified to serve as a director

- appointed by the governing body of the city, a person must be: (1) a resident of the district who is also a
- registered voter of the district; (2) an owner of property in the district;
- (3) an owner of stock or a partnership or membership interest, whether beneficial or otherwise, of a corporate partnership, limited liability company, or other entity owner of a direct or indirect interest in property in
- (4) an owner of a beneficial interest in a trust, or a trustee in a trust, that directly or indirectly owns property in the district; (5) an agent, employee, or tenant of a
- person described by Subdivision (2), (3), or
- (6) an initial director.
- (b) Section 49.052, Water Code, does not apply to the district. Sec. 3912.056. OFFICERS. The board

shall elect from among the directors a chair, a vice chair, and a secretary. The offices of chair and secretary may not be held by the same person. Sec. 3912.103. LIABILITY RESULTING

FROM DISTRICT ACTION. An action of the district or the board does not create a liability against the city or any other political subdivision. Sec. 3912.104. NO EMINENT DOMAIN

POWER. The district may not exercise the power of eminent domain.

What can it do?

Sec. 3912.102. AGREEMENTS; GRANTS. (a) As provided by Chapter 375, Local Government Code, the district may make an agreement with or accept a gift, grant, or loan from any person. Sec. 3912.131. IMPROVEMENT PROJ-

ECTS AND SERVICES; LIMITATIONS. (a) The district may provide, design, construct, acquire, improve, relocate, operate, maintain, or finance an improvement project or service described by Subsection (b) using any money available to the district, or contract with a governmental or private entity to provide, design, construct, acquire, improve, relocate, operate, maintain, or finance an improvement project or service authorized under this chapter and Chapter 375. Local Government Code.

(b) The district may undertake an improvement project or service only as necessary to reconstruct, preserve, and maintain bulkhead property.

Bonding authority

The legislation allows the issuance of bonds by the district for repairing and maintaining bulkheads within the district. That section of the bill reads as follows: SUBCHAPTER E. BONDS Sec. 3912.201. BONDS AND OTHER OB-

LIGATIONS. (a) The district may issue, by public or private sale, bonds, notes, or other obligations payable wholly or partly from district revenue. (b) In exercising the district's borrowing

- power, the district may issue a bond or other obligation in the form of a bond, note, certificate of participation or other instrument evidencing a proportionate interest in payments to be made by the district, or other type of obligation. (c) District bonds may be secured and made
- payable wholly or partly by a pledge of any part of the money the district receives from improvement revenue or from any other source Sec. 3912.202. BOND MATURITY.

Bonds may mature not more than 30 years from their date of issue.

Where do things stand?

The first board of directors, found in city files, was created on September 22, 2015, when the city council made the appointments. The last reference found in city files is May, 2019 when three new board members were appointed with terms to run through June 1, 2023 with the terms of the members appointed in 2015 set to expire in September, 2019. No entries in the city records indicate any board members have been appointed since that time meaning that all of the board seats are currently vacant with last appointments expiring in June, 2023. There are no entries to be found in city records of the dissolution of the District, the applicable bill language reads as

SUBCHAPTER F. DISSOLUTION Sec. 3912.251. DISSOLUTION BY CITY ORDINANCE. (a) The city by ordinance may dissolve the district.

(b) The city may not dissolve the district until the district's outstanding debt or contractual obligations that are payable from any source available to the district have been repaid or discharged, or the city has affirmatively assumed the obligation to pay the outstanding debt from city revenue. As stated above: The governing body of the city shall appoint directors from persons recommended by the board and since the terms of all of the board members have expired and there is no record of any appointments by the Corpus Christi City Council on or after June 1, 2023 (the last odd-numbered year) there is nothing in city records to indicate there is currently a seated (appointed) board meaning the council could potentially fill all five seats at their discretion. Which new members would be "recommended by the board" is unclear since there currently is no board found listed in city records and the current list of city boards does not mention of the Padre Isles Management District. The Island Moon has submitted an Open

into effect Hurricane Celia roared through the Coastal Bend and opened it again. The exact location of Corpus Christi Pass has moved around over the last few decades. What was originally Corpus Christi Pass was actually a series of passes which began at the bay side of what is now Fish Pass and ran parallel to the beach all the way down The Island to what is now the end of Whitecap Boulevard. The last remnant of the historic Corpus Christi Pass is Lake Padre. The pass historically was considered the dividing line between Padre and Mustang Islands. That line now is Packery Channel which was originally part of the Corpus Christi Pass system. But as far back as the 1960s there was

an acknowledged need for a permanent water-exchange pass between the Gulf and Corpus Christi Bay. A study was commissioned in February of 1967 by the firm of Turner, Collie & Braden based in Houston and presented to the Texas Parks and Wildlife Commission in June of that year. The idea of cutting the pass was done in an attempt to reduce salinity levels in the Upper Laguna. It was part of a larger plan to combat hypersalinity in the Laguna. The study concluded that a pass could be cut through Mustang and Padre Islands but jetties would be needed to keep it open in the long term.

It called for "heavy stone revetments...to fix the Gulf mouth of the pass and protect it from wave attack." It also called for the revetments to be at the terminus of jetties which would be a total of 1400 feet in length, bordering a channel that would be ten-feet deep by one hundred feet across

on the Gulf side of the beach and sixty-feet wide and seven-feet deep on the bay side. The side slopes would be at a ratio of one vertical to three horizontal.

Heavy stone revetments would run from the Gulf end of the jetties to a distance of 1000 feet landward with layers of stone weighing up to three tons and to a thickness of six feet. Lighter stones weighing up to 400 pounds would then be placed inside the rocks from the Gulf mouth to the point where the channel emptied into the bay. The jetties would be 400 feet apart on the Gulf side and extend a mere 400 feet out beyond the beach. The exact length would be determined not by designers but by the budget. The total budget for the project varied from \$2.7 million for 1000-foot jetties to \$5.4 million for 2200-foot jetties with half of the costs being the actually construction costs of the jetties themselves and the remainder for engineering, inspections and

Annual dredging was anticipated to cost between \$66,000 and \$100,000. But over the years as The Island was battered by hurricanes and attentions shifted to rebuilding rather than new construction the idea for a permanent Corpus Christ Pass was forgotten. Jetties were built at Fish Pass

It wasn't until 2005 when the tidal surge of a hurricane washed the last plug of sand from the nearly complete Packery Channel that The Island had a permanent water exchange pass. Dale Rankin





Dean Smith Basketball Coach

Dotson's Note: Dean Smith was born in Emporia, Kansas, on February 28, 1931. Both of his parents were public school teachers. Smith's father, Alfred, coached the Emporia High Spartans basketball team to the 1934 state title in Kansas. This 1934 team was notable for having the first African American basketball player in Kansas tournament history. Thanks to Bill Morgan, Dallas Shirely and Bobby Dibler for the facts contained in this report and to Bill Morgan for the photos.



While at Emporia High School for two years and then at Topeka High School, Smith lettered in basketball all four years and was named all-state in basketball as a senior. Smith's interest in sports was not limited to basketball. Smith also played quarterback for his high school football team and catcher for the high school baseball team.

After graduating from high school, Smith attended the University of Kansas on an academic scholarship. He majored in mathematics and joined Phi Gamma Delta fraternity. While at Kansas, Smith continued his interest in sports by playing varsity basketball, varsity baseball, and freshman football. He was also a member of the Air Force ROTC detachment. During his time on the varsity basketball team, Kansas won the national championship in 1952. In 1953, the team was an NCAA tournament finalist. Smith's basketball coach during his time at Kansas was Phog Allen, who had been coached at the University of Kansas by the inventor of basketball, James Naismith. After graduation, Smith served as assistant coach at Kansas in the 1953–54

Smith was commissioned as a Second Lieutenant on June 7, 1954, in the United States Air Force and was stationed at Fürstenfeldbruck Air Base in Germany where he was on a team that won the Air Force championship for Europe. He later worked as a head coach of United States Air Force Academy's baseball and golf teams. Yet, Smith's big break would come in the United States. In 1958, North Carolina coach Frank McGuire asked Smith to join his staff as an assistant coach. Smith served under McGuire for three years until 1961, when McGuire was forced to resign by Chancellor William Aycock in the wake of a major recruiting scandal, and consequently,


Years later, Aycock recalled that McGuire came to his office on a Saturday and told him he was resigning. Smith was waiting in McGuire's car outside South Building (UNC's main administration building), so Aycock called him in and asked him if he wanted to take over as head coach. Smith accepted, and the hiring was formally

announced the following Monday. When Aycock named Smith as head coach, he told the 30-year-old Smith that wins and losses didn't matter as much as running a clean program and representing the university

The Atlantic Coast Conference (ACC) had canceled the Dixie Classic, an annual basketball tournament in Raleigh, North Carolina, due to a national point-shaving scandal including a North Carolina player (Lou Brown). As a result of the scandal, North Carolina de-emphasized basketball by cutting their regular-season schedule. In Smith's first season, North Carolina played only 17 games and went 8-9.

This was the only losing season he endured during his career. In 1965, he was famously hanged in effigy on the university campus following a disappointing loss to Wake Forest. After that game, UNC would win nine of their last eleven games, and Smith would subsequently go on to turn the program into a consistent success. From 1965 to 1966 onward, Smith's teams never finished worse than tied for third in the ACC. For the first 21 of those years, they did not finish worse than a tie for second. By comparison, during that time the ACC>s other charter members each finished last at least once.

Smith's first major successes came in the late 1960s, when his teams won consecutive regular-season and ACC tournament championships, and went to three straight Final Fours, going all the way to the national championship game in 1968. They would appear in either the NCAA or NIT in every one of Smith's final 31 years in Chapel Hill. However, this run occurred in the middle of UCLA's stretch of 10 titles in 12 years, and in fact Smith lost to UCLA's John Wooden in the 1968 title game

Dean won his first national championship with his 1981-82 team, which was composed of future NBA players such as Michael Jordan, James Worthy and Sam Perkins. After winning the NCAA tournament, North Carolina had a record of 32–2. The other teams that advanced with North Carolina were Georgetown, Houston and Louisville. The Tar Heels actually finished in a tie for first in the ACC regular season with the Ralph Sampson-led Virginia Cavaliers. In the semifinals, North Carolina defeated Houston 68–63 in New Orleans, while Georgetown defeated Louisville 50-46.

The national title game against Georgetown was evenly matched throughout. However, with 17 seconds left on the clock, and the Tar Heels behind by 1 point, Jordan made what ended up being the game-winning shot to put the Tar Heels up 63-62. On Georgetown's ensuing possession, Hoya guard Fred Brown inexplicably passed the ball directly to Worthy with no Georgetown player anywhere near the pass. Worthy attempted to dribble out the clock, but was fouled with 2 seconds left. He missed both free throws, but Georgetown had no timeouts left. The Hoyas missed a halfcourt shot as time expired, giving Smith his first national championship in his seventh appearance in the Final Four.

Down For the Count

The event drew 5,000 people, standing room only. NBC decided to televise the spectacle. When their television producers walked into the building, they gasped and said, "Oh my, if we could just put this building on wheels." That building was of course Memorial Coliseum, the Madison Square Garden of the Coastal Bend. "It was the perfect fight venue because every seat in the house was a great seat," said promoter Lester Bedford. The ceiling was low and rounded and smoking was permitted at that time. The haze of the smoke hung over the ring as the boxers battled it out in front of a packed house. It was loud and the fans colorful, a perfect setting for showing a fight on television. From 1954 until 2004, boxing was the biggest professional sport in Corpus Christi, Texas. That's where I first saw Hector Luis "Macho" Camacho in person. Macho Man was a young, brash kid from Bayamon, Puerto Rico. Some guys have a chip on their shoulder; he had a whole cord of wood. He came into the fight with eleven wins and no defeats. They should have hung a sign over Camacho's dressing room door that said "Speed Kills;" he just had such energy. With lightning-quick hands he could hit you so many times you thought you were surrounded. His challenger, Rafael Williams, sported an equally impressive record of 19-1. On May 20, 1984, Macho Man danced while Williams kept catching Camacho's right-hand jabs with his face. The fight was stopped in the 7th round and ruled a TKO (technical knockout) in favor of Camacho. At 5' 6" tall and weighing 133 pounds, Hector was a middleweight, a star waiting his turn to shine. Hector wore his hair cut close with a spit curl that hung down in the middle of his forehead. His body was bronzed and his shoulders were broad enough to serve breakfast on. He was a southpaw. He owned guts, wanted glory, and was fifty miles away from being smart. Hector Luis Camacho Matias was born on May 24, 1962. He was the youngest of five children. At the age of three, Hector moved to New York City's Spanish Harlem with his mom, Maria, and took up boxing by the age of fifteen. He had been kicked out of six different schools, but managed to win the New York City Golden Gloves Titles, three different times. He was an admitted car thief, a drug user and had been arrested for shoplifting. He eventually served time in prison at Rikers Island. Pat Flannery, a language teacher who taught him to read, became a father figure to Hector. It was Flannery who is credited with giving Camacho his nickname. Sometimes even the harshest of sports acts as a rescue for some. It has been said that in ancient times

strangers shook hands to show they were

unarmed. That did not apply to the sweet

er-puncher, Camacho became a flamboyant

fighter during a time when the sport was in

science of boxing. A precise count-

its heyday. Hector looked like an extra in a gladiator movie. He would dress in unforgettable style and was always a favorite on the Las Vegas strip. He wore dazzling outfits and dressed as a Roman gladiator, in an American Indian headdress, Army camouflage trunks with helmet, a Puerto Rican flag outfit, and cheetah-skin trunks. He won four World Championships in three different weight divisions. Those divisions were listed as super flyweight, lightweight, and junior welterweight. Camacho would win one war after another. He had the temper of a gangster and was so mean he would kick puppies. Along the way he won a unanimous decision over Freddie Roach and Vinny Pazienza and a split decision over Edwin Rosario and Ray "Boom Boom" Mancini. On September 12, 1992, in Las Vegas, Camacho lost a unanimous decision to Julio Cesar Chavez. Camacho's record now stood at 27-2. On January 29, 1994, he lost a third time, to Felix Trinidad. On April 22, 1996, Macho Man returned to Corpus Christi to fight Wilbur Garst. This was a tune-up fight for Roberto Duran. The fight was stopped in the seventh round by TKO; Camacho was again a winner. I was at ringside with my pal Scott Robinson; what a fight. Angelo Dundee was Hector

Camacho's trainer. A total of 17 World Champions have fought in the old building: From Frankie Warren to Buddy McGirt, Jesse Benavides to Ronnie Shields, Lupe Suarez to Evander Holyfield, "Sweet Pea" Whitaker to Meldrick Taylor, and Jorge Paez to "Jesse" James Leija. I even remember Jerry Quarry singing the National Anthem before a fight at the coliseum. Yeah, the old gal had seen a lot. The coliseum was finally torn down in 2010. Camacho would retire in 2010. His thirty-year career record stands at 79-6-3 with 45 knockouts. It seems kind of odd these days to write about boxing, a sport in which a concussion is usually the preferred outcome, while the game of football goes on trial every day in regards to eliminating concussions.

On Tuesday, November 20, 2012, Hector Camacho was shot in the left side of his face while sitting with a friend in a black Ford Mustang. His friend, Adrian Moreno, was also killed by the drive-by shooter. After surgery, he was declared brain dead on Thursday and removed from life support. Camacho threw his last jab at life on Saturday, November 24, 2012. He was 50 years old and died of a heart attack. Cocaine was found at the scene, and there was no arrest at that time. There is no doubt that he lived in the fast lane, as dangerously as he fought. Camacho had five children from different relationships. Camacho's son, Hector Camacho Jr., is also a boxer like his dad, who is also survived by his parents. In life as in death, time moves forward. Macho Man and fight night at Memorial Coliseum are no more.

On the Rocks

My neighbor Bob and I were visiting about shoreline erosion around the city the other day, and he mentioned that he saw a big pile of broken concrete on the side of the road in Flour Bluff that was headed for disposal. We also visited about the bull rock that someone put on the north edges of the JFK Causeway in the vicinity of the bridge. We're still not sure who did that, and we're glad that someone is trying, but it's kind of a thin band aid. As the city moves to using more concrete in projects, and these projects near their design lifetime and have to be repaired, this is providing for lots of bro-

ken concrete. Most of the contractors are

figuring in recycling and selling the broken

increases, however there are other things

concrete in order to ameliorate material cost

that could be done. I was visiting with Parks and Rec's committee ex-chair Alissa the other day, as she had been chasing shoreline erosion with some of the city parks, especially on the bay facing north. This shoreline is where we are literally losing ground as I type this article here in January with a 25 mph north wind. These parks include North Beach, Ropes, Doddridge, Poesnish, Hans and Pat Suter Wildlife Refuge (there has been a little movement there lately), South Bay Park, and of course what we have happening on the Island around the causeway. South Bay Park and the JFK Causeway access roads are great examples of what happens when you're not proactive about shoreline

One of the perceived issues with shoreline protection is the permitting aspect of a project, mainly through the US Army Corps of Engineers (USACE) and/or the Texas General Land Office (GLO) depending on where you put your hard engineered protection (and it pretty much has to be a hardened solution due to \$\$ and permitting timing). Nationwide Permit #13 – Bank Stabilization allows you to place material centered on the mean high tide for up to 500 linear feet in a density no more than 1 cubic yard per linear foot. There are a few other conditions, but generally shoreline protection projects can occur without formal permitting, and I mean like yesterday (you loyal readers know that this is part of

what I do for a living). The short story is that there are materials of opportunity literally piled up all over the city that could be used to stem the erosion issues before they get out of hand.

City Council

City council next week looks kind of fun; they will be discussing the developer reimbursement funds which always creates sparks, the creation of a TIRZ #6 associated with the old Pharaoh's golf course, and miracle of miracles, an extension to the lease agreement with Riley P. Dog Park and the City. I have a feeling that public comment will be like the lines at the workout gyms after the New Year; stacked up.

Seatrout scoping

Next Tuesday is also the Texas Parks and Wildlife (TPWD) spotted seatrout scoping meeting at the NRC building on the TA-MUCC campus from 6-8 p.m.. I expect that these meetings up and down the coast will vary in public opinion; the meetings up north in Port Arthur and Texas City will be people against a reduction in bag limits, and the local meeting will be a majority of folks in favor for the reduction. This is based on data from TPWD and firsthand observations from local guides. This info will be collected from the meetings and be presented by staff at the next TPWD Commission meeting in Austin January 24-25th and you can watch/ listen online if you can't make it to Austin via link on their website.

ISAC January 16

What will not be held next week is the January meeting of ISAC, which is slated for the following Tuesday, January 16th. Island liaison Roger will be giving some updates on the Mobility plan and announcing a Commodores Park Master plan open house in February. We will be discussing an extension to the no-wake zone in Packery (again), FEMA/retaining walls, as well as other things critical to the future development of the Island. Good things to come in 2024. Backwater Adventures

New Year Goals!

The New Year is a great time for more than toasts and spirits. It's a time to reflect on our past and make goals and promises to ourselves, for the better. In life AND IN FISHING, take a quiet moment and write down some of these and put them away in a special place like on the wall of the garage where your fishing poles hang! The last few years I have enjoyed stepping away from using bait in my fishing and teaching every person on my boat to be a better ANGLER. Our catches have improved in numbers and quality. We don't have to depend on the quality of our live bait that day to decide how our catching goes. We are producing natural bait activity in the dancing of our lures. Anticipating a gamefish hiding at the end of each well-placed cast. Covering lots of water looking into the beautiful clear waters of our blessed Laguna Madre and Coastal Bend. No mess, more time to fish, and an ease of mind and stress unlike baitfishing altogether. Take a step and make the decision to raise your level of skill and efficiently this fishing year, let's learn the dance of the fake bait!

Soft plastics

Deep probing soft plastics with heavier jig heads from the boat is in its peak January and February.

Heavy light tackle heads are 1/4, 3/8,&1/2-

oz in weight. These will help you keep the lure close to the bottom and in the face of slow moving cold gamefish. I like to use this along the ICW canal and deep channels and holes. I use my RAPTER SHALLOW WATER ANCHORS, or my GPS SPOT LOCK on the HUMMING BIRD TROLL-ING MOTOR to hold the boat in position, after I have found fish on the SIDE SCAN UNIT. WINTER TIME IS THE BEST TIME TO LEARN HOW TO USE YOUR ELETRONICS. I make casts to the edge of the shallow water and slowly scratch the bait along the bottom towards the deepest part of the channel, and cast deep and bring it towards the edge. The angle fish are holding in often dictates if they will strike your bait or not. Vary your presentation offering everything from a slow scratch on the bottom, a bumping the mud, or an erratic bounce. Their aggressiveness will change with the lunar bite and their body temperatures. Winter time colors that tend to work best are PURPLE REIGN, Pearl/ CHARTRUSE, in the DOWN SOUTH LURES and my DOA 3" CAL SHADS in Texas Croaker, purple/chartreuse, and black/ chartreuse. Start your gears rolling now so by the time spring hits us you will have had two months of fine tuning and will be ready for the explosion of spring fishing.

Baffin Bay

The deepest areas in the natural flats are 5-6' and 8'in Baffin Bay. So there are a lot of areas that require mid-depth fishing even when it's the coldest time of year. I do this from the boat and it's the funnest and easiest way to learn how to become confident in using lures. Hunting the mid-depth waters of the Laguna Madre and surrounding bays is a endless opportunity of clear water and gamefish rich sand pockets. I dance soft plastics with 1/16, 1/8&1/4-ounce jig heads in these areas. I mimic the action of wounded and confused baitfish. Soft movements

timed to the theme of the day. Cold and slow lunar periods, I use a slow and easy to attack bait imitation. When the fish are fired up and it's warm a faster more aggressive action.

Let's start your year off right with a fantastic adventure in bay fishing and learning the water and how to catch fish here. I'm easy to find around MARKER 37 MARINA AND ALWAYS EAGER TO MEET ANGLERS AND TALK FISHING.

If you really want to boost your fun this year rent a bait slip at MARKER 37 Marina! It makes it so easy to get the family on the water all year. Sinkholes: A Window into the World Beneath Your Feet

Florida is a state known for its thousands of process known as "recharging". sinkholes that dot the landscape. This is due Fish and other animals can live down here to the state lying on a giant slab of limestone with no problem; and some are permanent that was formed over millions of years by the accumulation of dead shellfish. The Texas bedrock is the same limestone, and therefore has the same kast topography that Florida does. "Karst topography" can be defined as bedrock made up of limestone or gypsum that is slowly eroded away by water to form underground caverns and sinkholes. Sinkholes are a fascinating window into the world below our feet. They provide access to the underground aquifer, as well as sustain life that is found nowhere else in the world!

These "karst windows" are formed over hundreds of years as the limestone is eroded away. Limestone itself is a very soft rock made primarily of calcium carbonate; the same compound found in the shells of various mollusks and clams. Since limestone is soft, it doesn't take a very strong acid to dissolve it; which is why rainwater is so adept at eroding away the limestone to form

underground caverns. As these caverns grow larger, the ceiling grows weaker under the weight of the soil, plants, and other things on the surface. Eventually, the ceiling collapses in on itself, bringing everything on the surface down with it. Over the course of several days, the soil and grass that was first pulled into the sinkhole will slowly disappear down the hole, and into the aquifer. The trees follow, seeming to fall in slow motion toward the bottom of this new pit in the Earth's surface. This process gradually continues as more soil sloughs off into the hole, making it bigger as time goes on. The water that pours in begins its underground journey through the aquifer before it eventually emerges as a spring, or is brought up by someone's well. This water is adding to the groundwater, a

residents. These include blind crayfish and salamanders that hunt using touch rather than sight. In the sinkhole bowl itself, you can find species of plants, salamanders, and invertebrates that thrive solely in that specific environment. Sinkholes are just one example of how

connected all the plants and animals, including humans, are on this planet. If one part of this ecosystem is changed, it can have damaging repercussions down the line; whether it be destroying the delicacy of the karst window itself, or contaminating our drinking water. We have to be cognizant of our actions, otherwise we will also pay the price.

invasive species officials put out a news release about the blue land crab Cardisoma guanhumi warning folks from Georgia through the Carolinas to be on the lookout for this new invasive species. The concern appears to be that their large and deep burrows might damage salt marshes. Cardisoma is native throughout the Caribbean and Florida and occurs here. I've seen them on the Texas A&M Corpus Christi campus --even under shrubs by a classroom building which is definitely not their usual habitat.

Although the Georgia DNR is raising the alarm now, a USGS map of the crab's range in the U.S. shows considerable records of occurrence up though South Carolina and an occasional record in North Carolina (see https://nas.er.usgs.gov/viewer/ omap.aspx?SpeciesID=2774). The USGS also shows our part of Texas and the Rio Grande Valley as being part of the native range. Notably, the USGS site lists this as a non-indigenous species, rather than the more pejorative term of "invasive species."

It seems clear that this is not a problem of introduction by people, like planting Brazilian pepper because of its pretty red berries at Christmas time or releases of lionfish from the aquarium trade. Rather, it's a range expansion that is most likely occurring because of a warming climate. Although since people contribute to climate warming I suppose you could infer that people are indirectly causing the crabs expansion --- ugh, see how I dither early in the morning with only one cup of coffee! Anyway, like our mangroves (considered by some to be invasive here! See earlier articles) Cardisoma is marching northward but our salt marshes certainly don't appear to be overrun by them.

So, if you see this pretty blue crab when you're next in our salt marshes don't panic. It lives here too! It's been here certainly for many decades, and likely for hundreds if not thousands of years, probably cycling in and out depending on incidents of very hard freezes much like mangroves have. This crab is substantially larger than the much more common (and native) fiddler crabs we have in marshes. And, similar to the fiddlers, males have one claw much larger than the other. They use these to "wave" to females to come join them in their burrows. But, they're also not above giving you a nice pinch if you try to catch one. When I lived in Miami in the 1970's their massive population would cause automobile accidents in seasons when females migrated to the open water to release their eggs. Crabs crossing roads by the many thousands were often crushed causing slick conditions! Anyway, as noted above, share the marsh with them and keep Going Na-

<u>Trivia Question of the Week</u>

Which is correct, Duct Tape or Duck Tape?

Some call it Arkansas Chrome but it is one of the burning questions of our times friends; Duck Tape or Duct Tape? We probe the depths of the human condition by plumbing the existential depths with questions like... "It's used for Ducts not on Ducks right? So it must be Duct Tape." Trivia Question of the Week

Which is correct, Duct Tape or Duck Tape?
