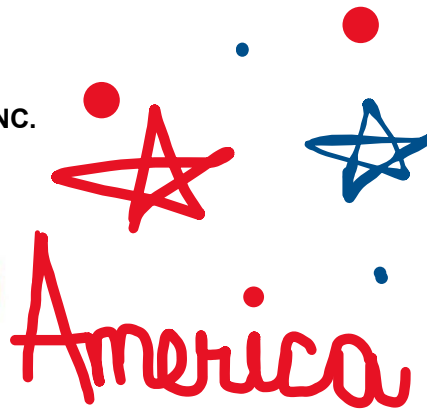

NOTICE TO EXHIBITORS

*The safety of the dogs is the primary concern so by entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

*Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.

*It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.

*Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. *Exhibitors are responsible for complete, accurate, and legible information on the entry forms. Any illegible or incomplete entries will not be entered in the trial. No female (Bitches) in season allowed at trial.

<p>Coming South on I-75: Take exit 50A for Dryden Rd. Keep left at the fork, follow signs for Dryden Rd N. Turn left onto Dryden Rd. Then turn left onto Arbor Blvd. Take Arbor Blvd till it ends into River Rd. Turn left on River Rd., proceed approximately seven-tenths of a mile. Dayton Dog Training building is the last building on the left just past the Orbit Industrial Park and just before the lake on the left side.</p> <p>Coming North on I-75: Take the Dryden Rd exit – turn left onto Dryden Rd – follow to Arbor Blvd. turn left onto Arbor Blvd – follow to end at River Rd turn left – Dayton Dog Training building is on left about seven-tenths of a mile, just past the Orbit Industrial Park on left.</p>
