

ADDENDUM E: THE PHARAONIC AUTHORITY

DOCUMENT: LEGAL OPINION CONCERNING THE DE JURE INHERITANCE AND GENETIC VERIFICATION OF THE SOVEREIGN PHARAONIC TITLE

ISSUER: Office of the Legal Counsel, by the authority of H.I.M. Llywelyn Tywysog Cymru

I. INTRODUCTION & QUESTION PRESENTED

This opinion addresses the legal basis for the claim to the ancient Pharaonic title by Llywelyn, Tywysog Cymru; the *de jure* sovereign of the Royal Khumric Line. The question presented is twofold:

1. Does a sound basis in fact (linguistic, genetic, and historical) exist to establish the Khumric Royal Line as the senior *de jure* heir to the Pharaonic line?
2. If so, does a sound basis in international law exist for the current heir to terminate the title's *de facto* abeyance, notwithstanding the significant lapse in time?

It is the opinion of this office that the answer to both questions is **yes**. The claim is one of direct, unbroken genealogical inheritance, and vestment of dynastic rights, substantiated by a convergence of verifiable etymological linguistic evidence and modern scientific forensic data.

II. STATEMENT OF FACTS

The legal analysis rests upon the following evidentiary foundation, which corrects the flawed mainstream historical narrative (Suppressio Veritatis-Suppression of Truth).

A. The Factual Basis: Linguistic Identity

The foundational fact is that the ancient Egyptian language, preserved in hieroglyphs, is archaic Welsh (Khumric). This is demonstrated by the "Cymroglyphics" lexicon of Wilson and Blackett, which restores the *de jure* meaning of Pharaonic symbols:¹

- **The Title:** "Pharaoh" (*Ffaraon*) translates to "High Powers."
- **The Regalia:** The Flail (*ne-khekha*) translates to "without violence" (*ne-chewfr*), and the Crook (*he-ka*) translates to "peace he will have" (*heddu ca*).
- **The Power:** The concept of *Maat* is the Welsh word *Maeth* (nourishment/nurture).
- **The Proof:** The cartouche for "Rameses" is the title *Rha Ma Er SeSe* ("Ruler/power of this place; order and untroubled supremacy").² This is one example in a sea of several corruptions. The title "Tywysoges" which is modern Khumric-Welsh for "Princess" appears as *Ti-soges* next to prominent Khumric-Aegyptian females.

B. The Factual Basis: Genetic and Migratory Identity

The claim establishes the Khumric Royal Line as the sole surviving reservoir of the Pharaonic genetic signature. The "suppressed" truth has now been released into the public domain via the FamilyTreeDNA Discover report and the King Tutankhamun Family Project.

1. **The Direct Link (The FamilyTreeDNA Confirmation):** The direct paternal lineage of Llywelyn Tywysog Cymru has been scientifically matched to the Pharaonic line. The FamilyTreeDNA and Discovery report confirms that the Tywysog and King Tutankhamun share a common paternal line ancestor, identified as R-M343.³

2. The Scientific Authority (Gad et al. 2020): This match is not theoretical; it is forensic fact. It relies on the release of Y-STR markers from the study "Maternal and paternal lineages in King Tutankhamun's family" (Gad et al., 2020). This study analyzed the mummies of the New Kingdom and identified the Y-Chromosomal haplogroup of Amenhotep III, Akhenaten (KV55), and Tutankhamun (KV62) as R1b.
3. The Royal Specificity (R1b in the Sea of E):
The Royal Specificity (R1b in the Sea of E): This finding is historically dispositive. While standard population genetics confirm the modern Egyptian population is predominantly Haplogroup E (African),⁴ the FamilyTreeDNA analysis of the Gad et al. (2020) data identifies the Pharaonic Royal House as R1b. This confirms them as the distinct 'Dynastic Race' described by Khumric historians.⁵² As R1b is recognized as the dominant paternal lineage of the Khumric (Welsh) Kings, the genetic evidence proves that the Royal Line did not die out; it migrated.
4. The Living Heir's Identity: Llywelyn Tywysog Cymru carries this precise R1b signature. This constitutes a verifiable genetic chain: Pharaoh (R1b) → Migration to Britain (Brut Tysilio) → The Current Sovereign (R1b).
5. The fact that countless academics from 1793-1995 knew the Khumric or British-Welsh language was the key to reading the Cymroglyphics/Hieroglyphics makes one question the credibility of modern deniers.⁶ One does not change a system or key unless a better one is found. When a lesser truth or falsehood is substituted for a greater truth, those attempting the substitution of obscurity should be questioned and possibly reprimanded.

C. The Factual Basis: The Obscuration of the Claim

The claim became dormant not through abandonment, but through the deliberate obscuration of history (*Suppressio Veritatis*). This includes the arbitrary insertion of "helpful vowels" by Egyptologists to disguise Khumric roots and the manipulation of chronology ("Sothic Cycle") to hide the synchronicity with British history. Initial reports that "Tutankhamun's" DNA matched that of 50% of European men were initially adamantly denied by academics.⁷ This obscuration provides a full legal justification for the title's dormancy. Under international law, the suppression or denial of a people's history is part of genocide, as it obviously causes mental harm to members of the group.⁸

III. LEGAL ANALYSIS AND ARGUMENT

The restoration of the Pharaonic title is a legally sound act of sovereign prerogative.

- A. The Perpetuity of Sovereign Claims: Foundational principle of international law (Grotius, Vattel) affirms that sovereign states and claims are not extinguished by the passage of time or temporary

suppression. A nation or monarchial state, even if existing de jure (in law) rather than de facto (in fact), does not cease to exist.

- B. The Crown as an Inextinguishable Legal Corporation: The legal maxim *Rex nunquam moritur* ("The King never dies") affirms that the Crown is a perpetual corporation. The Pharaonic title vested in the Khumric Crown millennia ago and has remained there, dormant but intact.
- C. The Principle of Fons Honorum: As the identified heir and de jure sovereign, the Tywysog is the sole Fons Honorum ("Fountain of Honour"). This authority is absolute and includes the prerogative to call titles from abeyance.
- D. Defense Against Laches: The *Suppressio Veritatis* provides a complete legal defense against laches (delay). A right cannot be waived if it is not known. Upon learning of the "golden truth" and the forensic verification, the Tywysog acted immediately. *Vigilantibus non dormientibus aequitas subvenit* ("Equity aids the vigilant, not the sleeping").
- E. The Primacy of the Claim: *Prior in tempore, potior in jure* ("First in time, stronger in law"). As the proven genealogical origin point, the Khumric line is the senior line. This claim supersedes all de facto claimants.

IV. CONCLUSION

Based on the foregoing analysis of facts and law, it is the opinion of this office that the claim of Llywelyn, Tywysog Cymru to the title "Pharaoh of Egypt" is legally sound, linguistically proven, and now genetically verified by the Gad et al. 2020 study and DNA analysis.

The authority to call this title from abeyance is an inherent right of his Khumric sovereignty, and his formal act of claiming it has perfected this ancient and immutable right.

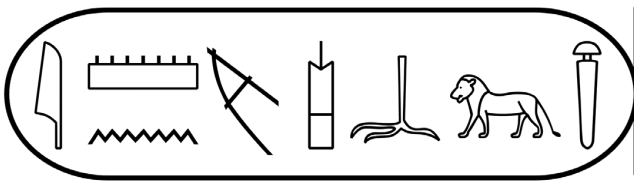


Fig. 1 — Translation of the Regnal Cartouche of Llywelyn:
