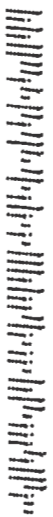

In alignment with the National Vessel Documentation Center's (NVDC's) continuous process improvement efforts, as of October 1, 2025, NVDC's application and submission process will be transitioned to an all-electronic request system.*

Customers not already utilizing NVDC's secure web-based system, [eStorefront](#) (linked here) or through the website at: [National Vessel Documentation Center / Order Products Online / NVDC ESTOREFRONT](#) are encouraged to do so at the next available opportunity.

PDF FILING: As of October 1, 2025, .pdf filing will no longer be available.

RENEWAL NOTIFICATIONS BY PAPER: NVDC will no longer be mailing CG-1280 Renewal Applications by mail to single-vessel owners. The CG-1280 application will be replaced with a courtesy notice directing customers to eStorefront.

~~Fleet vessel owners will continue to receive notices, in order to utilize the form-generated sequence number required to renew fleets on eStorefront, until further notice.~~

PAYMENTS: In accordance with [Section 3\(c\) of the President's "Modernizing Payments To and From America's Bank Account" Executive Order](#) signed on March 25, 2025, NVDC will no longer accept checks, cash, or money orders, or process credit cards* via form CG-7042 Authorization for Credit Card Transactions, as of October, 1, 2025. Credit card and ACH payment methods are accepted on eStorefront.

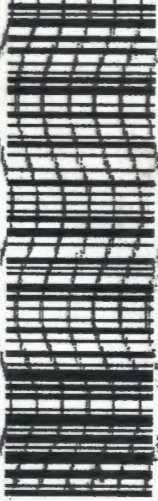

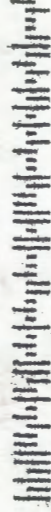
