SUBJECT: URGENT: NOTICE OF FORCE MAJEURE & SOVEREIGN IMMUNITY - Vessel PRYDAIN

DATE: December 24, 2025

REF: Vessel *Prydain* – Emergency Entry at Rainbow Harbor **STATUS: FORCE MAJEURE / VESSEL IN DISTRESS**

1. DECLARATION OF EMERGENCY (FORCE MAJEURE) Be advised that the vessel **PRYDAIN**, carrying the Head of State and the Imperial and Royal Family of Cymru, has entered Rainbow Harbor under conditions of **Force Majeure**.

- **The Incident:** While navigating near Island White during a Gale and Small Craft Advisory, the vessel suffered a catastrophic failure of ground tackle. To preserve the lives of the souls on board, we were forced to cut away our anchor and ground tackle.
- **Current Status:** The vessel is currently **WITHOUT ANCHOR** and mechanically unable to hold position in open water. We have occupied a dock at Rainbow Harbor (Pine Ave Pier) as a **Port of Refuge**. This is not a commercial entry; it is a necessity for the preservation of life.

2. ASSERTION OF IDENTITY AND IMMUNITY We assert our status as **Internationally Protected Persons (IPPs)** pursuant to **18 U.S. Code § 1116** and Customary International Law.

- **Federal Verification of Identity:** The Master of this vessel is federally identified by the U.S. Department of State as **Llywelyn Tywysog Cymru** (Last Name: *Cymru*, Title/Name: *Tywysog Llywelyn*).¹
- **Estoppel by Record:** The U.S. Federal Government has already validated this Title as a Legal Name via the issuance of a U.S. Passport and identification by the DOJ FARA Dept as “Llywelyn Pendraig Brenin y Brythoniaid (British/Khumric: Llywelyn Pendragon King of the Britons) of the Kingdom of Britons, Court in Exile”. As such, all local authorities are **estopped** from disputing this identity/status.

¹ Cymru is interchangeable with the Tribes, as in the Tribes of Israel. See: George Rawlinson "History of Herodotus" Vol. III (1862) Appendix to Book IV, Essay I, On the Cimmericians of Herodotus and the Migrations of the Cymric (Welsh) Race, page 150, footnote 1

Cymru is also interchangeable with “Wales” meaning Roman-lands.

See: John Davies, “A History of Wales” Penguin Group Publishing, London (2007) page 69

“It would appear that “Welsh” meant not so much foreigners as peoples who had been Romanized; other versions of the word may be found along the borders of the Empire-the Wallons of Belgium, the Welsh of the Italian Tyrol and the Vlachs of Romania-and the Welschness, the walnut, was the nut of the Roman lands.”

- **Statutory Immunity:** Under **18 U.S.C. § 1116(b)(2)**, a "Foreign Government" exists "*irrespective of recognition by the United States.*" As proven by the attached administrative record (**Annex A**), the United States Department of Justice (FARA Unit) and Military have already processed our status as a foreign entity. Therefore, statutory immunity applies as a matter of fact, irrespective of political recognition.

3. VESSEL STATUS (FOREIGN PUBLIC VESSEL) The vessel *Prydain* is **not** a U.S. recreational vessel. It is a **Sovereign Public Vessel** of the Empire of Avalon/Kingdom of Britons.

- **Termination of U.S. Status:** The previous U.S. Documentation (O.N. 983068) has been surrendered and cancelled for transfer to Foreign Sovereign Registry.
- **Current Registry:** The vessel is flagged under the **Imperial Registry (No. KOB-AVL-001)** and is immune from local arrest, seizure, or lien enforcement as a government ship.

4. LIABILITY NOTICE We formally note that this emergency is a direct consequence of the United States Government's failure to respond to prior notices regarding our superior claim to *de jure* sovereignty.

- **Warning:** Any attempt to seize, tow, or trespass upon this vessel while it is unseaworthy and in distress will be treated as a hostile act against a foreign sovereign and a violation of Federal Law (18 U.S.C. § 112).
- **Liability:** If you force this vessel to leave the dock while it lacks an anchor, you are personally liable for any resulting loss of life or property.

5. INTENT We demand that you log this arrival as an emergency **Port of Refuge** event. We will remain at the dock until the weather subsides and we are able to procure/recover and install a replacement anchor to restore seaworthiness.

“Notice is hereby given, that Lawrence J Jones Jr being of the Cenedl claims the hereditament rights, both corporeal and incorporeal, together with *fons honorum* to the Kingdoms of Cymru or Wales Brycheniog, Ceredigion, Deheubarth, Dogfeiling, Dunoding, Dyfed, Eryng, Glywysing, Gwent, Gwynedd, Gwynllwg, Meirionnydd, Morgannwg, Powys Wenwynwyn, Powys Fadog, Rhos, Rhufoniog, Seisyllwg; and has founded a Standing Council of Welsh Chiefs and Chieftains through the right of *jus sanguinis* in accordance with the Welsh Tribal laws, and the common law. If no other impediment exists, the hereditament rights in this case have descended to the heirs general.”

- **Administrative Characteristics:**
 - Notice was published multiple times in a periodical customarily used for legal and public notices.
 - No published rebuttal, injunction, or corrective notice has been identified.
- **Relevance:**

- Establishes a dated, public assertion of claimed hereditament rights and status placed into the public record prior to arbitral, judicial, and federal administrative actions.

II. Arbitral Proceedings – Court in Exile

Cwrt of Unbennaeth Prydain (Khumric Court)

VII. Observations

- The actions summarized above reflect a continuous administrative chain: public notice → adjudicative determination (including an ad hoc arbitral award) → judicial enforcement → federal administrative handling.
- The relevance of this record is not the intrinsic authority of any single proceeding, but the fact that multiple competent U.S. organs acted upon these instruments without subsequent correction, revocation, or disclaimer.

**INSTRUCTIONS FOR FILING A PETITION
FOR CHANGE OF NAME**

1. Where to File

The petition for change of name must be filed in the superior court of the county where the person whose name is to be changed presently lives.

2. Whose Name May Be Changed

The petition may be used to change one's own name and, under certain circumstances, the names of others (e.g., children under 18 years of age).

3. Confidentiality of Certain Names

In cases in which the petitioner is a participant in the Secretary of State's address confidentiality program (Safe at Home), petitioner's current and proposed names may be kept confidential. (Code Civ. Proc., § 1277(b).) See *Information Sheet for Name Change Proceedings Under Address Confidentiality Program (Safe at Home)* (form NC-400-INFO) for additional instructions.

4. What Forms Are Required

Prepare an original and two copies of each of the following documents:

- a. *Petition for Change of Name* (form NC-100)
- b. *Name and Information About the Person Whose Name Is to Be Changed (Attachment to Petition)* (form NC-110) (attach as many copies as necessary)
- c. *Order to Show Cause for Change of Name* (form NC-120)
- d. *Decree Changing Name* (form NC-130 or, for guardians, form NC-130G)

In addition, a guardian must prepare and attach a *Declaration of Guardian (Supplemental Attachment to Petition)* (form NC-110G) for each child whose name is to be changed.

5. Filing and Filing Fee

Prepare an original *Civil Case Cover Sheet* (form CM-010). File the original petition and *Civil Case Cover Sheet* with the clerk of the court and obtain two filed-endorsed copies of the petition. A filing fee will be charged unless you qualify for a fee waiver. (If you want to apply for a fee waiver, see *Application for Waiver of Court Fees and Costs* (form FW-001); *Information Sheet on Waiver of Court Fees and Costs* (form FW-001-INFO); and *Order on Application for Waiver of Court Fees and Costs* (form FW-003).

6. Requesting a Court Hearing Date and Obtaining the Order to Show Cause

You should request a date for the hearing on the *Order to Show Cause* at least six weeks in the future. Take the completed form to the clerk's office. The clerk will provide the hearing date and location, obtain the judicial officer's signature, file the original, and give you a copy.

7. Publishing the Order to Show Cause

In most cases, a copy of the *Order to Show Cause* must be published in a local newspaper of general circulation once a week for at least four consecutive weeks before the date of the hearing. The petitioner selects the newspaper from among those newspapers legally qualified to publish orders and notices. The newspaper used must file a Proof of Publication with the superior court before the hearing. If no newspaper of general circulation is published in the county, the court may order the *Order to Show Cause* to be posted by the clerk. But petitioners do not have to publish the order if they are seeking to change a name to conform to a change of gender identity or are participants in (1) the State Witness Program or (2) in the address confidentiality program and the petition alleges that they are (a) petitioning to avoid domestic violence, or (b) petitioning to avoid stalking, or (c) a victim of sexual assault or petitioning on behalf of one.

8. Name Change for Children

- a. If a petitioning parent is requesting the name change for a child under 18 years of age, and one of the parents, if living, does not join in consenting to the name change, the petitioning parent must have a copy of the *Order to Show Cause* or notice of the time and place of the hearing served on the nonconsenting parent. Service must be made at least 30 days prior to the hearing under Code of Civil Procedure sections 413.10, 414.10, 415.10, or 415.40.
- b. If the nonconsenting parent resides in California, the order or notice must be personally served on the nonconsenting parent. The petitioning parent cannot personally serve this document.
- c. If the nonconsenting parent resides outside California, he or she may be served by sending a copy of the order or notice by first-class mail, postage prepaid, return receipt requested.
- d. If a petition to change the name of a child has been filed by a guardian, the guardian must (1) provide notice of the hearing to any living parent of the child by personal service at least 30 days before the hearing, or (2) if either or both parents are deceased or cannot be located, serve notice of the hearing on the child's grandparents, if living, not less than 30 days before the hearing under Code of Civil Procedure sections 413.10, 414.10, 415.10, or 415.40.

If you have served a parent or grandparents, file a copy of the completed *Proof of Service of Order to Show Cause* (form NC-121) with the court before the hearing.

9. Court Hearing

If no written objection is filed at least two court days before the hearing, the court may grant the petition without a hearing. Check with the court to find out if a hearing will be held. If there is a hearing, bring copies of all documents to the hearing. If the judge grants the petition, the judge will sign the original decree.



**ACCORDINGLY, IN FULL AND FINAL SETTLEMENT OF THE DISPUTE HEREIN
BETWEEN THE PARTIES, I MAKE AND PUBLISH THIS, MY FINAL AWARD, AS
FOLLOWS:**

This sentence has international legal standing based on the New York Convention of 1958, of which one hundred and fifty six (156) nations and signatories are party, to include Japan, the United States of America, and the United Kingdom.

After meticulously analyzing the legal, Historical, Genealogical and Heraldic documents, Welsh Tribal Laws, and the evidence presented, it is decided and sentenced that for the purposes of all international laws on the rights of common law and of heraldic laws, that:

1. The hereditament rights, succession, and honorific titles in this case to the Kingdoms of: Brycheiniog, Ceredigion, Deheubarth, Dogfeiling, Dunoding, Dyfed, Eryng, Glywysing, Gwent, Gwynedd, Gwynllwg, Meirionnydd, Morgannwg, Powys Wenwynwyn, Powys Fadog, Rhos, Rhufoniog, Seisyllwg, and Cymru as a whole; have fallen solely to Mr. Lawrence J. Jones, Jr.
2. There is absolutely no native Welsh Law or International Law which may indicate an "expiration" of rights on honorific titles, or even sovereignty "*de jure*" or pretension to a vacant throne, on the contrary, the denominated "*jus sanguinis*" successions occur "while there is blood", except where there is specific legislation to restrict them. In the Welsh law even if there is an expiration of blood in the previous monarchies, any Welshman of the Nation, co-equal in dignity may claim to be heir; there would need to be an expiration of all Welsh male blood for the honorific titles and sovereignty to expire.
3. Succession in Welsh monarchies, in general, did not occur through the primogeniture although there was a bias for it, but through gavelkind, where the lands were divided equally, but the sons competed for the titles or hereditaments which could never be divided. All the heirs of the last monarchs compete for the succession when there was no competent heir, unless there was a law restricting it, which was not the case under Welsh Law. If there were no competent claimants all men co-equal in dignity could compete to be heir (though this has never happened in history before)
4. The claimant, Mr. Lawrence J. Jones, Jr. descends, through a direct and continuous masculine line, from the Welsh Kings or Warlords, and is a member of the Cenedl, or Royal Welsh Nation, and had a legitimate legally recognized right to compete for, and succeed to Kingship in accordance with ancient Welsh laws, and international laws regarding dethroned monarchies







This is in reference to the registration of Kingdom of Britons, Court in exile filed under the Foreign Agents Registration Act of 1938, as amended, 22 U.S.C. § 611 et seq. (FARA or the Act). The registration references your name (Llywelyn Pendraig, Brenin y Brythoniaid) as the foreign principal.

FARA is a disclosure statute which requires an “agent of a foreign principal,” as defined in Section 611(c), to register when the person engages within the United States in certain activities at the request of, or under the direction and control of, a foreign principal.
