FY2025 Articles -- Annual District Meeting  
April 24, 2024

- ARTICLE 1 To choose a Moderator to preside for 1-Year.
- ARTICLE 2 To see if the District will vote and authorize the Commissioners to accept and expend, for specific purposes provided, any Federal and State Grants or programs and accept any gift or donations which may be awarded to the District, or pass any vote or votes in relation thereto.
- ARTICLE 3 To see if the District will authorize the Treasurer with the approval of the Water Commissioners, to borrow money from time to time in anticipation of revenue of the Fiscal Year beginning July 1, 2024, and to issues a note of notes therefore payable within 1-year, any debt or debts incurred under this vote to be paid from revenues of said Fiscal Year.
- ARTICLE 4 To see if the District will vote to raise and appropriate the sum of \$915,000 and use from Free Cash the sum of \$20,748.54 for the District operating budget or pass any votes relative thereto.  
**[RAISE AND APPROPRIATE: \$915,000.00]**  
**[FREE CASH: \$20,168.54]**
- ARTICLE 5 To see if the District will vote to authorize the Water Commissioners to sell surplus materials owned by the District.
- ARTICLE 6 To see if the District will vote to authorize the Water Commissioners then in office to sell and permit the cutting and removal of wood and timber in the Watershed as will, in the opinion of said Commissioners, cause improvements to its use and development.
- ARTICLE 7 To see if the District will vote to take from free cash the sum of \$82,500.00 for future Water Main Updates.  
**[FREE CASH: \$82,500.00]**
- ARTICLE 8 To see if the District will vote to take from free cash the sum of \$22,500.00 for the replacement of the Raw Water Line at the Roaring Brook Filtration Plant.  
**[FREE CASH: \$22,500.00]**
- ARTICLE 9 To see if the District will vote to take from free cash the sum of \$10,000.00 for the Emergency Repair Fund  
**[FREE CASH: \$10,000.00]**
- ARTICLE 10 To see if the District will vote to authorize any insurance payments received in relation to a claim filed on the 2017 Chevrolet Silverado to be appropriated to the Truck Replacement Fund, to be used to replace existing District trucks.
- ARTICLE 11 To see if the District will elect by ballot (1) Clerk for 1-Year, (1) Water Commissioner for 3-Years, and (1) Water Commissioner for 2-Years.
- ARTICLE 12 To hear the reports of any committee and act thereon.
- ARTICLE 13 To see if the District will vote its officers any instructions.
