MENDMENT TO DECLARATION OF COVENANTS AND CONDITIONS, RULES,
REGULATIONS AND RESTRICTIONS FOR ESTATES LAKE

WHEREAS, herefore, a Declaration of Covenants and Conditions, Rules, Regulations and Restrictions for ESTATES LAKE (hereinafter referred to as the "Declaration") was executed and entered into by Lake Venice Property Owners Association, Inc. (hereinafter referred to as the "Association" or the "Declarant") on October 5, 1993, and was filed and recorded in Volume 2643, Page 1689, et seq., of the Deed Records of Fort Bend County, Texas; and

WHEREAS, the Declaration applies to that certain tract of land in Fort Bend County, Texas, being known as Estates Lake (also known as the "Small Lake") and is hereinafter referred to as the "Lake", and being more particularly described as follows, to wit:

All that parcel of land, known as ESTATES LAKE, containing 4.0 acres of land, more or less in Eldridge Lake, in the Brown and Belknap League, Abstract 15, Fort Bend County, Texas, and being more particularly described by metes and bounds on Exhibit "A" (attached to the original Declaration); and

WHEREAS, under the provisions of Paragraph 9 of the Covenants and Conditions, Rules, Regulations and Restrictions of the Declaration, the Rules and Regulations may be amended or terminated at any time by a two-thirds (2/3) majority vote of the Board of Trustees of the Association; and

WHEREAS, the Association desires to amend, in part, Paragraph 1 of the Covenants and Conditions, Rules, Regulations and Restrictions of the Declaration with regard to the use of Estates Lake; and

WHEREAS, at least two-thirds (2/3) of the Board of Trustees of the Association voted at a meeting of the Association to so amend Paragraph 1 of the Covenants, Conditions, Rules, Regulations and Restrictions of the Declaration with regard to the use of Estates Lake;

THEREFORE, Paragraph 1 of the Covenants, Conditions, Rules, Regulations and Restrictions of the Declaration is hereby amended to add the following:

"The Board of Trustees may, in its discretion, charge and levy uniformly applied fines to members and other persons who use the Lake and are not Members in Good Standing of the Association. The amount and frequency of the fine will be established from time to time and at any time by resolution of the Board of Trustees of the Association."
