Tarn Springob asked him to get price for this work and for the grass and landscaping afterwards, and then tabled this discussion to the next meeting. Tarn Springob asked if it should be a requirement for bulkheading on a property located in VE but backing up to Alkire Lake? A discussion followed, and Ralph Twiss will investigate the matter and report back to the board at the next meeting.

Tarn Springob said the city now has two documents in their hands that transfer ownership and ties up the City for all maintenance going forward. We are now waiting for a response. Tarn Springob said that currently the pump still belongs to VE, we will continue to operate it and that the committee has found a company to perform any necessary future maintenance. Leticia Gomez of MASC Austin Properties, Inc. said she called about the latest bill for the water meter because it seemed high and asked that it be rechecked, which the city did and they said it was the same. Bob Vacek asked her to give him copies of the statements dating back to last October for review.
