Call Meeting to Order:

Call Business Meeting to Order:

Actions between Meetings:

The City of Sugar Land did some research on the previous agreement between VE and the City on the street drainage work completed years ago at the bulkhead and street at Eldridge Lake and Lombardy. Consistent with our previous agreement, the City will fix the spillway between the 2 homes (a \$225.00 expense) within the next month. Don Wilson reported that he received a bid back from Steve Orsak and the bulkhead portion that remains the responsibility of VEPOA will costs \$3,640,00. A motion was made via email to have Orsak proceed with those repairs. - b. Grounds Steve Trailie said he had spent some time with Jeff Johnston to learn as much as he could about taking care of the grounds. Pat Uselton said he would help him with the grounds. Steve Trailie agreed to chair the grounds committee.
- c. Lake Quality Bob Buck said he had dyed the lake recently, and is working on a tentative date for the Fishing Tournament. He said he is also working with a second source for the fish survey.
- d. Neighborhood Caring No report.
- e. Public Relations Alice Tannahill said she had met with Kristen Johnson who is willing to do the neighborhood directory, A discussion ensued regarding the use of cell phones rather than landlines since so many people do not use a landline anymore. Ralph Twiss suggested putting the directory on the website, and Curtis Burgeron said it could have a password to help protect the information. Ed Beckham made the motion to nominate Pat Krajca as Treasurer, Andy Engleman seconded the motion, and the motion passed.
