Each year, our community shines with many homes adorned with lights and decorations. And this year seems particularly good to get into the holiday spirit! During the week of December 12, homes will be judged for the top three most festive decorations - two front yards (entire community) and one back yard (Lake Venice) homeowner. # Lake Study

The newest activity taking place in our lake is the upcoming bathymetry lake study. This study will use GPS and hydro-acoustic depth sounding equipment to map the lake. The result of this study is that we will have a detailed 3D image of the lake showing water and sediment depths throughout. Additional testing of the water and sediment will be performed for remediation purposes. Following the study, a long-term dredging plan will be developed to remove an appropriate amount of sediment. Since our lake is over 60 years old and serves as the storm drain for the neighborhood and streets, the dredging process is long overdue if we want to maintain an acceptable lake quality. This removal will enhance the water quality as well as the longevity of the lake. Please continue to remind your lawn personnel to minimize grass, leaves and limb disposal from entering the lake. We get plenty of debris just from the Fall leaves.

#### HOUSE WATCH PROGRAM

Police Department

Contact the Sugar Land Police Department to set up a "House Watch". The House Watch Program is designed to provide homeowners a means of having their residence checked periodically by an officer or trained civilian volunteer when they are away from home on vacation or an extended weekend. In order to participate in the program, you can come by the Police Department or complete the on-line form at: http://www.sugarlandtx.gov/police/services/programs/house\_watch.asp. The homeowner must be away from his/her residence for more than three (3) days and must not have anyone staying at the home while he/she is away. Homes can be placed on house watch for a maximum of three (3) weeks.

### **2022 Annual Assessments**

The 2022 annual assessments invoice will be sent out soon. Annual assessments are due on January 1, 2022. They are considered late after January 31, 2022 with all past due accounts assessed a late fee of \$10.00 along with a monthly collection fee of \$15.00 until paid in full.

Your assessments are what allow your Board of Directors to maintain your community. The assessments cover all operational costs of the Association.

PAST DUE BALANCES: If owners are experiencing difficulties related to the pandemic, a request can be submitted for payment deferment and/or extended payment plans to the Board for review. Please contact Pennie Mancuso in our accounting department at MASC Austin Properties, Inc. via phone at (713) 776-1771 or via email pmancuso@mascapi.com to make the necessary payment arrangements if you have a past due balance.

# **Before Starting An Improvement**

If you are making any type of improvement to the exterior of your home, you must submit an Architectural Improvement



request form to MASC Austin Properties, Inc. before starting the work. (This includes painting the exterior, room additions, and replacement of the roof, driveway and fence, etc.) Replacement of plant material due to freeze damage does not require an ACC form unless the entire lawn landscape hardscape needs replacement.

You can find the required form on our website at www.venetianestates.org under DOCUMENTS- Request for Home Improvement Approval. Please make sure to submit the form with the necessary information and as much detail as possible along with samples for a quicker response.

# Generator Rebate Pilot Program

Sugar Land City Council recently approved an ordinance establishing a generator rebate pilot program -- a move intended to promote preparedness, resiliency and residential reinvestment. Qualifying homeowners must apply for the rebate by Nov. 30, which will be issued after completion and approval of all required city building inspections. The rebate covers permit and plan check fees associated with the installation of permanent standby generators. The rebate offer will be available to homeowners who have received approval of all required city permits for the installation of a permanent standby generator, completed installation and received approval of all required city inspections between Feb. 15 and Nov. 30 of this year.
