## Board Meeting Highlights

### January Board & Annual Residents Meeting:

Acting board members, ,were re-elected for another two year term. After serving for two terms as Secretary, Craig Kamman resigned from the board. Tim Bally and Rick Pfeiffer were both elected to the board as Members at Large.

The board recognized and thanked Alan Brown and Craig Kamman for their years of service to the board. Alan has been the newsletter editor for 15 years and is the longest serving board member, he has decided to pass the newsletter torch on. Alan will remain on the board and continue to serve on the landscape committee

Covenant revision - voting rights, Jeanie has proposed that QC be aligned with state law on this matter, which would give each household one vote on QC issues put to resident vote.

APD Liaison for QC, Officer Robert Aguilar, talked about the low rate of crime in Andover and what we can do as homeowners to keep our property safe. Also discussed was this coming year's National Night Out which will be Aug. 1, Officer Aguilar indicated he would be more than glad to come out if QC chooses to participate.

Some residents and board members voiced their concerns over QC spending money on "Dunk Your Junk" when a raise in dues was just approved to cover future expenses. It was mentioned that people from outside QC are using this, and that all the residents are paying for something that not every resident uses. The board will discuss in more detail at the next meeting.

**February Board Meeting:** Gary David with Jayhawk Landscape discussed plans for the common areas in the upcoming year. Points of concern are the erosion around the edges of the lake and the exposure of irrigation system piping.

The new change to the covenant concerning voting rights will be put to a vote by the residents of QC, ballots will be mailed.

Michael Cunningham will take over as Newsletter Editor and Welcome Committee Chair. Peter Heller has volunteered to also serve on the Welcome Committee. Daniel suggested that the Welcome Committee have some sort of a gift with the QC logo on it to hand out with the packet. The Landscape & Design Committee will remain the same with Chris Robrahn as Chair, with help from Alan Brown, Mike Wilcox, and Michael Cunningham. Joining the Landscape Committee is Tim Bally. The Finance Committee will remain the same with Chris Robrahn as Chair, with help from Jeanie Shackelford, Daniel Lee and Michael Cunningham.

Also discussed was "Dunk Your Junk", an alternative was suggested, but it still means all QC residents are paying for a few to get rid of their junk. No definite plan was decided upon. Amber will research and get some bids for an alternative solution for trash pick up vs. dumpsters.

**March Board Meeting:** The board weighed the pros and cons of 'Dunk Your junk' and after a lengthy discussion voted to postpone the event for 2017 in order to conserve funds for other much needed projects. Chris described some needed repairs for landscape and other upcoming expenses.

With the nice weather approaching Amber will begin looking at yard compliance and the Landscape Committee may also do a ride along with her to look at compliance issues.

The board also reviewed a draft for new bylaws for our HOA as we currently do not have any in place and will finish the review at the next meeting.

Alan Brown reported that he has made numerous repairs to the cracks in the 21st street wall, he will be asking home owners that back up to the wall for access to their backyards so that he may repair both sides of the wall.

**April Board Meeting:** QC Liaison Officer Aguilar reported a pit bull in Quail Crossing and encouraged residents to notify him or the APD as pit bulls are not permitted in the city of Andover. National Neighborhood Night Out is Tuesday, August 1 from 6pm to 8:30pm. The police can offer blockades and a mascot visit. Some neighborhoods do party themes. More details in this newsletter and police need to be notified by July.

The Board reviewed the second half of draft bylaws and Jeanie collected recommended changes. The Board will review the edited version of all by-laws at the next meeting for final approval. The Board approved by-laws and voting covenant change will be sent to residents to vote for final approval.

Board members responded to a few inquiries about not holding Dunk Your Junk this year. Notices of the Andover community trash collection event were posted on mail boxes and the City event was very slick and well managed.

The Welcoming Committee has met with four new residents over the past month. Residents seemed appreciative of the welcome and the information packets.

Alan Brown will soon resume repairs to the 21st street wall, letters were sent to the residents along this wall to allow Alan access to the wall via their backyards. He will also be staining the playground equipment as soon as weather permits.

**May Board Meeting:** The board finalized the new bylaws and covenant changes which will be voted on by the residents at the September meeting. Other items discussed: How much better our community is looking lately, so much pride being taken in homes/yards. Better inspections of backyards that border the lake. Alan continues to make repairs to the 21st street wall and playground equipment. This year's Family Fun Day will be held in cooler weather, 9/16/2017, more info to come in the Summer Newsletter.

QCHOA will start using a standardized form for Landscape & Design changes provided by HOA Mgt. The new form will be linked to the QC website and submitted to HOA Mgt. when completed, then sent to the Landscape & Design Committee for final approval.

Sooner or later, the weather will shift and we will face another period of very hot and dry summer heat and some of those awesome landscape plantings, might wilt away!

So think about the big picture first. What are you willing to put into your landscaping? Doing less can make sense if you aren't willing (or can't) invest into your property. The worst thing in the world is to see a home where someone put too much into their landscaping, then can't (or won't) keep it up. During our last compliance review, we noted a couple of homes in Quail Crossing that could be dynamite, but the effort to maintain has not "been a part of the mix".

Once you decide, go shopping! You can get landscaping items on sale and it can be affordable if you do the work yourself at a time that is pleasant. Don't wait until July to start... landscaping can be a fun outdoors project, done in April-May or September-October.

Yard maintenance is another matter. 3 trees (2 inches in diameter 1 foot up from the base) in your front yard is a covenant requirement as is "8 shrubs on the property". Mowing and keeping your lawn in compliance is a part of why people move here... to keep your property values up and to make our neighborhood the best it can be!

# NuStar Pipeline Remediation Update

To assess the reliability of NuStar's well testing, the HOA engaged its environmental consultant to conduct tests and compare to NuStar reports. On September 22, 2016, the consultant observed NuStar's testing methods and collected samples from six yard irrigation wells. He lowered water collection bailers deeper than NuStar testing, to reach further within each well's screen interval. The HOA samples were analyzed by Pace Analytical Services LLC, Lenexa, Kansas. The consultant compared the HOA test results with NuStar's test results, once posted on the KDHE website in February 2017.

The consultant concluded that NuStar's testing of inactive irrigation wells is not likely to be representative of groundwater contamination conditions. HOA testing revealed Benzene in two of the sampled wells in September 2016, yet most of NuStar's quarterly reports had not shown contamination in the two wells, with the last reported detection in February 2015. The HOA has requested NuStar adjust its testing methods, as described in the consultant report, to more accurately represent groundwater contamination levels. The HOA requested KDHE ensure NuStar employs the more reliable testing methods, to observe NuStar's testing, and to share its observations with the HOA. A KDHE representative was present during the most recent quarterly testing in March 2017. The representative indicated well testing was modified to lower collection bailers within well screen intervals and options were being reviewed to address the HOA's other recommendations for improving testing reliability. The KDHE representative indicated the March test results would be considered in determining if the modified testing would be employed again in future testing.

# Crime Watch - Home Security Lighting

You've come home late at night and realized your street is quiet and actually quite dark. The more you travel down the road you realize home addresses cannot be seen and its hard to see where driveways start and where they end. At times you cannot identify vehicles. If you are observing this then be assured criminals see this and see it as "an easy target". Homes and streets that are well lit are less likely to fall victim to burglaries and vehicle break-ins. This segment will cover a small part with making your home a "hard target" by increasing lighting.

Studies show that improving something as simple as lighting reduces your chances of becoming victim to burglaries and vehicle break-ins as much as 20%-25%. Why is this?

Criminals perceive a well lit area as high risk for detection of their actions. Simply, they feel that if they can see, then you can see them. Also having a well lit home and neighborhood imply the community cares and cohesively work together to improve the community and deter crime.

Whats the cost? Improving lighting is the most cost effective way to deter property crime. As a community member you are only spending the cost of increased wattage bulbs. It is also recommended to install motion detection lights as they give the impression that there is constant monitoring of the property and startle trespassers and those looking to commit property crimes. The average cost of 10W LED bulbs (equivalent to 60W incandescent) is about \$4 dollars a bulb. LED bulbs are more energy efficient only costing \$1 a year to operate 12W as opposed to \$1.17 per 14watts a year of incandescent lighting. Lastly LED bulbs provide 25,000hrs of use as opposed to incandescent life averaging 1,200hrs. What does this mean? You will only purchase bulbs about every 5 years!

Help deter crime and improve the community by simply leaving lights on and improving lighting in your area.

## Michael Cunningham

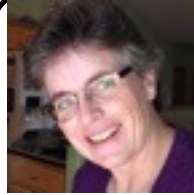

Presently on the Board of Directors for Quail Crossing Home Owners Association since 2013 now serving the fourth year as treasure.

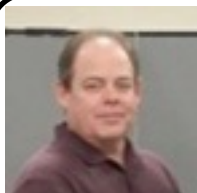




**Alan Brown**

I am a professor of Biology and Biotechnology at Butler Community College. My family and I have lived in Quail Crossing for 16 years.



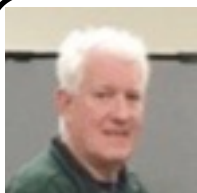
**Mike Wilcox**

### **Why You Should Not Scalp Your Lawn**

Many people believe that scalping their lawn is the way to go. After all, if it's mowed super low it doesn't have to be mowed as often. What's the harm? Well it is perhaps the worst thing you can do to your grass.

One problem is that grass blades photosynthesize to provide food to the roots. By chopping off the majority of this blade, you reduce the amount of energy the roots receive, and this makes for a weak lawn that is more susceptible to stress, insects and disease. Another problem with scalping is it encourages weed growth. Without the dense grass blades to block light, weed seeds are allowed to germinate and grow. In a scalped lawn, weeds can quickly dominate.

The recommended height setting on your mower is one of the two highest settings possible and to mow often enough so the clippings are chopped into a fine mulch and not big piles of grass in your yard.

Look at the lush green yards next time you are out for a walk and take note of their grass height.



## HELP KEEP OUR LAKE BEAUTIFUL

Well, it's that time of year when more and more of us start taking advantage of our neighborhood's greatest asset, our lake. Not only for the residents who live on the lake but also those that use it. Living on the lake, I truly enjoy watching the families out in the evenings after dinner, fishing, walking, walking dogs or just sitting on a bench and watching the ducks.

So, since the lake means a lot to each of the residents in their own way, here are just a few things to keep in mind when you are out there.

If you are walking your dog, please have them on a leash and pick up their deposits.

Please remember to take your trash home with you when you leave.

There is absolutely no swimming or boats permitted in the lake, the only boats allowed are of the remote control type.

If you are fishing, there are a few things to remember. All fishing is catch and release. This means take a picture of your catch, then put the little guy back in the water, not on a stringer or in a cooler. Netting of fish is not permitted. If you take line off of your reel, be sure to pick it up. Not only does it get caught up in the lawn maintenance equipment, but our lake wildlife can become entangled in it and possible choke/drown. If you cut off a hook or lure, take the old one with you so that no person or animal gets a hook in their foot (I see lots of barefoot kids out there in the summer).

Lastly, be courteous of family homes on the lake without fences, their yards are not common areas and should not be used as such.

Thank you, and let's have a fun and safe summer at the lake.
