At this time BDTA does not require fully vaccinated individuals to wear masks. However, this may change as BDTA will follow CDC, PA and county guidelines in effect at the time of the trial.

Exhibitors are responsible for picking up after their dog(s).

Designated potty areas will be provided.

Please park in designated parking areas

Do not arrive earlier than one (1) hour ahead of your judging time. We ask that you leave the show grounds once your classes are completed.

BDTA will not be responsible for any lost or damaged items left at the show site.

#### **Obedience Trial Fees**

Classes with Jumps will be judged in Jump Height order, beginning with the lowest jump height then in ascending order. Handlers with multiple entries in the same jump height will be accommodated.

Entries will be accepted for Dogs listed with AKC Canine Partners and may participate provided their AKC Canine Partners listing number has been recorded on the entry form.

Two-day Combination Obedience/Rally Catalogs may be pre-ordered for \$5.00 each.

Closing date for entries is 11:30 PM Wed., April 13, 2022, unless limits are reached before that time, after which entries cannot be accepted, canceled or substituted, except as provided for in Chapter 11, Section 6 of the Dog show rules.

#### Telegraph, Telephone and Unsigned entries Cannot be Accepted.

Entries not on official AKC Entry forms or photocopies of entry forms without agreement and rules on the reverse side of the official AKC entry form are NOT ACCEPTABLE.

Entries without fees will not be accepted. Acknowledgement of entries by written conformation letter will be made as soon as possible after Trial closes. Should acknowledge not be received by the exhibitor within a reasonable time, please notify the Obedience/Rally Trial Secretary, Linda Arnold, 102 Coverdale Road, Butler, PA 16001 [lindy53@zoominternet.net] If a legible email address is provided, email confirmation of receipt of entry will be made as soon as possible as entries are received and processed.

**Post Dated Checks and Returned Checks** do not constitute a valid entry fee. The Obedience/Rally Trial Secretary will add a collection fee of \$25.00 to the amount of each returned check.

**No Refund For Duplicate Entries.** Every effort will be made to find duplicate entries; however, if the entry has been processed, no refund will be made.

**Declination of Entries. No Entry** shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Butler Dog Training Association may decline any entries and may remove any dog on account of disease, viciousness, or other cause, and no one shall have any claim against BDTA or any official thereof.

Entry Fees Shall Not Be Refunded in the event a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the show committee. If because of severe weather, riots, civil disturbances, weather or other acts beyond the control of the BDTA or the Trial Officials it is impossible to open or complete the show, no refund of entries will be made. The well being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop a trial before completion, no refund of entry fees will be made.

**Errors On Entry Blanks**. Owners are responsible for errors in the filing out of entry forms. No entry and no entry fee will be refunded in the event of such errors, or for cancellation of entries after the published closing date. Please type or print carefully on entry forms to eliminate errors.

**Transfers/Move-up Policy.** Obedience and Rally Transfers to another class will be accepted as space permits within entry limits, in accordance with Chapter 1, Section 16 of the Obedience Regulations. Requests for transfers must be made in writing and presented to trial secretary at least **30 minutes before the start of each Trial.** Forms may be downloaded from the AKC website at www.akc.org or requested from the Trial Secretary.

**Bitches in Season** will not be admitted to the Trial. Any exhibitor with an entered bitch in season on the Trial date will be refunded the entry fee **less \$5.00** upon written certification by a veterinarian given to the Trial Secretary **before the start of judging each trial.** 

Exhibitors are Responsible for the Behavior of Their Dogs and/or Children. All dogs present must be held on leash or confined to their crates except when being judged or when in the exercising area. Exhibitors are responsible for cleaning up after their dogs. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such case, no refund of any entry fees will be made.

**Judges will not wait for any dog holding up a class.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. Do not arrive earlier than one (1) hour ahead of your judging time. Dogs not required for further judging will be excused.

\*Due to space limitations, please plan to crate in your car.

At this time, exhibitors may enter the building to watch their class(s). However, this may change as BDTA will follow CDC, PA and county guidelines in effect at the time of the trial.

Un-entered dogs will not be admitted to the trial.

**Exhibitors** should follow their veterinarians' recommendation to assure their dogs are free of external parasites, any communicable diseases and have appropriate vaccinations.

#### Butler Dog Training Association COVID-19 Policy for Obedience/Rally Trials

By entering our Trials, you are agreeing to follow the current COVID Protocols set by BDTA in accordance with the state of PA, local and CDC Guidelines and Mandates, or if the AKC makes changes. In the event these trials are cancelled due to COVID-19 safety or government restrictions, checks will be shredded or full refund will be made.

EVENT ATTENDEES VOLUNTARILY ASSUME ALL RISKS RELATED TO EXPOSURE TO COMMUNICABLE DISEASES.

PLEASE STAY HOME...If you are sick, have a temperature, you do not feel well (fever, cough, sneezing, loss of taste/smell, problems breathing/catching your breath) or if you have recently been exposed to someone with COVID-19 within 14 days prior to our shows or have tested positive for COVID-19, You may also want to stay home if you are at high risk, cannot wear a mask, if you may not feel safe/comfortable, feel scared or feel we should not have these shows. If your absence is related to COVID-19, your entry fees will be refunded.

Consistent with the latest CDC and State guidance/recent updates, those fully vaccinated are no longer required to wear masks but those unvaccinated are urged to continue to wear masks. We agree with this guidance and urge all those unvaccinated to continue to wear masks or face coverings that cover your nose, mouth and chin.

Please keep in mind some judges may require facemasks to be worn in the ring so be prepared to comply with such a request. Also, some individuals may not be able to receive a vaccination or may simply choose not to get one. BDTA will not ask for proof of vaccination but urge unvaccinated and at-risk participants to wear masks for their own safety.

Although we will have a limited supply of masks, hand sanitizer, wipes and gloves on hand; we ask that everyone please bring their own supply.

All crating will be outside the building. Be prepared to crate in your cars.

- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
