Dave Wygal is a Training Instructor with the National White Collar Crime Center (NW3C). He currently instructs and/or facilitates the Financial Investigations Practical Skills (FIPS), Financial Records Investigative Skills (FRIS), Intellectual Property Rights (IP), Intelligence Writing and Briefing (IWAB), and

Financial Records Examination and Analysis (FREA) classes. Prior to his career with NW3C, Wygal spent the majority of his 21 years in law enforcement with the City of Clarksburg Police Department in West Virginia before retiring in 2012. While in Clarksburg, Wygal was assigned to the Detective Bureau as a major case detective with an emphasis on sexual and financial-based crimes.

Wygal's background includes training in Advanced Crime Scene Investigations, Advanced Death and Homicide Investigations, Forensic Entomology Evidence, Traffic Accident Reconstruction and certification in forensic interviewing techniques. In addition to his own training, Wygal has trained new detectives on all aspects of investigative work.

Among his accomplishments, Wygal received the Chief's Award, seven Sherlock Holmes Awards and was named Officer of the Year. Wygal has worked with several federal, state and local task forces including the FBI Homeland Security Task Force, FBI Crimes Against Children, U.S. Marshal Fugitive Task Force and WV Internet Crimes Against Children Investigative Team. He continues to serve on the Board of Directors for the Harrison County Child Advocacy Center.



Norman Gibson High Tech Crime Specialist NW3C, Fairmont, WV



In November of 2009 Norman Gibson joined the staff of the NW3C bringing with him over 8 years of law enforcement experience and two years of civil litigation computer forensic investigative experience.

In 1998 Norm started his law enforcement career as a deputy sheriff for the Wayne County Sheriff's Department in Detroit, Michigan. Assignments included Corrections, the Internet Crime Unit, and the Deed Fraud Unit. In addition to those specific assignments he assisted the Narcotics unit, Morality unit, and Auto Theft Task force with undercover

work, surveillance, evidence collection, and interviews. In 1999 Norm was assigned to the Internet Crime Unit where he investigated crimes against children, identity theft, fraud, internal investigations and was also trained to perform forensic analysis on seized computers. In addition, he educated the public through Internet Safety presentations provided in schools, at parent teacher organization meetings, and for attorneys and sheriffs for Cooley Law School and the National Sheriff's Association. In 2005 Norm was assigned to the newly created Deed Fraud Unit that was formed in conjunction with the Sheriff's Department and the Register of Deeds office.

In 2006 Norm left to begin work in the civil arena. He performed forensic analysis on computers related to civil litigation involving a variety of cases including but not limited to theft of proprietary data/intellectual property, arson and divorce. In 2009 he joined the West Virginia High Technology Foundation as a Forensic Project Manager to test and validate forensic tools, and later that year joined the NW3C as a Computer Crimes Specialist.

Currently he teaches almost the entire NW3C curriculum and has delivered training throughout the country in classes and conferences, as well as participated in the development of multiple NW3C courses. In addition to teaching, Norm has developed and assisted in the development of various whitepapers published by NW3C. He also provides technical assistance to law enforcement including but not limited to forensic examinations in the West Virginia office.

Norm has attended over 700 hours of computer investigative courses. In 2007 he attended the International Association of Computer Investigative Specialist (IACIS) Basic training and became Certified Forensic Computer Examiner (CFCE). He also has completed the AccessData Certified Examiner (ACE) and Encase Certified Examiner (EnCE) certifications. He graduated in 1996 from Western Michigan University with a Criminal Justice degree.
