Boarding Agreement

This is a contract between Greenridge Kennels, LLC (hereinafter called "Kennel") and the pet owner whose signature appears below (hereinafter called "Owner") for services related to

(hereinafter called "Pet").

(Pet's Name)

Payment (cash or check only) is required for services at the time of checkout. Owner agrees to pay the rate of \$15.00 USD per night Pet is boarded at Kennel. Pets picked up after 7:00am will be charged the full boarding rate for that day (unless previously negotiated between Owner and Kennel). Owner agrees to pay all costs and charges for special services requested, plus all veterinary expenses deemed appropriate by Kennel for Pet during time it is in the Kennel's care. Kennel shall attempt to contact Owner prior to incurring such veterinary services as may be required by Pet's health and/or behavior. Owner agrees that Pet shall not be released by Kennel until all charges are paid to Kennel by Owner.

Owner agrees to provide adequate quantity of food for Pet based on boarding term. If Owner does not provide food for the entire boarding term, Kennel will charge Owner \$2.00 USD per meal based upon Pet's dietary needs.

Due to the social nature of our Kennel, there are some inherent risks. These risks may include, but are not limited to: transfer of communicable diseases such as Canine Papilloma Virus (puppy warts), Canine Cough and Feline Upper Respiratory Infection. Injuries may include, but are not limited to: broken nails, sore feet, puncture wounds, abrasions, and cuts. These injuries are generally benign and can usually be managed by Kennel staff. In some cases, veterinary care may be required. Owner agrees that Kennel is not responsible for any injuries, illnesses, or other issues (ticks, fleas, etc.) that develop while Pet is in care of Kennel.

Kennel shall exercise reasonable care for Pet delivered by Owner to Kennel for boarding. It is expressly agreed by Owner and Kennel that Kennel's liability shall in no event exceed fair market value for the Pet boarded. The Owner further agrees to be solely responsible for any and all acts or behavior of said Pet while it is in the care of the Kennel. Owner agrees to be financially responsible for Kennel property damaged by the Pet. Reasonable costs for damage will be payable upon checkout of Pet.

Owner specifically represents to Kennel that Pet has not been exposed to Rabies or Distemper within a thirtyday period prior to boarding. Kennel requires proof and copies of current Rabies, Distemper, and Bordetella vaccinations for Pet prior to boarding dates. We require a Bordetella vaccination every six (6) months. The Bordetella vaccine is not 100% affective so it is recommended that it be given to your dog at least two (2) weeks prior to Pet's boarding date to increase efficacy. Kennel makes no guarantees in regards to the Bordetella vaccine. All pets are checked for external parasites (fleas/ticks) upon entry to facility. If any external parasites are present, the dog must be treated at the Owner's expense prior to boarding at Kennel. Kennel highly recommends Pets be treated monthly for external parasites as well as internal parasites (heartworms, tapeworms, hookworms, whipworms, etc.)

Boarding Agreement

If Pet becomes ill or if Pet's behavior is endangering itself, humans, or other animals, Kennel, at its sole discretion, may engage the services of a veterinarian. All attempts will be made to contact the Owner of the Pet first; however, in the event of an extreme emergency, the well being of the Pet takes precedence. Medication will be administered as necessary under the direction of a veterinarian. The undersigned Owner hereby gives the veterinarian complete authority to treat Pet in whatever manner deemed necessary. Owner will be responsible for all veterinary charges upon release of Pet. Owner also gives full authority for treating veterinarian and their associates to discuss with Kennel any aspect of any illness or injury that the Kennel has presented for treatment.

Any Pet left at Kennel for more than 10 days (without communication from Owner) will be deemed abandoned and turned over to the proper authorities. Owner will have full responsibility for any charges or fees incurred.

Storm Disclaimer: In the case of severe weather conditions, Kennel cannot guarantee safety of Pet. Kennel agrees to make every effort possible, without endangering human life, to care for Pets entrusted to us. Owner agrees not to hold Kennel responsible for injury or loss of pet due to above mentioned conditions.

Owner authorizes Kennel to use pictures of their Pet taken while participating in Kennel activities on its website and in other promotional materials.

By signing this agreement and leaving Pet in care of Kennel, Owner certifies to the accuracy of all information given about Pet to the best of their knowledge. Owner specifically represents that he or she is the sole owner of the Pet.

By signing this agreement, Owner indicates that he or she has read and accepted all policies listed in the agreement and on our website. All provisions in this contract shall be binding upon both parties thereunto for this visit/service and for all subsequent visits/services.

This contract contains the entire agreement between the parties.
