JAN REE SWIM CLUB RULES

> The following are state laws:

- o No one may swim alone.
- Everyone must shower before entering the pool.
- Everyone must sign in and out with Lifeguard. This includes guests.
- The water safety line must be in place unless lap swimming is taking place.

➤ The following are Jan-Ree Swim Club Rules:

- No one is allowed in the lifeguard or pump rooms.
- No smoking permitted ANYWHERE on the pool property & please respect our neighbors.
- o No alcohol or other intoxicants are allowed on pool premises.
- o No food or drinks are permitted on the pool deck.
- o Music must be played at a low, comfortable level, respecting our members & neighbors.
- No running, pushing, wrestling, ball playing, or undue disturbances in or around the pool area.
- Admission will be denied to anyone with open sores, colds, coughs, inflamed eyes, infections, or bandages.
- o No abusive or foul language is permitted.
- Only one person at a time is allowed on the diving board.
- No Diving allowed except from the diving board.
- o No hanging or sitting on the deep-water line allowed.
- Members may bring their own chairs, chaises, and umbrellas.
- O All persons using the club grounds shall do so in a quiet, respectful manner.
- o Small children (3 and under and/or not potty trained) must be in a swim diaper.
- When hosting a pool party, the member must be present until all party guests exit the property.
- o If members bring guests to the pool, the member must be present while guest(s) is on the property.
- o No person under the influence of alcohol or drugs may use the pool.

Child/Teen Swimming Guidelines

Age 0-9 and under must be supervised by someone 14 or older.

Age 10-13 must take and pass a swim test if they want to be left unsupervised at the pool. The test will be to swim two lengths of the pool and tread water for 1 minute.

If there are any incidents of children/teens who are breaking rules and being disrespectful without an adult at the pool, they will be warned and possibly lose their privileges to be at the pool without an adult. It will be reviewed on a case-by-case basis.

Waiver, Release of Liability and Hold Harmless Agreement

In return for participation in Jan Ree Swim Club, I, a member –

- 1) Acknowledge that I understand the nature of the swim club and believe that I/we are in proper physical condition to participate. I further agree that if at any time, I, or another participant within my membership, believes conditions to be unsafe with respect to member's physical condition, the equipment, or facilities, it shall be the member's responsibility to and I/member will discontinue participation in the swim program.
- 2) Further acknowledge that the swim program involves the risk of serious bodily injury (including the possibility of permanent disability, paralysis or death), which may be caused by a) member's own actions or inactions, b) the actions or inactions of others participating in the swim program, c) the actions or inactions of the entities and persons identified below; and I fully accept and assume all such risk and all responsibility for losses, costs, and damages member may incur as a result of Member's participation in the swim program.
- 3) Acknowledging that as a Jan Ree Swim Club sponsored program, all applicable regulations, policies, procedures, and consequences as defined in the Bi-Laws and Pool Rules will apply during the Member's participation in the swim program.
- 4) Accordingly, I hereby release Jan Ree Swim Club, together with its directors, officers, employees, volunteers, and agents from all liability, claims, demands, losses, and damages arising out of Member's participation in the swim program; and I further agree that if, despite the release and waiver of liability agreement I, the Member, or anyone on behalf of Member or myself, make a claim released in this agreement, I will indemnify and hold harmless each entity and person released herein from any and all litigation expenses, attorney fees, loss, liability, damage, or cost that may incur as a result of such claim.
- 5) Agree that in an emergency, any Jan Ree Swim Club representative may transport or authorize the transportation of my member to a hospital/medical facility and I authorize any physician or other medical personnel to carry out any diagnostic procedures or emergency care deemed necessary. I understand the cost of medical attention and ambulance are my responsibility.
- 6) Acknowledge that information about my membership provided in this registration may be used by a Jan Ree Swim Club representative or any individual or organization identified by Jan Ree Swim Club as needed in order to effectively execute this swim program.
- 7) Acknowledge that from time to time, a Jan Ree Swim Club representative may photograph or videotape members while he/she is involved in a swim program activity. These photographs or videos will solely be used by Jan Ree Swim Club for the promotion and marketing of its Swim Club and activities and will not be sold. I understand that it is my responsibility to notify Jan Ree Swim Club in writing if I do not wish to have my member(s) photographed or videoed.
