Note: If tuition is greater than the amount awarded by your student's scholarship, then the parent/guardian is obligated to participate in a monthly payment plan for the difference- to be paid in full by July 30, 2027. If your student does not receive a scholarship, then the parent/guardian may also participate in a monthly payment plan that will cover full tuition fee and additional costs from beginning date of registration to the end of the 2026-2027 school year calendar- to be paid in full by July 30, 2027. Those that meet financial need may be eligible for in-house tuition assistance.
