

# DELAWARE STATE UNIVERSITY ALUMNI ASSOCIATION **DSUAA National Convention – Host Criteria**

DSUAA invites each eligible Local Chapter and/or Affinity Group to confirm their interest in serving as a potential host of an upcoming National DSUAA Annual Convention.

## **Eligibility:**

- The DSUAA Local Chapter/Affinity Group must be in good standing as defined by the National DSUAA Bylaws.
- The DSUAA Local Chapter/Affinity Group must confirm their interest in serving as host for the National Convention by submitting a completed Interest Form to National DSUAA.

#### **Selection:**

- The Host shall be selected randomly from the eligible Local Chapters/Affinity Groups who submit a completed interest form.
- The selection shall occur once every two years at the National Convention.
- Three Local Chapters/Affinity Groups shall be selected from the eligible Local Chapters/Affinity Groups to host the next three conventions.

### Criteria:

- The host Local Chapter/Affinity Group shall select a location for the National Convention which is convenient to transport to and has housing available nearby.
- The host Local Chapter/Affinity Group shall provide at least one activity, in addition to the convention, for potential participation by attendees.
- The host Local Chapter/Affinity Group shall coordinate with National DSUAA on the details of the Annual Meeting.
- National DSUAA shall cover the costs of the Annual Meeting (food/venue/etc.). National DSUAA shall provide a minimum of \$5,000 to support the budget for the annual meeting. Proceeds from the Annual meeting will be considered revenue for National DSUAA.
- The Local Chapter/Affinity Group shall be responsible for other event/activity costs separate from the Annual Meeting. Proceeds from the events/activities separate from the National Convention will be considered revenue for the Local Chapter/Affinity Group.
- The selected Local Chapter/Affinity Group may choose to partner with other Local Chapters/Affinity Groups when hosting convention activities.
- A chapter selected during the previous selection cycle, may run again during the next selection cycle.
- If there are no chapters interested in being considered host, national DSUAA will serve as convention host.
