

# RIVER BEND PROPERTY OWNERS ASSOCIATION, INC.

The Bylaws committee presented the Board of Directors with proposed changes to the Articles of Incorporation, Bylaws and Declaration of Restrictions governing documents. These have been reviewed by legal counsel as well.

The proposed revisions are comprehensive and aimed at enhancing clarity, ensuring consistency in terminology across documents, updated for modern relevance, improving governance structures, and strengthening accountability.

Only Members in Good Standing are eligible to vote whose name is listed on the legal instrument provided to the RBPOA office. If a Membership is held by two (2) or more co-owners, the vote will be cast as the co-owners decide among themselves.

Your vote is important, please follow the instructions carefully to ensure your ballots are valid. There are three (3) forms to be completed and returned:

2025 RBPOA Articles Voting Form  
2025 RBPOA Bylaws Voting Form  
2025 RBPOA Declarations Voting Form

Before returning your completed forms, please verify that you have:

1. Printed your Name clearly.
2. Entered your Block and Lot numbers.
3. Signed and dated the form.
4. Selected either 'YES' or 'NO' for each item on the ballot.

For enhanced clarity, when *"This article has been broken into bullets."* is listed in the Proposed Change column, the original article is shown as a whole, then each color coded line is aligned with the proposed change.

The governing document ballots, along with the current governing documents, can be found by going to <https://riverbendparkhardyar.com/>, scrolling down to Documents, then can be saved and/or printed for completion. 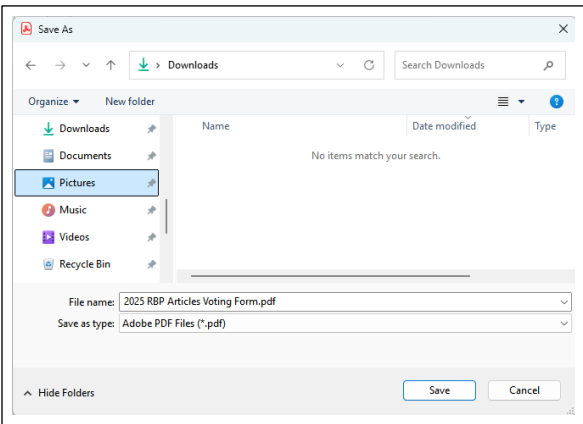
You have the option to email the completed ballots to [rbpark.voting@gmail.com](mailto:rbpark.voting@gmail.com), or returning printed ballots by placing them in an envelope, sealing it and then writing '**Governing Document Ballots**' on the lower left hand corner of the envelope. The envelope may be dropped off at the RBPOA office during regular office hours, dropped in the Dropbox, or mailed to River Bend Property Owners Association, Inc., PO Box 337, Hardy, AR 72542. All ballots must be received by 11:59 p.m. on **October 15, 2025** in order to be valid and counted.
