

Rules & Regulations

The park is open from on or around March 15th to on or around December 1st.

Property Owners / Guests Behavior

- A property owner that is <u>NOT</u> in good standing may <u>NOT</u> use park pools, bath houses, playgrounds, etc. as a guest of another property owner.
- Property owners are responsible for the conduct of their guests while on River Bend Park property. Property owners should make their guests aware of all rules and regulations while on River Bend Park property.
- Only property owners in good standing and their guests may use park utilities and amenities, pools, bath houses, playgrounds, etc.
- Property owners and their guests shall be respectful of others. Activities interfering with the harmony
 of the park, or reflecting poorly on the reputation of the park, are strictly prohibited.
- Property owners and their guests shall respect the park employees.
- Employees of the park answer to the park manager, who answers to the board President. Property
 owners should report problems to the Park Manager. If he is not available, call 870.897.7275 and
 leave a voicemail. No property owner is authorized to harass, threaten or discipline any park
 employee.
- If any property owner or their guests are caught willfully defacing or destroying River Bend Park
 property, the property owner shall be liable for the full value the property. The board reserves the
 right to bring criminal charges against such perpetrators.
- Each property owner shall keep their lot in a clean, sanitary, safe condition, including lawn maintenance.
- Any noise generating equipment such as loud TVs, radios, etc. shall at no time cause a nuisance to other property owners. No generators will be allowed during regular open season.

Occupancy of Individual Lots

- Only one (1) recreational vehicle, motor home, travel trailer, etc. that has appropriate holding tanks
 that is manufactured by a company engaged in the manufacture of camping and recreational vehicles
 may be used on any lot. Mobile homes or converted buses are prohibited. The restrictions regarding
 recreational vehicles, tents, etc. on individual lots are spelled out in the Declaration of Restrictions
 and Bylaws. Compliance will be strictly enforced.
- Tents may be used but should be taken down when you leave to go home.
- No lot shall be used for commercial purposes.
- Lot and block numbers must be placed on all campers for easy identification by park employees for pumping, recovery, or removal after a flood, etc.

Secondary Lot Rental

- A property owner may rent a secondary lot to a guest. A secondary lot does not contain their primary recreational vehicle, motor home, travel trailer, etc. The annual assessment must be paid on the property owners' primary lot before the secondary lot can be rented.
- A \$30 per night rental fee will need to be submitted before 12pm on Friday so that the water can be unlocked. This fee covers water, pumping service, pools and park amenities.

Quiet Time

- Quiet time hours are from 11:00pm to 7:00am.
- Power tools, mowers, weed eaters, etc. should not be used during quiet time hours.
- Camp site radios, TVs, vehicle radios, etc. should be kept at a respectable volume during quiet time hours.
- All vehicles, ATV's, SxS, golf carts, etc. riding around on park roads during quiet time hours should be respectful of other property owners.

Traffic / Vehicles

- The speed limit on **ALL** roads inside River Bend Park is **10 mph**.
- All vehicles, ATV's, SxS, golf carts, etc. operated within the park must have headlights and rear lights
 if operating after dark.
- All ATV's, SxS, golf carts, etc. must have a visible lot and block number on them.
- Operators of any vehicle in the park must maintain control of the vehicle at all times. Operators shall
 not at any time willfully or intentionally operate the vehicle in an unsafe manner that may endanger
 others.
- Riding any motorized vehicle on another property owners' lot is strictly prohibited.
- Riding any motorized vehicle on any River Bend Park Common Ground, whether access is currently restricted or not, is strictly prohibited.
- All property owners and their guests will abide by all State, Federal, and Local laws pertaining to motorized vehicles.

Pools

- No alcoholic beverages are permitted inside the pool area.
- No glass is permitted inside pool area.
- No nudity or indecent exposure is permitted inside pool area.
- No pets are permitted inside pool area.
- Children under the age of 12 must be accompanied by an adult 18 or older at all times while inside the pool area.

Waste Water / Garbage / Trash

- Blue-boys are strictly prohibited.
- Compost toilet materials are not allowed to be put into the dump station.
- No sewage, garbage, liquid/solid waste disposal system or outside toilets, whether portable or permanent, shall occupy any property owners' lot.
- No wrecked, abandoned, or discarded trailer, watercraft, or equipment of any kind shall be placed or stored on any site within the park.
- All garbage should be deposited in the dumpsters provided by the park located on the hill by the railroad tracks behind the office / bathhouse #2. This is for household garbage **ONLY**!!
- Garbage should be in sealed plastic bags and placed inside the dumpster. There should be no dumping of any trash on the ground at any time.
- Bringing trash from outside the park is strictly prohibited.
- Tree trimmings should be burned on property owners' lot in an approved container (firepit, grill, etc.) or removed from the park at property owners' own expense.
- Dumpsters shall <u>NOT</u> be loaded with landscaping debris, pruning matter, construction materials, old appliances, mattresses, furniture, BBQ grills or other large items.

Alcohol / Illegal Drugs

- Alcoholic beverages are not allowed at any youth activities or any posted areas.
- No illegal drugs / substances are allowed in the park.
- Violations will be reported to the appropriate authorities.
- NO EXCEPTIONS!!

Hunting / Fires

- No hunting is permitted inside the park.
- There shall be no discharging of firearms inside the park.
- There shall be no target practice with bow and arrows inside the park.
- Open fires must be in an approved container (firepit, grill, etc.). If a burn ban is in effect, open fires are not allowed anywhere in the park. Violators will be reported to the appropriate authorities.

Pets

- Pets <u>MUST</u> be kept on a leash or in a dog kennel / pen by the property owner or their guests when outside.
- Property owner or their guests must clean up their pets' waste in common areas and other property owners' lots.
- Property owners or their guests are responsible for the behavior of their pets, including any damages to park property or other property owner's property.
- The Park Manager and the board reserves the right to remove unruly, loud or misbehaving pets from the park.
- No pets are to be left unattended. When you leave the park to go home you must take your pets. Unattended pets will be turned over to the local animal shelter.

Lost / Stolen / Damaged Property

- The POA and the Board of Directors are not responsible for the loss or damage to any personal property of property owners or their guests inside or outside of the park.
- All facilities of the park are used by the property owners and their guests at their own risk.

Note: These rules and regulations are issued by authority of the Declaration of Restrictions and Bylaws. They are intended to ensure a pleasant experience for all property owners and their guests and to help ensure a well-maintained park. These rules and regulations are not all inclusive and are subject to change at any time. Any new additions or revisions will be posted and made available to all property owners.
