### **Membership Agreement (optional)**

This membership agreement between Global Conscious Solutions, LLC and name \_\_\_\_\_ shall be effective on the date of \_\_\_\_\_. Monthly payments for this membership shall occur on the 1<sup>st</sup> of each month in the amount of \$50. For families, each additional family member is \$45 and must be indicated below for who the membership is for.

#### **Membership:**

1. The initial membership period shall be for 6 months (Initial Period). A member shall not be entitled to terminate or suspend his/ her membership during the initial period.
2. After the initial period, the membership shall continue on a month-to-month basis. Either party may cancel the membership at any time by giving written notice to the other party, either by email to [healynd@gmail.com](mailto:healynd@gmail.com) or via mail to 219 Iwalani St. Hilo, HI 96720. Written notice must be received 30 days in advance of the next billing cycle.
3. This agreement is personal and cannot be transferred, assigned, or otherwise disposed of by the member
4. Membership entitles the member to one (1) visit with a doctor for the month to be either, (i) a return visit to modify an existing treatment plan, (ii) acupuncture, (iii) chiropractic manipulation, (iv) biofeedback, (v) cupping, or (vi) Rife biofield treatment for up to 45 minutes, (vii) homeopathic counseling, (viii) electrodermal facial, (ix) Mayan uterine massage.
5. Additional visits or therapeutic services for the month are 20% off.
6. Membership visits need to be scheduled in advance, no walk-in appointments.

#### **Automatic Payment Agreement:**

1. Monthly payments shall be made in advance by direct debit from the members credit or debit card, or by bank transfer.
2. Global Conscious Solutions reserves the right to periodically review subscriptions. Members will be given advance notice, at least 30 days, of any changes, including but not limited to, (i) any increase in membership fee, (ii) change in date to automatic withdrawal.

#### **Termination or Suspension of Membership:**

1. Global Conscious Solutions reserves the right to cancel or suspend membership of any member in the event of the following:
  - a. When monies are due and remain unpaid for 30 days after it's due date.
  - b. The member knowingly provides false information that would have reasonably affected Global Conscious Solutions' decision to grant the membership.
  - c. The member is not following a recommended treatment plan as provided by either Dr. Bryce or Dr. Kelsey.
