STEPS IN THE CALL PROCESS

(v. 6/20/2021)

CALL COMMITTEE PROGRESS

STEP 1: NOTIFY THE DISTRICT PRESIDENT, THE REGIONAL VICE-PRESIDENT AND THE CIRCUIT VISITOR AS SOON AS IT IS KNOWN THAT A PASTORAL VACANCY WILL OR HAS OCCURRED

DONE!

STEP 2: MANAGE THE DETAILS OF CLOSING THE PASTORAL-CONGREGATIONAL RELATIONSHIP: EXIT INTERVIEW, FUTURE RELATIONSHIP, FINANCIAL ISSUES, APPROPRIATE FAREWELL

We have elected to stop pursuing this out of respect for Pastor Tim's current call

STEP 3: SELECT AN INTENTIONAL INTERIM MINISTER, VACANCY PASTOR OR PULPIT SUPPLY PASTOR, DEFINE YOUR EXPECTATIONS OF HIS WORK AND NEGOTIATE HIS COMPENSATION PACKAGE

Pastor Corey Grant has been serving as our Vacancy Pastor, as announced 10/18/20 by Lay Ministry

STEP 4: ESTABLISH A CONGREGATIONAL CALLING PROCESS (UNLESS THE PROCESS IS ALREADY SPECIFIED IN YOUR CONSTITUTION) AND A CALL COMMITTEE

DONE! Following our Bylaws

STEP 5: COMPLETE A SELF-STUDY OF YOUR CONGREGATION'S LIFE, MINISTRY & MISSION, AND A PASTORAL PROFILE

Complete and published 5/14/2021

STEP 6: RECEIVE CONGREGATIONAL NOMINATIONS FOR THE OFFICE OF PASTOR (minimum 2-week period, per Bylaws)

FAQ's:

- 1. Is this our final list?** No. President Gibson ADDS to our list both a) pastors he knows match our needs and congregational profile and b) those whom he can search in the whole LCMS database who also match; plus, President Gibson SUBTRACTS those who are ineligible for a call to our congregation for one reason or another. Ex: Pastor Nolte is ineligible because he is in our Circuit.
- 2. When can we expect our next update from the Call Committee?** We will notify you when we receive our Call Packet (résumés for all eligible Pastoral Candidates) from President Gibson – expected around 7/15.
- 3. When do we vote to extend a call?** We will announce a date for a meeting (which may not fall on a 'regularly scheduled' Voters' Assembly meeting date) some time after we receive the call packet, with plenty of advanced notice. Expect more info this summer!

STEPS IN THE CALL PROCESS

(v. 6/20/2021)

STEP 7: FORWARD ALL NOMINEE NAMES RECEIVED TO THE DISTRICT PRESIDENT'S OFFICE

STEP 8: RECEIVE YOUR CALL PACKET FROM THE DISTRICT (4 – 6 weeks after Step 7)

STEP 9: PRAYERFULLY EVALUATE CANDIDATES AND KEEP YOUR CONGREGATION INFORMED

STEP 10: ESTABLISHMENT OF COMPENSATION AND CALL DOCUMENT PREPARATION

STEP 11: ESTABLISH THE DATE AND PROCEDURE FOR THE CALL MEETING

STEP 12: IMMEDIATELY NOTIFY THE PASTOR-ELECT OF HIS SELECTION AND SEND THE PROPER CALL DOCUMENTS

STEP 13: NOTIFY THE DISTRICT PRESIDENT THAT THE CALL HAS BEEN SENT

STEP 14: THE CALL IS ACCEPTED OR DECLINED

STEP 15: EXPRESS THANKS AND APPRECIATION
