Call Committee Update
11/14/2021

Review (from Sept 12 verbal update)

- From our initial Call Packet, out of 8 men, we had:
 - 1 genuinely interested pastoral candidate
 - 2 candidates who offered to interview but who were quite happy where they were, or not yet available
 - → We are required by our Bylaws to present the CtK with 3 candidates
- We requested additional names, a 2nd Call Packet, from District

Update since 9/12

- We developed our interview questions & format
- We received our 2nd Call Packet, with 5 additional candidates
 - 2 had taken calls already!
 - 2 we deemed to be suitable candidates to interview
 - 1 did not respond and we also thought him not the best fit
- We arranged and held 5 ZOOM interviews in October and early Nov
 - 1 candidate is interested in a 2nd interview (on-site) – exploring options for January
 - 1 candidate we interviewed had already received and is considering a call, but should he decline, he will advise if he is interested in a 2nd interview
 - 1 candidate declined to continue the process with us
 - 2 candidates – additional conversations pending

STEPS IN THE CALL PROCESS

(v. 11/14/2021)

STEP 7: FORWARD ALL NOMINEE NAMES RECEIVED TO THE DISTRICT PRESIDENT'S OFFICE

STEP 8: RECEIVE YOUR CALL PACKET FROM THE DISTRICT (4 – 6 weeks after Step 7)

STEP 9: PRAYERFULLY EVALUATE CANDIDATES AND KEEP YOUR CONGREGATION INFORMED

STEP 10: ESTABLISHMENT OF COMPENSATION AND CALL DOCUMENT PREPARATION

STEP 11: ESTABLISH THE DATE AND PROCEDURE FOR THE CALL MEETING

STEP 12: IMMEDIATELY NOTIFY THE PASTOR-ELECT OF HIS SELECTION AND SEND THE PROPER CALL DOCUMENTS

STEP 13: NOTIFY THE DISTRICT PRESIDENT THAT THE CALL HAS BEEN SENT

STEP 14: THE CALL IS ACCEPTED OR DECLINED

STEP 15: EXPRESS THANKS AND APPRECIATION
