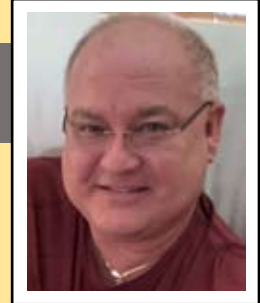

Memorial Day weekend marked the commencement of summer and served as a poignant reminder of the sacrifices made by our fallen soldiers. Following the holiday, the club enjoyed exceptionally favorable weather for our first Drive & Lunch event of the season to the Lakeshore Inn in Fontana. This successful outing, meticulously planned and executed by George P., saw the participation of 25 Corvettes and 54 members. They made a brief stop at a new Shell gas station, owned by a friend of George P. and is now a generous \$250 sponsor for our upcoming car show, where participants enjoyed complimentary donuts and coffee. The journey then continued to Fontana, where, thanks to the cooperation of Fontana's police chief, Jack, the owner of Chuck's Lakeshore Inn, facilitated street closures to accommodate our Corvettes and our members enjoyed a fabulous lunch.

Eighteen of our members actively participated in the annual St. Jude fundraising drive, a long-standing MCC initiative organized by John and Fred. The MCC's commitment to St. Jude is reflected in our status as a sponsor of the event. At the May meeting, John Klemmer provided a comprehensive financial report. Our club's members demonstrated exceptional fundraising success, with five out of the top ten fundraising cars belonging to our Bourbonnais group, including two MCC members – Tim & Cindy Chamberlain and Jeff & Deb Senglaub. Their outstanding achievement resulted in them being recognized among the top ten cars, securing a prominent position at the event.

The MCC's contribution to St. Jude this year totaled approximately \$34,000, contributing significantly to the overall total of \$548,000 raised by the 115 participating Corvettes, exceeding last year's total of \$510,000. Two St. Jude families joined our drive, benefiting from the organization's policy of covering all expenses for these families. The impact of our collective efforts is profound; the improved survival rate for a specific type of brain cancer, from 4% to 96%, highlights the life-changing impact of our donations – exemplifying the philosophy that "You never know exactly which dollar donated will cure cancer."

The next St. Jude Corvette drive is scheduled for May 14-15, 2026. We encourage increased membership participation next year.

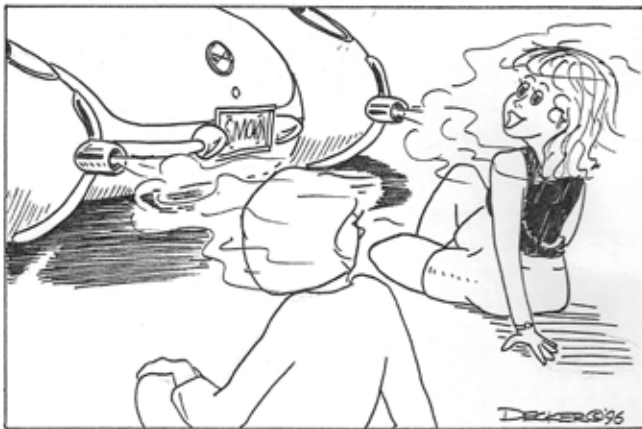

C3 Owner Lucky to Have Kept His Head After Crashing into a Guardrail

The owner of this late '70s brown Corvette instantly turned his car from a T-top to a convertible – just probably not the way he would have preferred. Check out these gruesome photos from Colorado, which show the aftermath of a C3 Corvette coupe that crashed into a guardrail near the Douglas County Fairgrounds in Castle Rock last weekend.

The low-sitting Corvette's nose was able to ram right under the guardrail, which flattened the windshield and came to rest right in front of where the driver's face normally would be. What a scary sight that must have been.



Fortunately, the Castle Rock Fire and Rescue Department was able to cut the roof supports to extract the driver, and then they lifted the guardrail to free his Corvette from its bondage.

Miraculously, the driver walked away from this horrific crash with nary a scratch, though his car has definitely seen better days, with the bubble glass shattered over the rear compartment where the only items remaining were a basketball and a white sheet. There could have been something else back there, too, but for the grace of God.

We've talked for years about the safety advances in today's Corvettes, which have no doubt saved countless lives. But even without those modern features, this classic 'Vette and its owner managed to make it through their ordeal, the owner in better shape than his car, of course.

Car Thieves Do Donuts in a Corvette Z06 After Theft from Dealership

Imagine being a car dealer and selling a Shark Gray 2016 Corvette Z06 to an out-of-state customer who's paid for it and is going to pick it later in the week.

Then imagine being that same dealer and discovering that thieves had broken into your showroom and stolen that same Corvette days before the customer was to pick it up.

Filed in the "Sad But True" category, that's exactly what happened to a Wisconsin dealership, where crooks used a rock to break in and go on a successful search for keys, whereupon they stole the aforementioned C7 as well as a 2023 Dodge Challenger SRT Hellcat.

As if the thefts weren't bad enough, the suspects were captured on surveillance video spinning donuts in the stolen vehicles in front of the dealership!

"To steal the cars, high-performance cars, and do donuts and get away with it, it's very hard to swallow," owner Doug Schoepp said.

The incident happened around 2:20 a.m. April 6 at Schoepp Motors in Middleton, according to the Middleton Police Department. "They toured around the building and found a window, busted it with a rock, reached in, opened (the door) up," said Schoepp, who's been in the car business a long time but apparently not long enough to know you shouldn't leave keys unsecured at night.

Schoepp has definitely learned his lesson the hard way, though, and promises ABC 27 Madison Wisconsin that "it'll never happen again," explaining that the keys are now hidden in a safe and pedal locks are being installed on all his remaining cars.

The dealership is offering a \$5,000 reward for information leading to an arrest, and Crime Stoppers is adding another \$1,000.

Coronary Artery Disease

Your heart is about the size of a fist and has the following arteries:

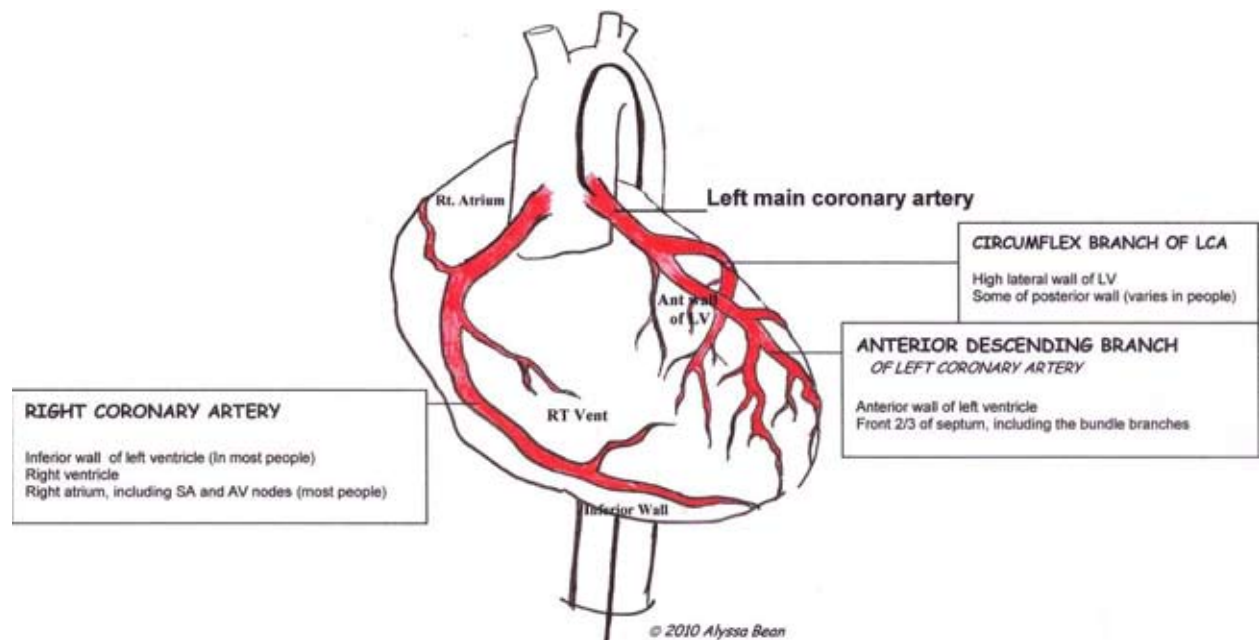
Right Coronary Artery

Left Main Coronary Artery (widow maker)

Circumflex Branch

Anterior Descending Branch

If you have disease in the Left Main Coronary Artery, you can lose the blood flow to the left ventricle which is the pump that sends blood to your brain and every part of your body. Arteries block up over a period of time. You don't notice problems until it is blocked around 70%. Once it is blocked completely that is called a heart attack.

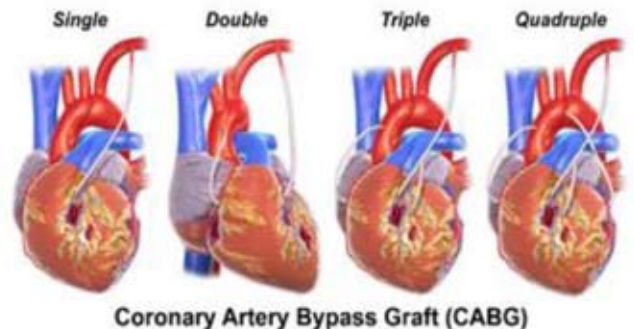
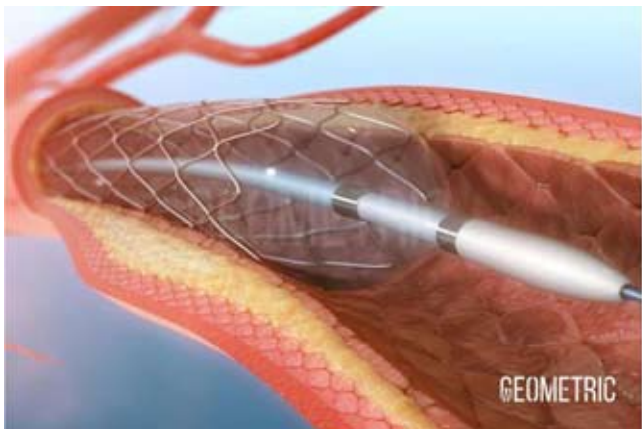

Acute Myocardial Infarction (heart attack)

NSTEMI (mild) and STEMI (severe)

Call for help-911

STEMI receiving center (paramedics know which hospitals provide this service)

TPA

Emergent PCI/stent

Emergent CABG

Mia advised it is best to call 911 if you think you might be having a heart attack. Paramedics know which hospitals in the area provide specialized treatment and have the staff on hand for heart attacks. Paramedics can get you to the hospital within the 30-minute window.

A very old technique is to make the person cough. 911 should still be called.

Met in East Troy on Wednesday, May 14th. Fred Anderson planned a great route to Bourbonnais, Il. Met with 25 cars from Chicago and Holland, MI and had dinner with over 50 people.

Fred Anderson said they took photos and videos. One of the speakers was from Spain. St. Jude has 14 interpreters that speak 60 languages. Interpreters are on call at all times. A child from another country will be at St. Jude within three days of first contact.

The Tennessee State Police escorted 115 Corvettes 80 miles from Dyersburg, TN to Memphis, TN. Corvettes stayed in the left lane and the police were doing 90 mph in the right lane. Lots of people cheering, waving, thank you, etc.

The cost to register for this event is \$500 which includes one night hotel stay, tank of gas, two shirts, meal and the best feeling in your heart that you helped people. Also, there is a donation of \$2,000 per car for two people.

John Klemmer spoke about the financials. The people who attended from the MCC did really well. This year St. Jude recognized the top ten cars that raised the most money. Our Bourbonnais group had five out of the ten. Two were from the MCC - Tim & Cindy Chamberlain and Jeff & Deb Senglaub. They were moved up to the front of the line in the first ten cars. The MCC accounted for about \$34,000 of the donation. The total amount raised this year from the 115 Corvettes was \$548,000 up from \$510,000 last year.

Two St. Jude families traveled with us. Families never pay a cent. There is a phrase "You never know exactly which dollar donated will cure cancer". There is a type of brain cancer that years ago had a 4% survival rate and now has a 96% survival rate.

Next year the St. Jude Corvette drive is May 14-15, 2026.
