



Bounce House & Waterslide Safety Waiver



RULES AND REGULATIONS FOR SAFE OPERATION OF SLIDE / BOUNCE HOUSE:

Included are rules for safe use of the bounce houses and waterslides.

TERMS: I understand and acknowledge that the use of this unit might result in known or unanticipated risks to my guests or me. Those risks include, but are not limited to falling, slipping, or colliding which could result in injury, illness, disease, emotional distress, accidental death, and/or property damage to my guests or me. I acknowledge and certify that I have adequate homeowner's, tenant, or other liability insurance to cover all medical bills, bodily injury, and property damage which might occur to my guests or me from the use of this bounce house or slide. I voluntarily release Campbell Ridge LLC and its affiliates from any, and all liability, claims, or legal action, whether personal to me or to a third party who relates to my use of this inflatable unit.

I, *(Renter)* agree to bear all costs for the replacement or repair of the equipment if stolen, lost, or damaged beyond normal wear and tear.

Replacement cost for the inflatable / blower is up to \$1,800. Costs for other supplies shall be equal to new purchase prices *(ground stakes, tarps, extension cords, etc.)*.

A \$75 cleaning fee may be implemented if the unit has excessive dirt, mud, grass, spilled drinks, etc.

The equipment shall be located at the set-up location and shall not be removed or altered until picked up by its owner or designee.

I, *(Renter)* agree to allow stakes to be driven up to 18" into the ground to secure the inflatable. Any electrical / communication lines, irrigation lines, lawn sprinklers, etc. will be pointed out prior to set up.

ALWAYS SAFETY FIRST!!!

ADULT SUPERVISION IS REQUIRED AT ALL TIMES!

ONLY ALLOW CHILDREN OF THE SAME AGE GROUP TO USE INFLATABLE AT THE SAME TIME.

DO NOT EXCEED CAPACITY BY AGE GROUP/WEIGHT. *SEE CHART ON THE BACK PAGE.*

NO FLIPS, SOMERSAULTS, ROUGH PLAY, CLIMBING / HANGING FROM NETTING, SIDES, ETC.

NO SHOES IN OR ON THE INFLATABLE.

NO SHARP OBJECTS (REMOVE FROM POCKETS): KEYS, JEWELRY, EYEGLASSES, KNIVES, etc.

NO FOOD, CANDY, DRINKS, OR GUM IN THE INFLATABLE.

NO SILLY STRING / CONFETTI – IT WILL DAMAGE THE INFLATABLE.

NO PETS IN OR NEAR RENTAL EQUIPMENT / NO ANIMAL FECES IN THE SET UP AREA.

NO CIGARETTES OR FLAMMABLES NEAR EQUIPMENT.

KEEP CHILDREN AWAY FROM BLOWERS, ELECTRICAL EQUIPMENT, GROUND STAKES, AND GENERATORS.

BLOWERS MUST BE PLUGGED IN TO A FULLY DEDICATED CIRCUIT. IF YOU EXPERIENCE ELECTRICAL PROBLEMS ASSOCIATED WITH INFLATION, CHECK YOUR CIRCUIT BREAKERS, AND MAKE SURE THERE IS NO OTHER LOAD ON THE CIRCUIT. IF THE UNIT DEFLATES, THE SUPERVISOR THAT HAS BEEN ASSIGNED TO WATCH THE CHILDREN IS RESPONSIBLE FOR MAKING SURE ALL CHILDREN CALMLY EXIT THE INFLATABLE.

**** IF 15+ MPH WIND OR STORMS DEVELOP - IMMEDIATELY EVACUATE AND DEFLATE INFLATABLE ****
