Payment Policy and Procedures

Monday – Thursday
By Appointment

Basic Training (New Students)

Every day Monday through Thursday

- 10 minute individual/private lessons
- \$35 Registration Fee
- \$75 a week
- Approximately 5 weeks or until completed
- A \$185 deposit paid in advance to hold scheduled lessons.
The deposit is the registration fee plus two weeks of basic training.

Once the basic training program is complete the student will then move into either Maintenance Lessons.

Refresher (Returning Students)

- Every day Monday through Thursday
- Approximately 2 weeks or until completed
- 10 minute individual/private lesson
- \$75 a week

Maintenance Lessons

- 1, 2 or 3 times a week
- Maintenance 10 Minutes individual/private lessons
- \$15 per lesson

All lessons must be paid in full on the Monday of the week that lessons will occur. Failure to do so will result in your child being taken off the schedule. This excludes maintenance and refresher lessons which are to be paid the day of the scheduled lesson.

Call Outs: If your child cannot be at their lesson, a two-hour notice is required in order for the lesson to be made up.

Missed Lessons: If you do not call and do not show for your lesson, the lesson is considered a no-show. This lesson cannot be made up.

Make-Up Lessons: If you called out in the allotted time period, you have until your next lesson to reschedule.
