Rules and Regulations

Show respect for the driver and follow the driver's instructions.

Client is responsible for any damages to the vehicle or its equipment, accidentally or otherwise.

Violence will not be tolerated.

- CANCELLATION POLICY: All deposits are Non-refundable if you decide to cancel your event.
- PAYMENT: Payment in full is to be paid to the driver upon arrival unless full payment is paid in advance.
- EVENT HOURS: Starting and ending times must be enforced ANY ADDITIONAL HOURS ARE SUBJECT TO LIMOUSINE AVAILABILITY.
- LOST ITEMS: JSI LIMOUSINE SERVICE is not responsible for any lost or stolen articles during the ride or articles left after the ride has ended.
- SMOKING: There is no smoking allowed in the limousine.
- ALCOHOLIC BEVERAGES: Alcoholic beverages are not allowed outside the vehicle during the trip. Any saltation given by law enforcement must be cover by client. JSI LIMOUSINE SERVICE is not responsible for underage consumption at any time before, during, or after the ride. By law JSI LIMOUSINE SERVICE cannot supply alcoholic beverages to underage passengers.
- JSI LIMOUSINE SERVICE: Driver/employee reserves the right to eject any individual(s) whom they deem to be disruptive, intoxicated, to pose a safety threat to themselves or to others, or deem to be using any illegal substance.
- CONDUCT POLICY: For any action such as fighting, violence, damage to equipment and/or vehicle, harassment towards the driver, or anyone else in or around the vehicle, the driver reserves the right to terminate the trip. The client will be responsible to find other transportation for the group and payment will not be refundable.
- VOMIT FEE: If a passenger should vomit in or on the vehicle, there would be a charge of \$100, the vomit fee will be held upfront and return after the event is finish.

By signing for and participating in the ride, the individual agrees that JSI LIMOUSINE SERVICE and its employees are not responsible for any claims, for injuries, loss, damage, death, liability, criminal or civil litigation for the participating individual arising out of or relating to a ride.

By signing this contract, the above client agrees to assume full responsibility for any damages to the interior or exterior of the vehicle that is cause by any individual riding the vehicle. The client is liable for the cost to repair any such damage as well as any cost for loss of JSI LIMOUSINE SERVICE due to such damage.

JSI LIMOUSINE SERVICE is not responsible for injuries or accidents in and around the vehicle. Alcohol impairs balance and judgment. Passengers are asked to remain seated while the vehicle is in motion. Move about your on risk.

JSI LIMOUSINE SERVICE is not liable in cases of unexpected vehicle breakdowns, accidents, severe weather, or anything that might delay a timely arrival or cause cancelation of the trip. Client will be notified as soon as possible of any unexpected problem that may postpone trip times. The limousine will not stop in unsafe places such as expressways, or dangerous neighborhoods.
