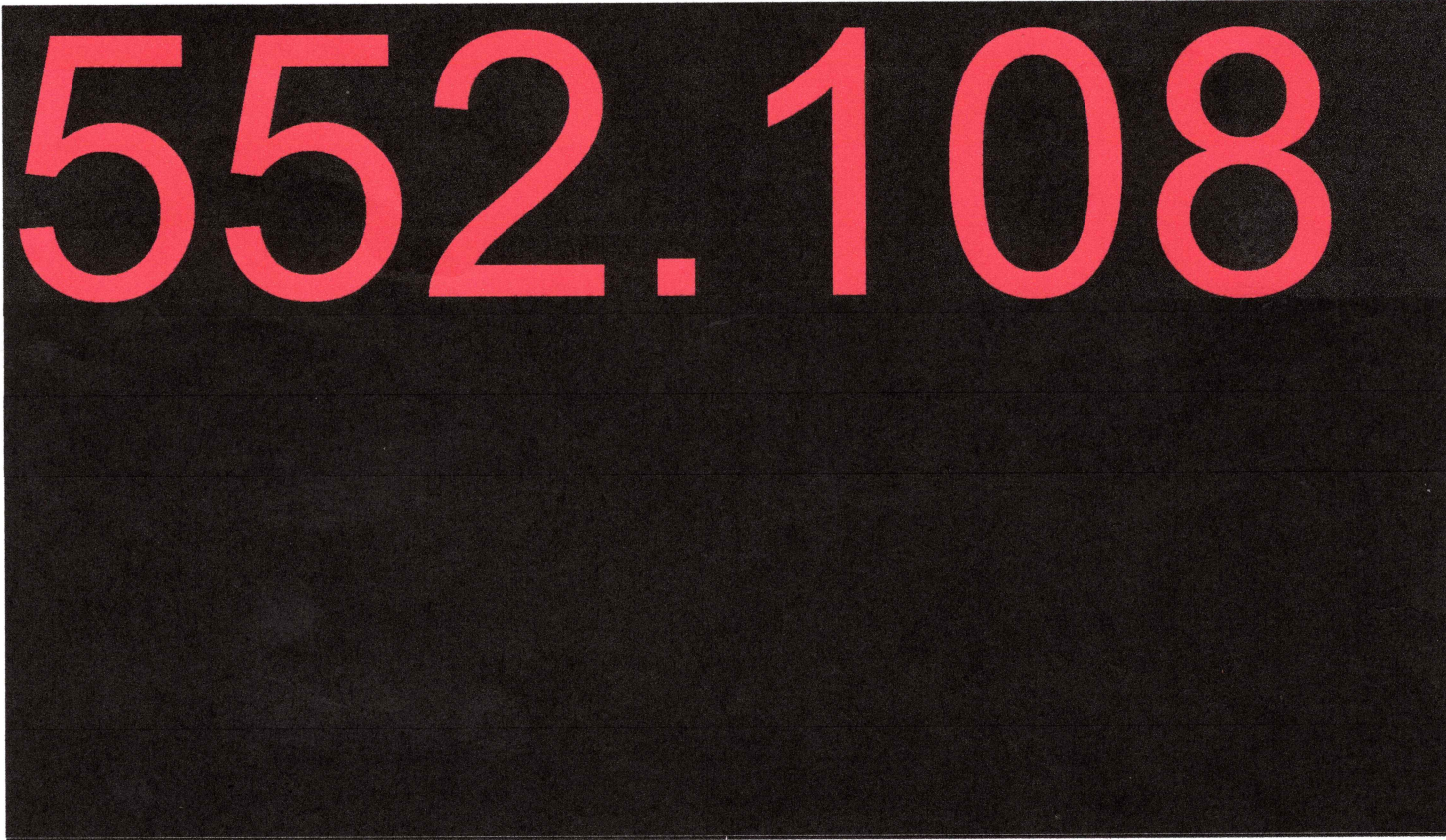

Officer Munoz observed a black Toyota [redacted] LP552.130 facing southbound towards the 2800 block of East Trinity Mills Road, in the parking lot of 3315 Trinity Mills Road, a public place located in Dallas, Texas. Officer Munoz drove by the Toyota and observed a white male in the driver seat passed out. Officer Munoz contacted the driver to check his welfare. Officer Munoz observed the Toyota's ignition to be running. Officer Munoz observed the male's chest rise and fall, indicating that he was alive. Officer Munoz knocked on the driver window and the male woke up. The male was identified as Jeffery A. Frenle (W/M DOB 552.101).
