If appointed, I understand that, prior to the expiration of my term, I am subject to suspension and/or removal by the Board of Directors. I hereby certify that to my knowledge the above information and required attachments are true and correct. I understand fraud or non-truthful answers to any of these questions can serve as the basis for finding me unsuitable for appointment to any position. I understand I may be prosecuted for perjury if my answer to questions 2 and 5 are not true. I hereby authorize LJF, its officers, employees, volunteers, staff and contractors to use this form to obtain information from records of the California State Police and/or any Federal, State and Local government or law enforcement agency pursuant to completing a background check regarding my criminal and child abuse history. I understand that LJF must notify me of any findings upon written request.
