President Annual Meeting Update

September 23<sup>rd</sup>, 2024

I want to welcome all our SRA owners and any guests to our Annual Meeting. Overall, we have had a mostly average year.

Winter snow and ice removal cost was lower than normal and summer mowing is running at normal cost; even with the recent hot weather we have had. We have been lucky to have gotten several rainfalls early in the season with substantial amounts to keep lawns looking good.

In our maintenance area we have replaced 5 roofs and resided 5 units. These units were all on our schedule due to age and/or condition. The SRA Board will be reviewing any potential projects for 2025.

Davis Asphalt Company recently replaced 5 driveways and made 7 repair patches. These were all done on a condition review or problem basis.

This summer we have had one storm that caused damage to one unit. Fortunately, it was only minor fascia damage and some siding blown off. The affected trees were removed professionally along with some other trees that were leaning.

Many of the Red Pines have been affected by Pine Bark Beetles. This parasite causes the tree to die and can quickly spread to other pine trees. In the 900 court we have also had a problem with some trees causing too much shade and dropping debris that then caused drainage problems. The area has been improved and the work done will correct the drainage issues and provided necessary conditions for grass to grow. The area looks completely different!

This will likely be our current mowing companies last year, and the SRA Board is actively contacting other companies for bids.

I am very proud of our current board as they take their volunteer positions seriously and have our Associations business always as our main goal.
