Terms and Conditions:

- 1. Please read these Registration terms & conditions carefully, as they incorporate the basis upon which MT Football Training Pty Ltd accepts your child to attend MT Football Training Pty Ltd programs.
- 2. By the way of registration / payment, I give authority and consent for my child to attend and participate in the activities of "MT Football Training Pty Ltd" ABN: 97669924574 ACN: 669924574. This includes participation in our Training Programs, Holiday programs, School Programs, Day Care programs, Birthday Parties, One on One Sessions & Group Sessions.
- 3. Anyone attending and participating in activities part of MT Football Training Pty Ltd, sessions are entirely at their own risk.
- 4. MT Football Training Pty Ltd shall not be liable for any Loss that may occur when any child attends and/or participates in any activity during a MT Football Training Pty Ltd session.
- 5. I indemnify and will keep indemnified MT Football Training Pty Ltd against all Claims which may be taken or made against MT Football Training Pty Ltd by my child, myself, by any parent or guardian of my child and any person claiming through all or any of them in relation to any Loss.
- 6. I indemnify MT Football Training Pty Ltd for any Claim arising from any failure of any person to notify MT Football Training Pty Ltd of any medical condition of my child and/or that my child is taking any medication, whether that matter is existing now or in the future.
- 7. All participants will inform MT Football Training Pty Ltd prior to participation in any activity of the MT Football Training Pty Ltd sessions of any condition that will or may affect their ability to participate.
- 8. Any person suffering from any infectious disease or other medical condition which could seriously affect themselves or others may not attend any activity of MT Football Training Pty Ltd.
- If the child is taking any medication other than as stated at time of registration, MT Football
 Training Pty Ltd must be notified prior to the child participating in any activity of MT Football
 Training Pty Ltd programs.
- 10. MT Football Training Pty Ltd may refuse to permit any child to participate for any medical condition or perceived medical condition in its absolute discretion.
- 11. Unlawful conduct, bullying (including cyber bullying), unsportsmanlike conduct, Discriminatory Conduct by any person arising out of or in any way in connection with the activities of MT Football Training Pty Ltd, will not be tolerated. MT Football Training Pty Ltd in its absolute discretion may suspend or cancel participation of any child because of such conduct by that child, by their parent or guardian or any other person associated with the child. In this case no refund will be provided.
- 12. Refunds are not issued for non-attendance. However, if your child is unable to attend a scheduled session for good cause, MT Football Training Pty Ltd in its absolute discretion may

- hold credit for future sessions or permit your child to attend another session. Make-up attendance in MT Football Training Pty Ltd Holiday Programs will not be permitted.
- 13. In the event of wet weather, extreme heat or for any other good cause requiring postponement of activities, an SMS text message will be sent to the nominated mobile phone number giving notice of the postponement of activities. If activities are to be postponed, MT Football Training Pty Ltd will give reasonable notice of the alternative date. Refunds will not be issued for non-attendance on the alternative date. In most cases MT Football will take a fair and reasonable approach to these matters and a credit will be issued.
- 14. MT Football Training Pty Ltd may occasionally take photographs/Videos of participants for promotional purposes. There is an option for consent to be provided or not provided in each registration form. If consent is given it is hereby given to the taking and publication of those photographs/Videos for MT Football Training Pty Ltd promotional purposes.
- 15. I consent to the administration of first aid by MT Football Training Pty Ltd and indemnify MT Football Training Pty Ltd in respect of any Claim for any Loss whatsoever arising therefrom. Only trained individuals will be issuing first aid and in any case emergency services will be called immediately following a call to the emergency contact listed on the registration form.

Definitions:

- "MT Football Training Pty Ltd" includes its directors, officers, employees, servants, agents, volunteers, contractors and their officers, employees, servants, and one of them and a group of them.
- "Claims" includes claims, actions, suits, proceedings, demands, costs and expenses.
- "Discriminatory Conduct" means discriminatory conduct based on actual or perceived race, religion, sexuality or gender or any combination thereof.
- "Loss" means personal injury (including psychological/psychiatric injury and death) and any loss of property occasioned by any cause whatsoever, including as a result of any negligence of any kind or character.
- "Medical condition" includes infectious disease and allergy or sensitivity to anything.
- "Medication" includes vitamins, supplements, antibiotics, and herbal and complementary medicines.
- "My child" means a child in respect of whom I have parental authority.
- "Participating in an activity of MT Football Training Pty Ltd" includes travelling to and from any activity of MT Football Training Pty Ltd.
